### DESCRIPTION

Take Ashland exit 19 off 1-5. Right at end of exit, left at light onto Hwy99, road becomes North Main Street. Continue on North Main to where it intersects Siskiyou Blvd, stay right and follow Siskiyou Blvd to the Safeway Store

**PARK** Away from Store Front or on Side Streets **Restrooms** available at Safeway

**Walk Completion and Credit:** Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including day the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when submitting the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)

These walking directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited. For emergencies contact 911. Walk owner is Pat Jewett and she can be reached at 503-453-6018.

1. Exit Store and walk STRAIGHT ahead to Siskiyou.
2. RIGHT on Siskiyou. (Carnegie Library across from Fire House.)
3. Just after Fire House, follow the curve as street is now Lithia Way.
4. CONTINUE on Lithia Way to Light at N. 2<sup>nd</sup> St.
5. LEFT on N. 2<sup>nd</sup> St, crossing Lithia Way. Labyrinth is on corner.
6. CONTINUE on N. 2<sup>nd</sup> St to Main St.
7. RIGHT on Main to Water St (no sign) opposite coffee shop (1k at Siskiyou sign)
8. RIGHT on Water St.
9. LEFT on Central.
10. LEFT on Helman to corner, take crosswalk to Median.
11. Go LEFT to tall bronze sculpture, then LEFT of sculpture down path. (Note paintings overhead.)
12. RIGHT on walkway to metal stairway up to the street.
13. CROSS Main St to "Ashland Creek" sign, turn RIGHT to end of bridge taking path to LEFT.
14. LEFT on footbridge to Calle Guanajuato (alley no sign.) There are restrooms in bldg. ahead before you cross bridge.
15. RIGHT on Guanajuato to Winburn Way (no sign)
16. RIGHT on Winburn and curve to the LEFT. Proceed to Nutley St. (3k at Nutley.)
17. Just past Nutley, take arboretum path to the RIGHT. Where path forks, go RIGHT (uphill) passing Perozzi Fountain.
18. CONTINUE to the end of trail at Winburn (no sign) opposite tennis courts.
19. CROSS Winburn and take path immediately to the RIGHT. Walk up steps, turn LEFT past Upper Duck Pond.
20. RIGHT at fork. Walk halfway around circular driveway on sidewalk. CONTINUE to a parking lot, walk around it to the LEFT on sidewalk, CONTINUE to street (near intersection of Winburn/Granite), pass maintenance shops on LEFT. CONTINUE to Pioneer St.
21. Turn LEFT on Pioneer, and just before the bridge, turn RIGHT on bark path. Pass parking lot, BEAR LEFT at horseshoe pit, pass large picnic tables on LEFT, then pass through another parking lot. Find water fountain near the end of this lot, CROSS small stretch of grass, and pick up narrow bark trail to another parking lot.
22. Find a short trail to foot bridge and CROSS, turning LEFT on bark path. Pass in front of the Parks and Recreation offices.
23. Do not take gated road ahead, but BEAR LEFT through small parking lot and pick up bark trail again.
24. Proceed to the Park entrance (restroom).
25. At Park entrance, CONTINUE on sidewalk at RIGHT of plaza.
26. RIGHT on sidewalk at E. Main St.
27. Walk one half block to "Chautauqua Park" ramp, turn RIGHT up ramp, LEFT on steps to the brick plaza.
28. Walk through brick plaza to Pioneer St (no sign).
29. LEFT on Hargadine and bear RIGHT on Beach to Gresham St.
30. RIGHT on Gresham to Allison.
31. LEFT on Allison to Sherman.
32. RIGHT on Sherman to Iowa.
33. LEFT on Iowa to Morton.
34. RIGHT on Morton to Holly.
35. LEFT on Holly to Liberty.
36. RIGHT on Liberty to Henry.
37. LEFT on Henry to Mountain Ave.
38. CROSS Mountain Ave on crosswalk and enter Southern Oregon University campus.
39. Proceed STRAIGHT ahead on paved path to the RIGHT of Ed/Phy bldg. Pass
40. Stevenson Union and bookstore on RIGHT.
41. STAY on main path curving to RIGHT and pass Hannon Library on RIGHT.
42. CONTINUE up curving path to RIGHT passing Susanne Homes Hall on RIGHT (9k at Indiana St.
43. Turn RIGHT to Madrone St.
44. LEFT on Madrone St. to Frances St.
45. LEFT on Frances (no sign) to Siskiyou.
46. LEFT on Siskiyou Blvd to Safeway.

# ASHLAND – Town – YR 0063 – 5k – 1A

These walking directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited. For emergencies contact 911. Walk owner is Pat Jewett and she can be reached at 503-453-6018.

1. Exit Store and walk STRAIGHT ahead to Siskiyou.
2. RIGHT on Siskiyou. Just after fire house, follow the curve as street is now Lithia Way.
3. CONTINUE on Lithia Way to Light at N. 2<sup>nd</sup> St.
4. LEFT on N. 2<sup>nd</sup> St, crossing Lithia Way. Labyrinth is on corner.
5. CONTINUE on N. 2<sup>nd</sup> St to Main St.
6. RIGHT on Main to Water St. (1k)
7. RIGHT on Water.
8. LEFT on Central.
9. LEFT on Helman to the corner, take crosswalk to median, turn LEFT to tall metal Indian sculpture at LEFT of sidewalk.
10. LEFT at sculpture and go down path. Notice artwork over head beneath overpass. RIGHT at picnic tables, walk around to RIGHT of brew pub and next to creek. CONTINUE through Blue Bird Park and climb steps to street.
11. CROSS Main St to "Ashland Creek" sign turn RIGHT to end of bridge, take paved path to the LEFT (becomes bark surface.) Take footbridge to Guanajuato Way (no sign)
12. Go RIGHT to Winburn Way (no sign).
13. RIGHT on Winburn and proceed to Nutley St (2k). Just past Nutley, take arboretum path to the RIGHT. Where trail forks bear RIGHT uphill past Perozzi Fountain.
14. At Japanese Garden sign, go RIGHT and take short loop through garden, returning to main trail. CONTINUE to end of trail at Winburn opposite tennis courts.
15. CROSS Winburn and take trail immediately to the RIGHT. Go up steps, turn LEFT, pass Upper Duck Pond. LEFT at fork, go around circular driveway on sidewalk. CONTINUE to parking lot, go around to LEFT of it on sidewalk.
16. Continue on paved walk to street (near corner of Winburn/Granite.) Pass maintenance shops on LEFT, CONTINUE TO Pioneer (Parks and Recreation sign, 3k) CROSS bridge to park offices.
17. Turn LEFT, do not take gated road, but BEAR to LEFT through small parking lot and pick up bark trail. Proceed to park entrance. Restrooms at play area. (4k at Lower Duck Pond).
18. RIGHT on East Main, go a very short distance to "Chautauqua Park" ramp on the right. Walk up ramp, CONTINUE LEFT upstairs to the brick plaza between the Shakespeare Festival theaters.
19. CROSS brick plaza to Pioneer St (no sign). Turn RIGHT to Hargadine.
20. LEFT on Hargadine and BEAR RIGHT on Beach to Gresham.
21. RIGHT on Gresham to Allison.
22. LEFT on Allison to Sherman.
23. LEFT on Sherman to Siskiyou Blvd and starting point. (5k)
