3. A map for both the up river 5K and down river 5K (one page).

**Start/Finish GPS Coordinates:** N 46.233618 W 119.162852

**Restroom Information:** The only restroom type facility at this event is an outhouse at the boat launch start/finish area.

This is a flat walk on paved trails on a dike along the Columbia River with views of the local area. A small portion of the up river 5K goes through a housing community. This is the only sanctioned event in Franklin County for those who are doing the Washington State 39 Counties Challenge.

DRIVING DIRECTIONS to Wade Park Start Point  
46.1401.20N 119.0946.36W

1. I-82 toward Tri-Cities.  
Take I-82 Exit 102 on to I-182 toward Richland and Pasco.
2. Take I-182 Exit 9 Road 68.
3. Turn **RIGHT** on Road 68 (toward the Columbia River).
4. Follow Road 68. **CROSS** Wernett and Argent Roads.
5. Turn **LEFT** on Court Street.
6. Turn **RIGHT** on Road 60 which will **CURVE LEFT** and become Sylvester Street.
7. Turn **RIGHT** on Road 54 and park in the parking lot on the **right**.
8. To walk the up river 5K walk, exit the parking lot toward the river and immediately turn **RIGHT** on the paved river trail.  
Do Walk Directions 1 through 6.
9. To walk the down river 5K walk, exit parking lot to Road 54. Turn **RIGHT** downhill to boat launch area. Turn **LEFT** into Wade Park and proceed on the river trail. Do Walk Directions 7 through 9.

*Thank you for walking our Pasco walk along the Sacajawea Heritage Trail. There are other AVA walks in the On-line Start Box registration system in Kennewick and Richland.*

Be sure to log back into the OSB system ([my.ava.org](http://my.ava.org)) to finish/complete your online registration after doing the walk. The OSB system does not deduct any walking fee from a walker's event bank until they have submitted walk completion info including the date the event was walked, the distance walked, and the selection of applicable special programs that walker is participating in. (Nevertheless, a fee of \$2 for a downloaded pdf is deducted from the user's Event Bank when the pdf is downloaded. Later, any pdf fees are credited back to a walker's Event Bank when he/she submits the walk completion info as a paying for credit walker.) The \$2 "coupon" for the downloaded pdf expires in 60 days.

WALK DIRECTIONS (There are porta-potties at boat launch area)

The 10K consists of two 5K out-and-back walks  
along the river from the parking lot.

Directions 1 through 6 are for the up river 5K

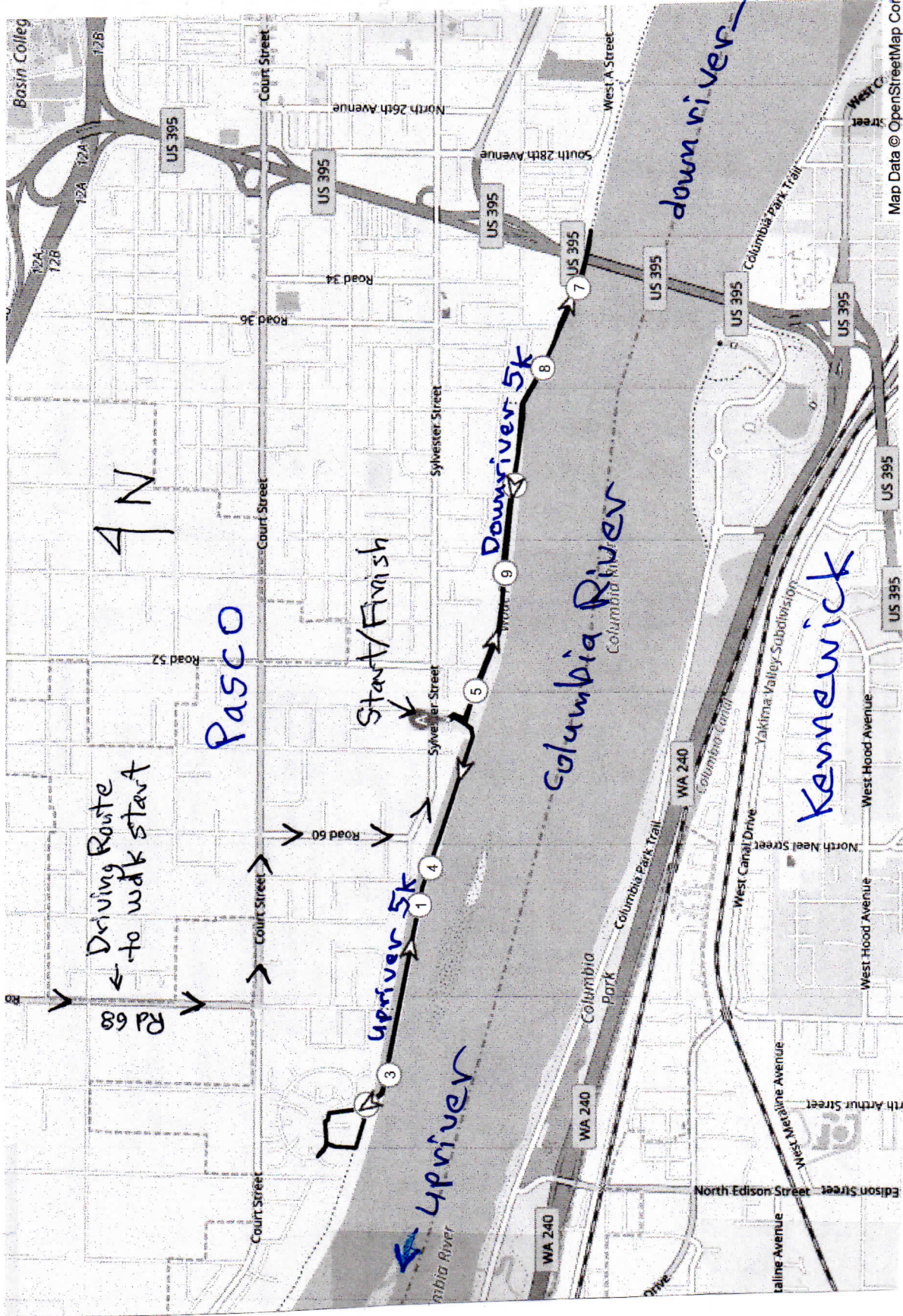
1. **FOLLOW** paved river trail with the river on your **left**. You will pass two access trails on your **right**.
2. At the next junction on the river trail which is a "Y", take the **RIGHT** hand paved trail which leads away from the river into the residential area. You will pass a play area on your **right**.
3. At the next trail junction, **ANGLE LEFT** on the paved trail and go past the small roundabout on Ivy Lane to Carnation Court.
4. Turn **AROUND** and retrace your steps back one block to Buttercup Court.
5. Turn **RIGHT** on Buttercup Ct. and go to the end. Go **STRAIGHT** on the asphalt trail off the end of Buttercup Ct to the river trail.
6. Turn **LEFT** on the river trail with the river on your **right** this time and return on the river trail to the parking lot and your vehicle.

Directions 7 through 9 are for the down river 5K

7. From entrance on paved bike path at Wade Park sign, go **STRAIGHT** along the path towards the Blue Bridge over the Columbia River. Stay to the **right** of the centerline on the trail keeping the river on your **right**.
8. Continue **STRAIGHT** on the path under the Blue Bridge to the first covered picnic bench on the **right**.
9. Turn **AROUND** at the picnic bench and retrace your steps back the way you came along the river trail with the river on your **left** this time, to the parking lot and your vehicle.

*The walk directions and map may only be used in conjunction with a signed AVA athletic waiver. All other uses are prohibited.*
