In case of Emergency Dial 911

Please use either the Online Start Box (OSB) or Physical Start Box (PSB) to register and complete the event. Do NOT mix and match, for example, by registering using the OSB then completing your event using the PSB nor signing the PSB log sheet. The sponsoring club only receives credit for an OSB participation when an OSB registration has been completed online by entering your participation date, distances, and any special programs using the OSB.

WALK COMPLETION AND CREDIT: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the date the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the users Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.

1. **EXIT** parking lot from the gas station entrance to Valley Ave. E. (unmarked)
2. **LEFT** on Valley Ave. E.
3. **CROSS** Main St. at light and **CONTINUE STRAIGHT** on Valley Ave. to 63rd St. Ct. E.
4. **LEFT** on 63rd St. Ct. E.
5. **ANGLE** right briefly.
6. **LEFT** to stay on 63rd St. Ct. E. to Parker Rd. E.
7. **CAREFULLY CROSS & RIGHT** on Parker Road E.
8. **ENTER** Rainier View Park.
9. **LEFT** onto trail in park following it around the back edges of the park (may be puddles & soft grass at back of park in winter).
10. **RIGHT** at "Y" in trail.
11. **EXIT** park through mosaic arch.
12. **RIGHT** on Meade McCumber Road E.
13. **CROSS** Valley Ave. E. and continue on Meade McCumber Road E. to Wood Ave.
14. **CROSS & LEFT** on Wood Ave. to Willow St.

**[Just after crossing Wood Ave. but before turning left, straight ahead behind wooden cross is a small labyrinth]

15. **RIGHT** on Willow St. to Sumner Ave.
16. **RIGHT** on Sumner Ave. to Park St. (seasonal Porta-potties in Loyalty Park)
17. **LEFT** on Park St. to Cherry Ave.
18. **RIGHT** on Cherry Ave. to Maple St.
19. **CROSS** Maple St. & **VEER RIGHT** on Cherry St. Continue past gazebo/Heritage Park to Main St.
20. **RIGHT** on Main St. to Alder Ave.
21. **RIGHT** on Alder Ave. to Maple St.
22. **LEFT** on Maple Street to Bonney Ave.
23. **LEFT** on Bonney Ave. to Main St.
24. **RIGHT** on Main St. to Valley Ave. intersection.
25. **LEFT & CROSS** Main St. at light.
26. **RIGHT & CROSS** Valley Ave. at same light.
27. **LEFT** on Valley Ave. E.
28. **RIGHT** into Fred Meyer parking lot and to your car.

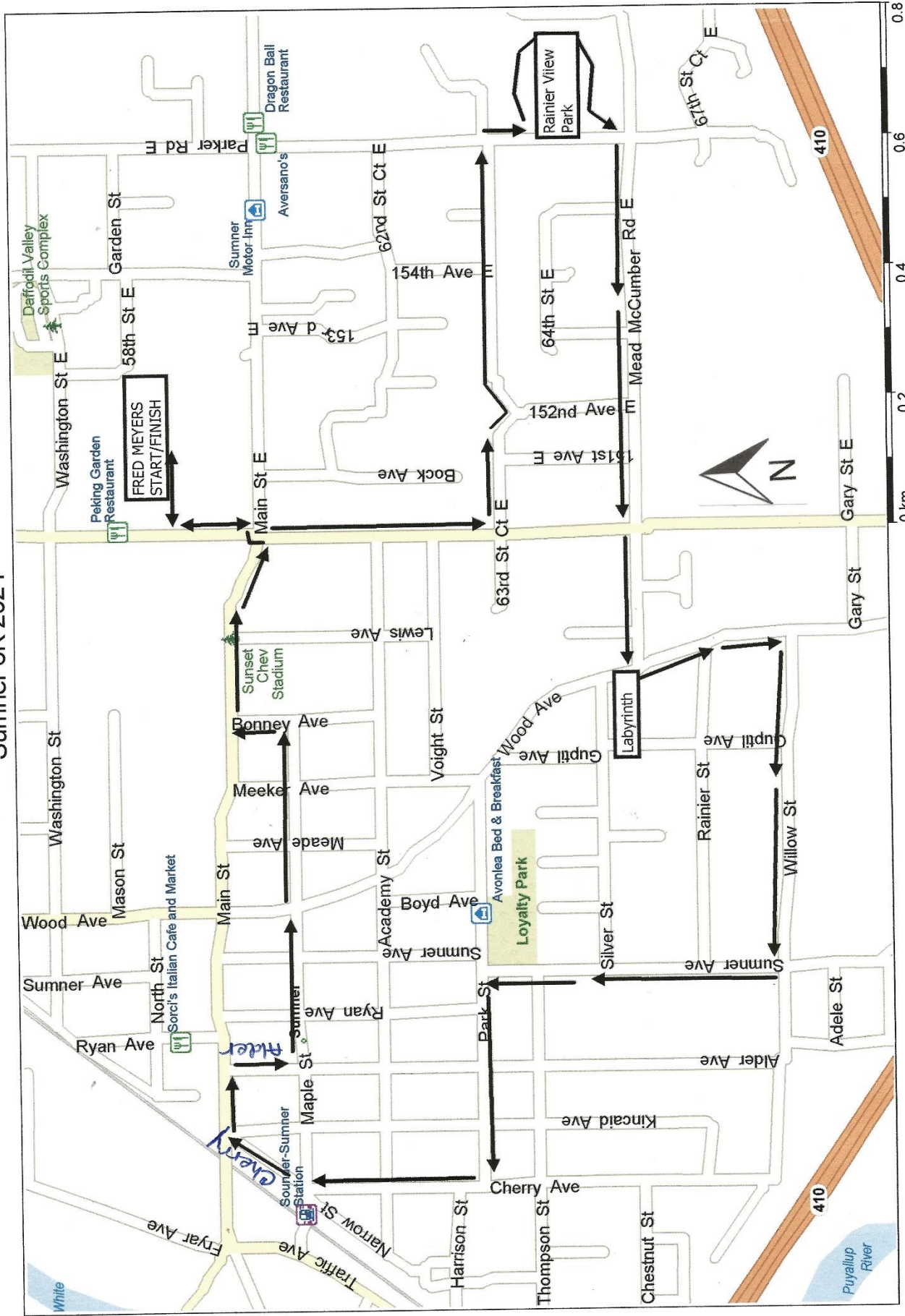

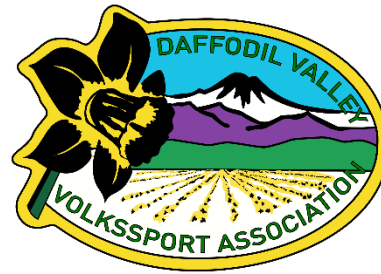

2. **LEFT** on Valley Ave. E.

4. **LEFT** on 63rd St. Ct. E.

6. **LEFT** to stay on 63rd St. Ct. E. to Parker Rd. E.
7. **CAREFULLY CROSS & RIGHT** on Parker Road E.
8. **ENTER** Rainier View Park.
9. **LEFT** onto trail in park following it around the back edges of the park (may be puddles & soft grass at back of park in winter).
10. **RIGHT** at "Y" in trail.
11. **EXIT** park through mosaic arch.
12. **RIGHT** on Meade McCumber Road E.
13. **CROSS** Valley Ave. E. and continue on Meade McCumber Road E. to Wood Ave.
14. **CROSS & LEFT** on Wood Ave. to Willow St.
**[Just after crossing Wood Ave. but before turning left, straight ahead behind wooden cross is a small labyrinth]
15. **RIGHT** on Willow St. to Sumner Ave.
16. **RIGHT** on Sumner Ave. to Park St. (seasonal Porta-potties at Loyalty Park)
17. **LEFT** on Park St. to Cherry Ave.
18. **RIGHT** on Cherry Ave. to Maple St.
19. **LEFT** on Maple St. (Maple is at the end of train station). **CROSS** railroad tracks to Traffic Ave.
20. **LEFT** on Traffic Ave. to State St.
21. **RIGHT** on State St. at light crossing Traffic Ave.
22. **CONTINUE STRAIGHT** on State St. to overpass
23. **RIGHT** to the trail before the overpass, going **RIGHT** on the trail.
24. **CONTINUE** on sidewalk as trail becomes W. Main St. to major intersection.
25. At intersection, **CROSS** Traffic Ave.
26. **LEFT & CROSS** Main St.
27. **STRAIGHT AHEAD** on Traffic Ave. which becomes Fryar Ave. to Zehnder St.
28. **RIGHT** on Zehnder St. crossing railroad tracks.
29. **CAREFULLY CROSS & LEFT** on Wood Ave. (no crosswalk) to 16th St.
30. **RIGHT** on 16th St. to Bonney Ave.
31. **RIGHT** on Bonney Ave. to Everett St.
32. **RIGHT** on Everett St. to Wood Ave.
33. **LEFT** on Wood Ave. to Main St.
34. **RIGHT** on Main St. Cherry St.
35. **LEFT** on Cherry Ave. crossing Main St. with care.
36. **CONTINUE STRAIGHT** on Cherry Ave.
37. **LEFT** on Maple St. to Bonney Ave.
38. **LEFT** on Bonney Ave. to Main St.
39. **RIGHT** on Main St. to Valley Ave. intersection.
40. **LEFT & CROSS** Main St. at light.
41. **RIGHT & CROSS** Valley Ave.
42. **LEFT** on Valley Ave. E.
43. **RIGHT** into Fred Meyer parking lot and to your car.
