DESCRIPTION

From 1-5 north or south bound take the OR-62 E exit, Exit 30 toward N. Medford/OR-238 E/Crater Lake. Follow OR 62E through White City to Eagle Point. Exit onto S. Shasta Ave and then an immediate left on Graystone Dr to the Superior Fitness parking area.

Walk Completion and Credit: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including day the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when submitting the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)

1. Leaving the parking lot, turn LEFT on Alta Vista, following the sidewalk to the break in the fence.
2. RIGHT on Hidden Valley Drive.
3. LEFT on Echo way.
4. RIGHT on Cherry Wood, which curves around.
5. CONTINUE STRAIGHT AHEAD at stop sign as it turns into Birch Wood.
6. LEFT on Cedar Wood (1 km)
7. RIGHT on Ponderosa.
8. CROSS Alta Vista to bike path, turn RIGHT.
9. At Golf Club CONTINUE on walking path (2k) Note pine tree just past driveway; acorn storage all over the trunk.
10. LEFT on R.T. Jones Jr Blvd, CROSS street to sidewalk. (3k just ahead). (5k at entrance to Oak Hill Mobile Home Park.)
11. Road turns into Main St. at bottom of hill (no sign.)
12. LEFT at Stevens when R.T. Jones Blvd ends (No street sign, but this is a T intersection).
13. RIGHT on Shasta (6k at Shasta & Onyx). Shasta turns into Park Dr.
14. Enter Butte Creek Park for view of Little Butte Creek and the back of Butte Creek Mill.
15. Walk to the end of park (fence line), TURN AROUND and retrace steps to Main St.
16. RIGHT on Main, walk through covered bridge.
17. RIGHT on So Royal (no sign) (7 k at Eagle Point Historical Museum.)
18. TURN AROUND at Butte Creek Mill ruins, the grist mill was built in 1872 and burned on Christmas Eve 2015.
19. LEFT on Loto (CROSS street before turning). Restrooms at Brown Park at Creekside — closed between October and March
20. RIGHT on Shasta, CROSS street to sidewalk. (8k at Shasta and Meadow).
21. CONTINUE on Shasta (9k at Arrowhead Trail Road).
22. LEFT on Alta Vista and back to parking lot.

6. LEFT on Cedar Wood (1k)
7. RIGHT on Ponderosa.
8. CROSS Alta Vista to bike path, turn RIGHT.
9. At Golf Club CONTINUE on walking path (2k)
Note pine tree just past driveway — acorn storage all over the trunk.
10. At R.T. Jones Jr Blvd, TURN AROUND and retrace steps.
11. Turn RIGHT at Golf Club Drive and walk to the entrance to Eagle Point Golf Club.
12. TURN AROUND back to Alta Vista.
13. Turn RIGHT and CONTINUE on Alta Vista back to parking lot.

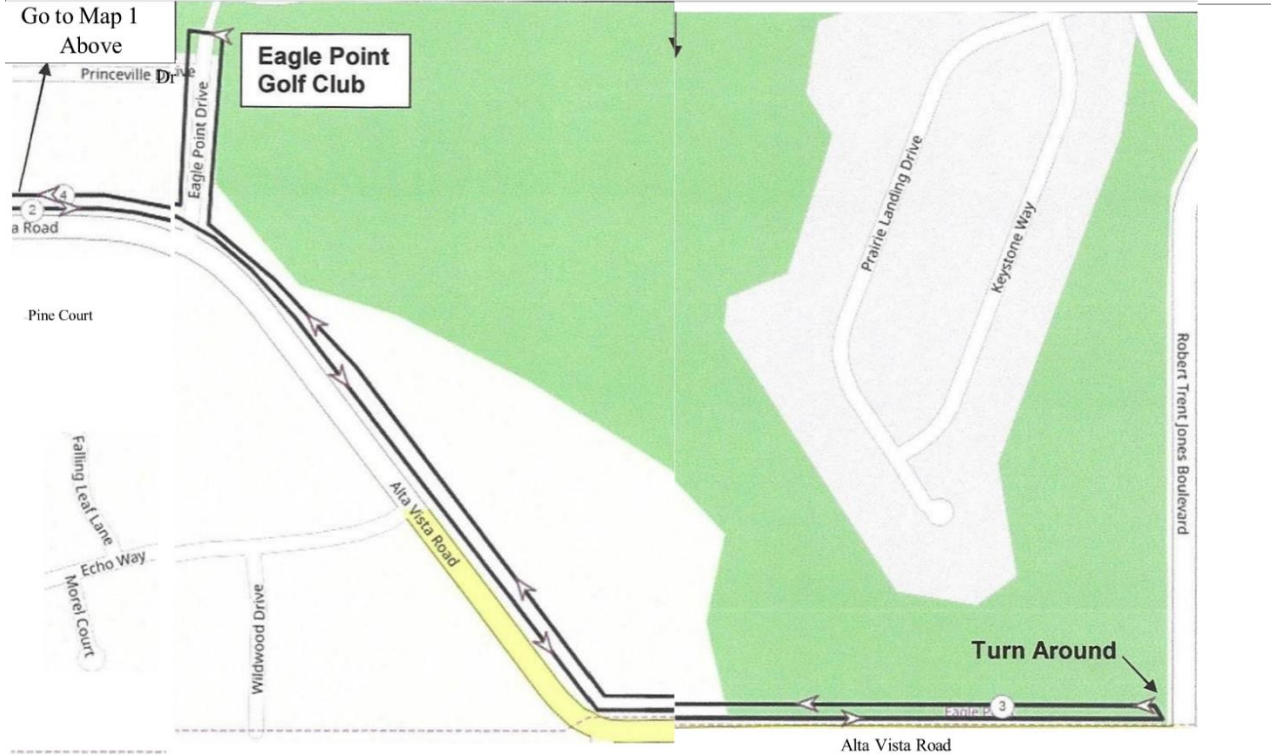
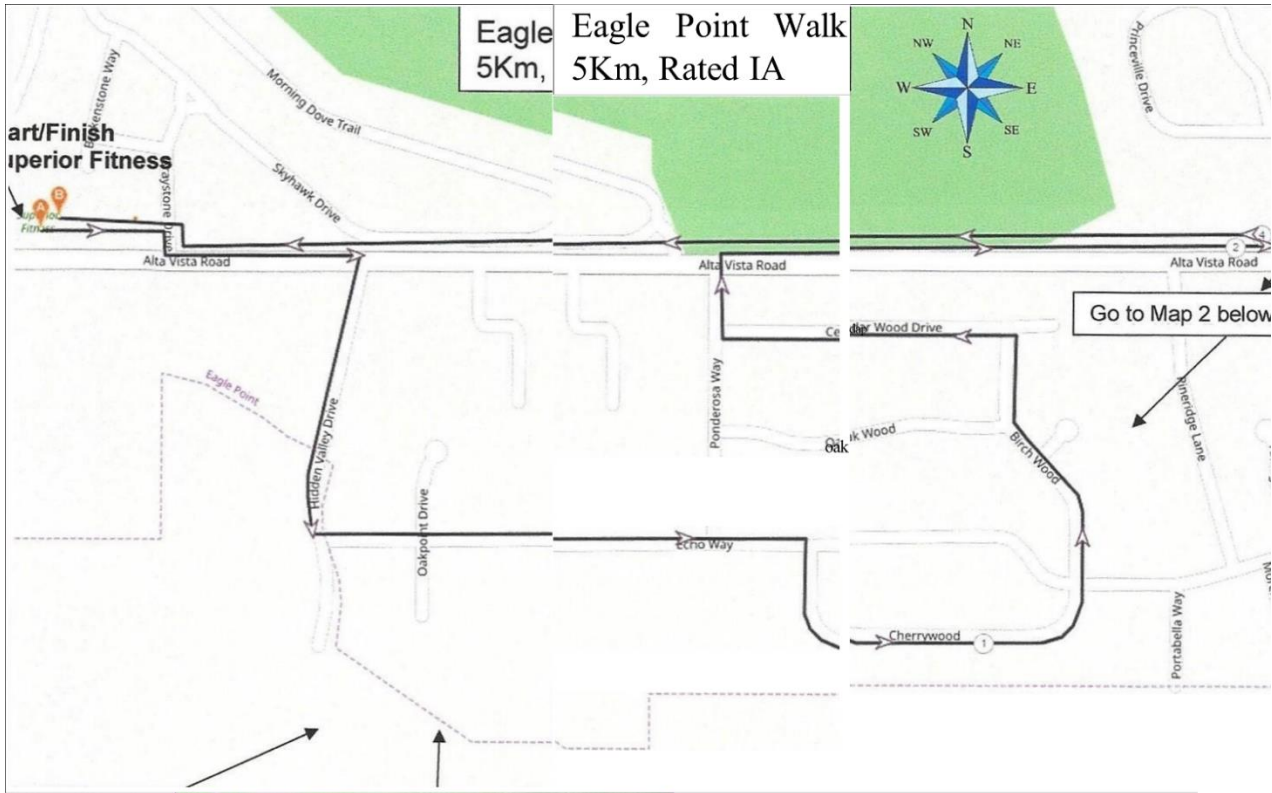
