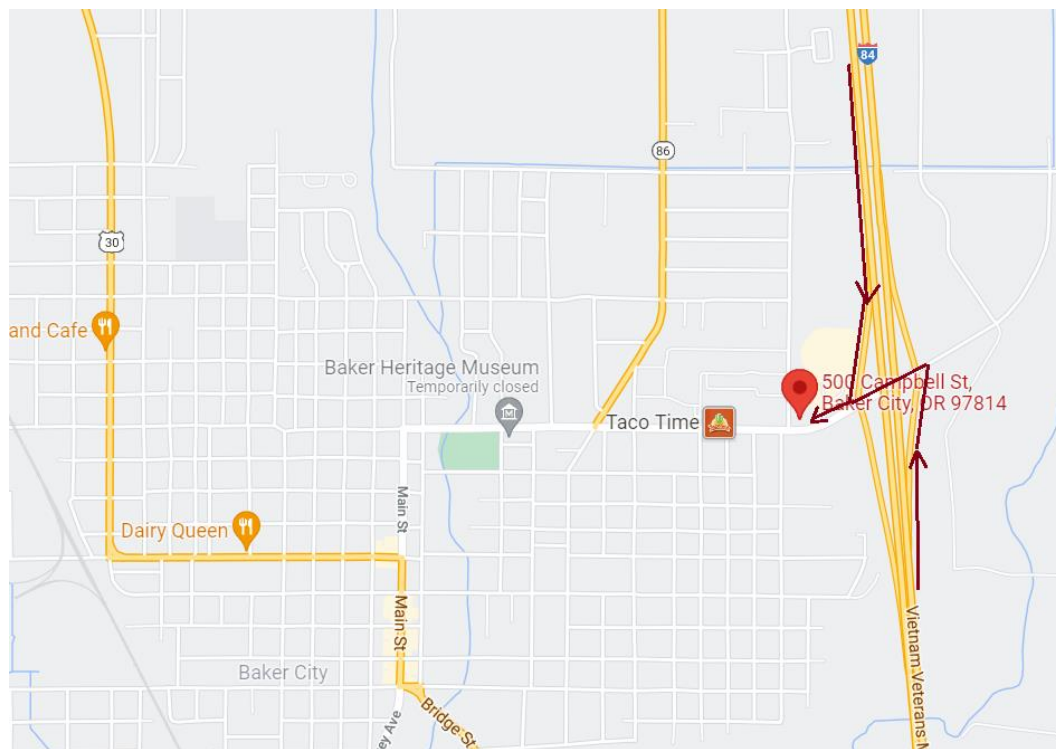

The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.

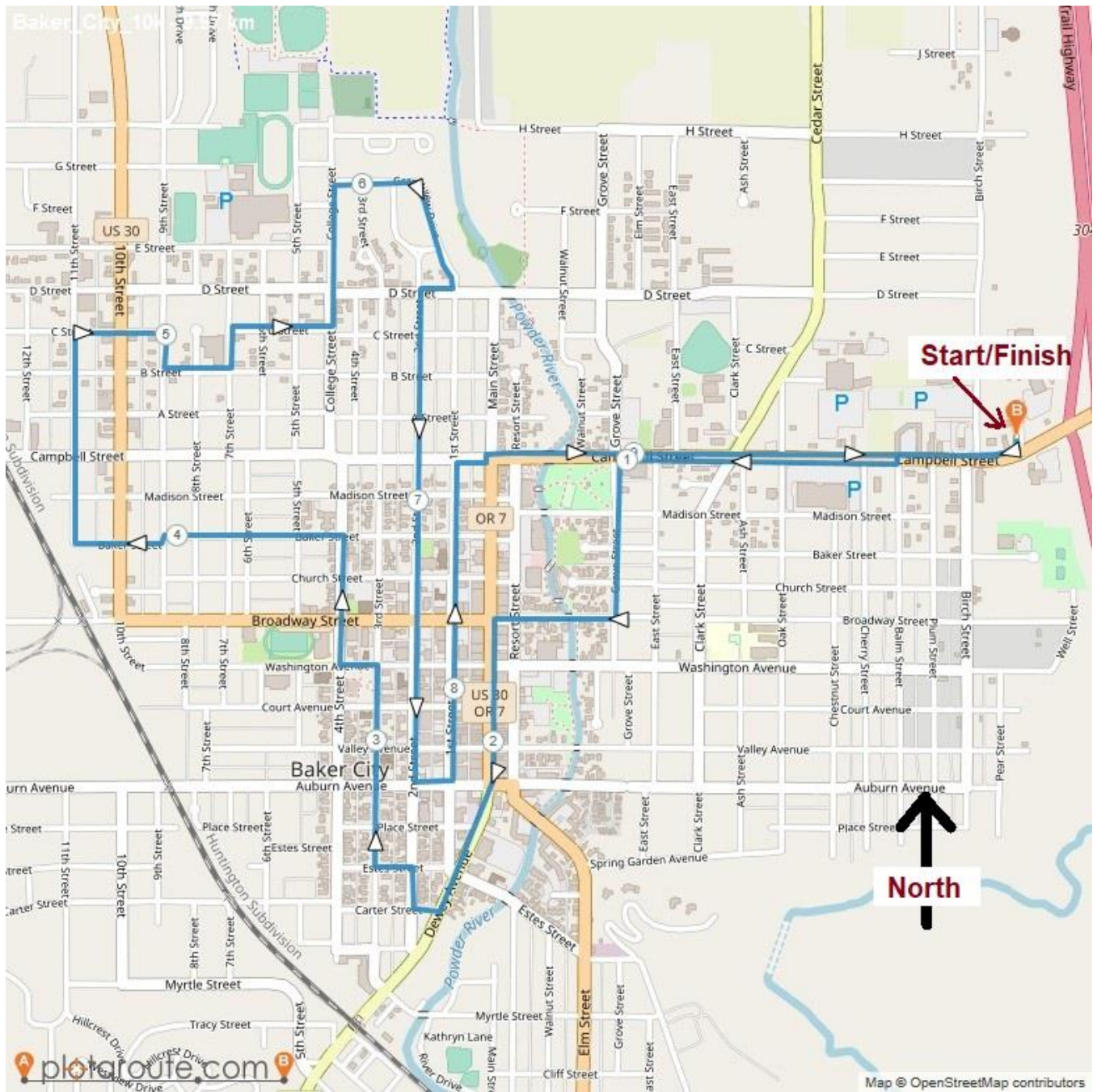

1. **EXIT** the Food Mart, turning **RIGHT** onto Campbell St. to Balm St.
2. **LEFT** on Balm St. to **CROSS** Campbell St. then **RIGHT** on other side to Grove St.
3. **LEFT** on Grove St. to Broadway St. (1k)
4. **RIGHT** on Broadway St. to Main St. (Slight Jog in Street)
5. **LEFT** on Main St. which becomes Dewey Ave. to Carter Ave. (2k)
6. **RIGHT** on Carter Ave. to 2nd St.
7. **RIGHT** on 2nd to Estes Ave.
8. **LEFT** on Estes Ave. to 3rd St.
9. **RIGHT** on 3rd St. to Washington Ave. (3k at Court St.)
Restrooms in Courthouse – Ladies thru back door, Men in basement)
10. **LEFT** on Washington Ave. to 4th St.
11. **RIGHT** on 4th to Baker St.
12. **LEFT** on Baker St. to 11th St.
13. **RIGHT** on 11th St. to C St. (4k)
14. **RIGHT** on C St. to 9th St., **CROSSING** 10th St (Hwy 30) on the right side with walk light.
15. **RIGHT** on 9th St. to B St.
16. **LEFT** on B St. to 7th St.
17. **LEFT** on 7th St. to C St. (5k)
18. **RIGHT** on C St. to College St.
19. **LEFT** on College St. to Grandview Dr.
20. **RIGHT** on Grandview Dr. which curves to the right to D St. (6k)
21. **RIGHT** on D St. to 2nd St.
22. **LEFT** on 2nd St. to Auburn Ave. (7k)
23. **LEFT** on Auburn Ave. to 1st St.
Restrooms in City Hall – In the front door up the inside steps
24. **LEFT** on 1st St. to Campbell St. (8k at 1st and Campbell)
25. **CROSS** Campbell St. then **RIGHT** on Campbell St. back to Start/Finish

1. **EXIT** the Food Mart, turning **RIGHT** onto Campbell St. to Balm St.

3. **LEFT** on Grove St. to Broadway St. (1k)
4. **RIGHT** on Broadway St. to Main St. (Slight Jog in Street)
5. **LEFT** on Main St. which becomes Dewey Ave. to Carter Ave. (2k)
6. **RIGHT** on Carter Ave. to 2nd St.
7. **RIGHT** on 2nd St. to Auburn Ave.
8. **RIGHT** on Auburn Ave. to 1st St.
Restrooms in City Hall – go in front door up the inside steps. (3k)
9. **LEFT** on 1st St. to Campbell St.
10. **CROSS** then **RIGHT** on Campbell St. (4k at Grove St.)
11. **Finish** at 500 Campbell St.
