**Walk Start Location:** Walmart Supercenter, 901 Row River Rd., Cottage Grove, OR 97424.

**Driving Directions:** From 1-5 take exit 174 toward Cottage Grove; 0.3 miles turn left onto Row River Rd.; 0.5 miles turn right onto Thomas Lane; 250 ft. arrive at Walmart.

**GPS Coordinates:** 43.80023, -123.04275

**Park:** In parking lot.

**Restrooms:** Walmart and Cottage Grove business area.

**Walk Completion and Credit:** Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including that the event was walked, the distance walked and the selection of applicable special programs that a person is participating in. (A fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when they submit the event completion info as a payment for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days).

Please use either the Online Start Box (OSB) or Physical Start Box (PSB) to register and complete the event. Do NOT mix and match. The sponsoring club only receives credit for an OSB participation when an OSB registration has been completed online by entering your participation date, distances and any special programs using the OSB.

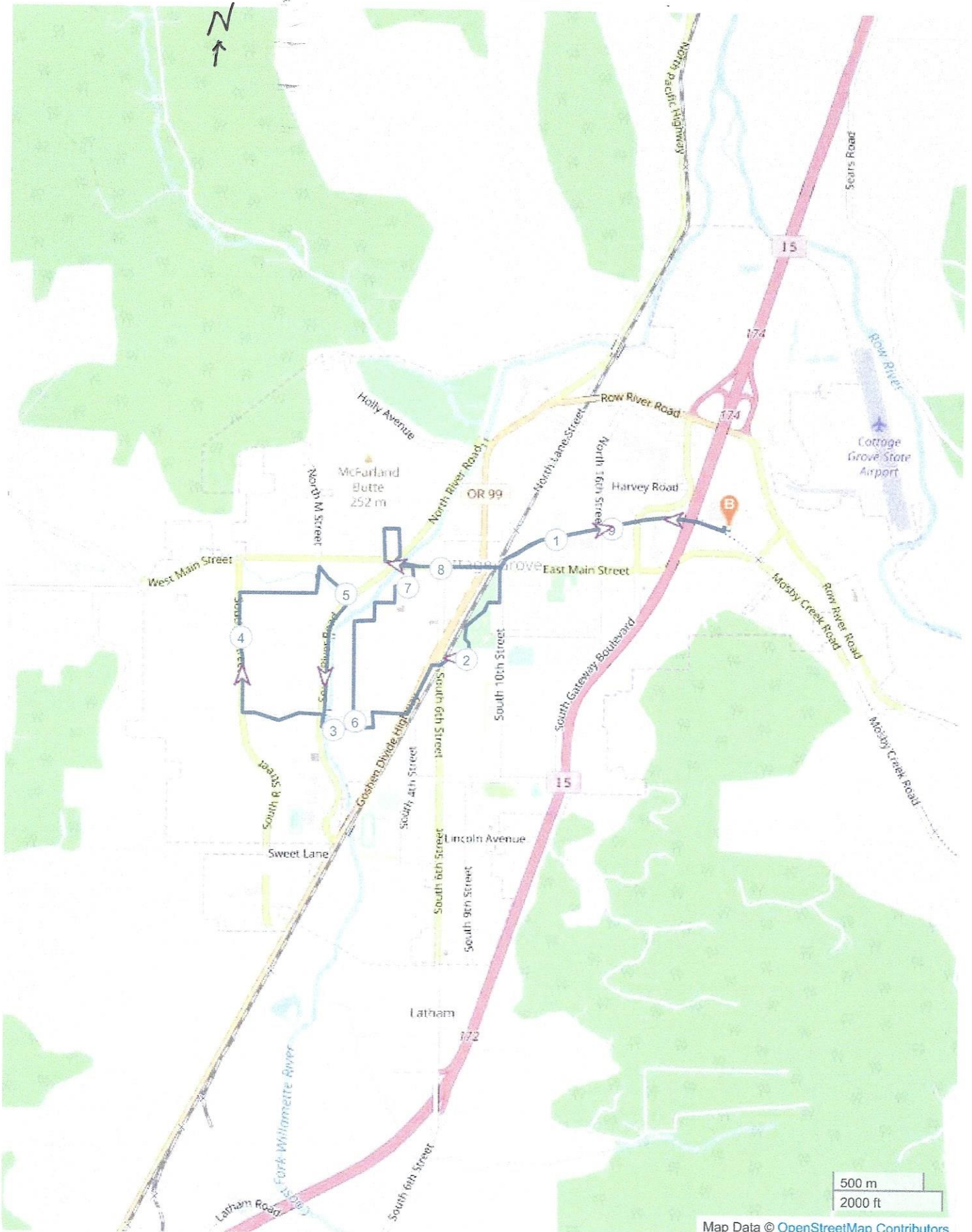
# **Cottage Grove Covered Bridge 10k walk rate 1A ©2021**

1. Facing Walmart, left on walkway thru treed area, cross road and up to the Row River trail.
2. Right on Trail for some distance to Main St.
3. Cross Main onto 10<sup>th</sup> Street. to Bohemia Park.
4. Right onto walk to circle counter-clockwise around park to exit opposite end onto 8<sup>th</sup> Street to Monroe Street.
5. Right on Monroe; circle left to Quincy Ave.
6. Right to cross tracks to Hwy. 99.
7. Left on Hwy. to Harrison Avenue.
8. Right on Harrison to 2<sup>nd</sup> Street.
9. Let on 2<sup>nd</sup> to Tyler Avenue.
10. Right on Tyler to Chambers Covered Bridge.
11. Cross Bridge to River Road.
12. Right on River Road to Harrison Avenue.
13. Left on Harrison to R Street.
14. Right on R St. to Anthony Road.
15. Right on Anthony to M Street.
16. Left on M Street to a short way to Old Mill Place Road (gravel Road on the right).
17. Right on Old Mill Place to River Road.
18. Cross and Right on Road to Chambers Bridge.
19. Left to cross bridge to South 1<sup>st</sup> Street.
20. Left on 1<sup>st</sup> to Jefferson Street.
21. Right on Jefferson to 2<sup>nd</sup> Street.
22. Left on 2<sup>nd</sup> to Adams Avenue.
23. Right on Adams to 3<sup>rd</sup> Street.
24. Left on 3<sup>rd</sup> to Washington Avenue.
25. Right on Washington a short distance to an Alley.
26. Left on Alley to Main Street.
27. Left on Main to River Road and cross to I Street.
28. Right on I Street to Birch Avenue.
29. Right on Birch to **RIGHT on H Street** to River Road.
30. Right on River Road to main.
31. Cross River Road and walk thru covered bridge and straight on Main to Row River Trail.
32. Left on Row River Trail to finish at Walmart.

1. Facing Walmart go left thru a treed area cross road and up to the Row River Trail.
2. Right on Row River trail quite a distance to Main Street.
3. cross Main onto 10<sup>th</sup> Street, and continue to Bohemia Park.
4. Right on first sidewalk to circle the park counter- clockwise and exit at the opposite onto 8<sup>th</sup> Steet to Monroe Avenue.
5. Right on Monroe and circle left to Quincy.
6. Right on Quincy to Hwy. 99 and Left on Hwy. to Harrison Avenue.
7. Cross Straight on Harrison to 2<sup>nd</sup> Street.
8. Left on 2<sup>nd</sup> to Tyler Avenue.
9. Right on Tyler to Chambers Covered Bridge.
10. Cross Chambers Bridge to River Road.
11. Right on River Road quite a distance to Main Street.
12. Cross Main and Right to walk through covered bridge and out onto Main Street.
13. Straight on Main, cross tracks to Row River Trail.
14. Left on trail back to Walmart parking and finish.
