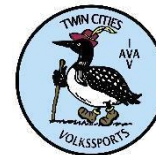

**DIRECTIONS:** Country Inn, 1204-7th Ave, Two Harbors 55616. (218-834-5557 or 877-604-5332 reservations and info only [www.countryinntwoharbors.com](http://www.countryinntwoharbors.com) ). Located 22 miles north of Duluth on Hwy 61 next to McDonald's. Walk from dawn to dusk. **REMOTE START POINT**

**FOR THE 5KM** is 1.5 miles from Country Inn at the Agate Bay public water access and Lighthouse Museum. **COMMENTS:** Route is along paved sidewalks and unpaved trails with some small hills. Free parking at starting points. Restrooms available at start point and at parks, businesses, and waterfront along the route.

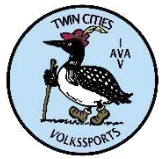
**WALK COMPLETION AND CREDIT:** Combined OSB/PSB event. Please use either the Online Start Box (OSB) or Physical Start Box (PSB) to register and complete the event. Do NOT mix and match, for example, by registering using the OSB then completing your event using the PSB nor signing the PSB log sheet.

If you are registered via OSB, be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the date the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when they submit the event completion info as a payment for credit participant. Note however that the \$2 coupon for the downloaded PDF expires in 60 days. Also note that an event registration expires after 30 days, but if your registrations lapses, you may re-register without cost.

### Driving Directions to 5 km

#### Start Point:

- a. Exit Country Inn to the **Left** and out the driveway to Hwy 61/Voyager Hwy/7<sup>th</sup> Ave
  - b. **Right** on Hwy 61/Voyager Hwy/7<sup>th</sup> Ave
  - c. **Right** on Waterfront Dr/6<sup>th</sup> St
  - d. **Left** on South Ave
  - e. **Right** on 3<sup>rd</sup> St/Lighthouse Point Rd
- Park in Parking Lot**

#### 5 km Walking Directions:

1. From the parking lot, use the stairs or ramp to the breakwater
2. **Walk** to the lighthouse and **Return** to the parking lot
3. **Exit the parking lot** on Lighthouse Point Rd/3<sup>rd</sup> St
4. **Right** onto the Two Harbors Lake Walk (trail lined with large rocks)
5. **Cross** South Ave and continue on sidewalk
6. **Right** at the end of the sidewalk onto the trail between two large rocks staying to the right and following the trail along the lakeshore
7. **Right** and continue on the trail with 1<sup>st</sup> St/ N Shore Scenic Dr/Park Road on your right
8. **Left** on the road just past the trailer park on your left
9. **Straight** onto Hwy 61/Voyager Hwy/7<sup>th</sup> Ave
10. **Continue** on Hwy 61/Voyager Hwy/7<sup>th</sup> Ave
11. **Left** on N Shore Scenic Dr/Waterfront Dr/6<sup>th</sup> St
12. **Right** on 2<sup>nd</sup> Ave
13. **Left** on 7<sup>th</sup> St
14. **Left** through the parking lot past the two locomotives and the Lake County Depot Museum onto South Ave
15. **Right** on 3<sup>rd</sup> St/Lighthouse Point Rd to the start point

## Two Harbors 10 km Walk

1. Exit Country Inn to the **Left** and out the driveway to Hwy 61/Voyager Hwy/7<sup>th</sup> Ave
2. **Right** on Hwy 61/Voyager Hwy/7<sup>th</sup> Ave
3. **Right** on Waterfront Dr/6<sup>th</sup> St
4. **Right** on 2<sup>nd</sup> Ave
5. **Left** on 7<sup>th</sup> St
6. **Left** through the parking lot to the front of the first locomotive
7. **Right** on N Shore Scenic Dr/Waterfront Dr/6<sup>th</sup> St to the shoreline (you will see the tugboat Edna G on the right)
8. **Left** onto the path along the shoreline.
9. **Right** on Lighthouse Point Rd/3<sup>rd</sup> St and follow the walkway with the parking lot on your left
10. Walk the breakwall to the lighthouse
11. **Return** on the breakwall and go up the stairs or ramp
12. **Make two Right turns** and walk through the archway
13. **Follow** the trail with the Lighthouse Museum on your left and the lake on your right
14. **Left** at the Y
15. **Right** on the paved path (Two Harbors Lake Walk)
16. **Cross** South Ave and continue on sidewalk
17. **Right** and continue on the trail with 1<sup>st</sup> St/ N Shore Scenic Dr/Park Road on your left
18. **Left** on the road just past the trailer park on your left
19. **Continue** onto Hwy 61/Voyager Hwy/7<sup>th</sup> Ave
20. **Right** at 4<sup>th</sup> St crossing Hwy 61/Voyager Hwy/7<sup>th</sup> Ave and passing the Holiday Station
21. **Right** the trail between Holiday and the Lake County Arena. **Stay Left** on the trail as the right side is for golf carts
22. **Continue** on the trail with the golf course on your right
23. **Left** at the Y to 4<sup>th</sup> St 24. **Left** on 4<sup>th</sup> St
25. **Right** on 12<sup>th</sup> Ave crossing 4<sup>th</sup> St
26. **Left** on 8<sup>th</sup> St
27. **Right** on 11<sup>th</sup> Ave
28. **Left** on 9<sup>th</sup> St
29. **Right** on Hwy 61/Voyager Hwy/7<sup>th</sup> Ave
30. **Left** at 11<sup>th</sup> St crossing Hwy 61/Voyager Hwy/7<sup>th</sup> Ave at the light returning to the start point
