GPS LOCATION: 47.362534, -122.023065

Restrooms: Restrooms inside store and along the route (in parks, seasonally)

Driving Directions: From SR 167: Take SR 18 east 9 miles to SE 272nd St. (SR 516). RIGHT on SE 272nd St. 5 miles to Four Corners Square. LEFT at 238th Ave. SE. RIGHT at next street. LEFT in Johnson Home and Garden parking lot. PLEASE PARK AWAY FROM THE FRONT OF THE STORE.

In case of Emergency Dial 911 State your location, Speak clearly and slowly.

Please use either the Online Start Box (OSB) or Physical Start Box (PSB) to register and complete the event. Do NOT mix and match, for example, by registering using the OSB then completing your event using the PSB nor signing the PSB log sheet. The sponsoring club only receives credit for an OSB participation when an OSB registration has been completed online by entering your participation date, distances, and any special programs using the OSB.

WALK COMPLETION AND CREDIT: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participants Event Bank until they have submitted event completion info including the date the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the users Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.

1. Exit Johnson's Home and Garden Center, past check out area, **RIGHT** to the entrance street.
2. **RIGHT** to unmarked 238 Ave. So., cross street and **LEFT** TO GRAVEL TRAIL (UNMARKED Kent-Kangley Rd./238 Ave. So.)
3. **RIGHT**, then after short distance **RIGHT** at the gravel trail, through the metal gate entrance to the Green to Cedar Trail. **10k passes under 4 bridges**
4. **5K TURN-AROUND** is just past Lake Wilderness on left and wood fence on right is a wood post on the right.

1K OPTION in the Lake Wilderness Arboretum.

- **At 5K Turnaround** and the end of Lake Wilderness on the left, **LEFT** on dirt path.
- **RIGHT** at parking lot.
- **RIGHT** on path just past map kiosk.
- Ignoring all side paths, **KEEP STRAIGHT** going through a major intersection. You will then pass a fenced area with piles of black plant pots on your left.
- **STRAIGHT** at intersection with stairs. You will pass a series of colorful story signs.
- **CONTINUE** on loop trail as it curves left.
- **LEFT** on path near small parking lot to next parking lot.
- **LEFT** on road at this second parking lot. **STRAIGHT** past pergola, then continue **STRAIGHT**.
- **STRAIGHT** at major intersection of many paths putting the short, white water post on your right.
- At the top of the hill, **LEFT** to continue 10/11k **RIGHT** for 5K/6K return to finish.
- *****There are many side paths and specialty gardens you may visit.**

5. **10K** Continue to the 4th bridge, turn around and retrace your steps.
6. At St. George's Episcopal Church (on left), **LEFT** to the Labyrinth.
7. Return to the Green to Cedar trail (on right when reading the information sign).
8. **LEFT** on the trail and return to the finish.
