1. Standing in Pioneer Park parking lot off NW 4th St., facing Playground sign with play equipment in front of you
2. **LEFT** to the sidewalk then **RIGHT** on sidewalk, keeping the playground equipment on your right to NE Despain Ave.
3. **RIGHT** on NW Despain Ave. to N. Main St.
4. **RIGHT** on N. Main St. to SE Byers Ave.
5. **LEFT** on SE Byers Ave., **JOG RIGHT** at 5th St. **CONTINUING** on SE Byers Ave. to SE 7th St.
6. **RIGHT** on SE 7th St. to SE Court Ave. (1k)
7. **LEFT** on SE Court Ave. The street name changes at 8th or 9th St. to SE Court Place. **CONTINUE** to Pendleton Woolen Mills.
8. **LEFT** to Pendleton Woolen Mills Store. Then **RETURN** to SE Court Place. (2k)
9. **RIGHT** on SE Court Place to SE 12th St.
10. **RIGHT** on SE 12th St. to SE Byers Ave.
11. **LEFT** on SE Byers Ave. to SE 8th St.
12. **RIGHT** on SE 8th St. to River Trail (1k). DO NOT CROSS THE BRIDGE (3k)
13. **LEFT** on Umatilla River Trail, just before the Bridge to the end of the trail, SE Byers Ave.
14. **RIGHT** on SE Byers Ave. to S. Main St.
15. **LEFT** on S Main St. to SE Dorian Ave. (4k)
16. **CROSS** and **LEFT** on SE Dorian Ave. to SE 4th St.
17. **RIGHT** on SE 4th St. to SE Emigrant Ave.
18. **RIGHT** on SE Emigrant Ave. to S Main St.
19. **CROSS** and **LEFT** on S Main St. DO NOT CROSS RR TRACKS.
20. Just before the RR Tracks, **RIGHT** on sidewalk toward the Museum, pass the Union Caboose, to a tall windmill at the end of the Museum grounds (SW 4th St./SW Frazer Ave) (5k)
21. At the windmill, **Turnaround** and **Return** on the sidewalk back to S Main St.
22. **LEFT** on S Main St. to the light at SW Frazer Ave. (Pendleton Chamber of Commerce/Visitor Information Center/Restrooms)
23. **LEFT** on SW Frazer Ave. to SW 1st St.
24. **RIGHT** on SW 1st St. to SW Dorian Ave.
25. **LEFT** on SW Dorian Ave. to SW 10th St.
26. **LEFT** on SW 10th St. to SW Emigrant Ave. (6k)
27. **RIGHT** on SW Emigrant Ave. to SW 20th St.
28. **RIGHT** on SW 20th St. to SW Court Pl/Ave (7k)
29. **CROSS** and **RIGHT** on SW Court Pl/Ave
30. AFTER RR Tracks, **CONTINUE** and **CROSS** Pendleton Hwy/SW Court Ave. toward the Rodeo Building
31. **RIGHT** to pass the Pendleton Roundup build on your Left to SW 12th Ave. (8k)
32. **LEFT** (at Bronco) on SW 12th and keep **Left** to River Trail. (Roy Raley Park on right has restrooms)
33. **LEFT** on River Trail to Bedford Bridge
34. **RIGHT** on Bedford Bridge, crossing Umatilla River, to NW Carden Ave. (9k)
35. **RIGHT** on NW Carden Ave. (no sigh) to SW 5th St.
36. **CROSS** SW 5th St and **UP** the stairs into Pioneer Park, passing the Restrooms back to the parking lot and **FINISH**.

3. **RIGHT** on NW Despain Ave. to N. Main St.
4. **RIGHT** on N. Main St. to SE Byers Ave.
5. **LEFT** on SE Byers Ave., **JOG RIGHT** at 5th St. **CONTINUING** on SE Byers Ave. to SE 8th
6. **LEFT** on SE 8th St. to River Trail (1k). DO NOT CROSS THE BRIDGE
7. **LEFT** on Umatilla River Trail, just before the Bridge to the end of the trail, SE Byers Ave.
8. **RIGHT** on SE Byers Ave. to S. Main St. (2k)
9. **LEFT** on S Main St. to SE Dorian Ave.
10. **CROSS** and **LEFT** on SE Dorian Ave. to SE 4th St.
11. **RIGHT** on SE 4th St. to SE Emigrant Ave.
12. **RIGHT** on SE Emigrant Ave. to Main St.
13. **CROSS** Main St. then **LEFT** to SW Frazer Ave. (3k)
14. **RIGHT** on SW Frazer Ave. to SW 1st St.
15. **RIGHT** on SW 1st St. to SW Dorian Ave.
16. **LEFT** on SW Dorian Ave. to SW 5th St.
17. **RIGHT** on SW 5th St. to SW Court Ave.
18. **RIGHT** on SW Court Ave. to Main St. (4k at SW 3rd St.)
19. **LEFT** on Main St. to NW Bailey Ave.
20. **LEFT** on NW Bailey Ave. to NW 5th St.
21. **RIGHT** on NW 5th St. to NW Carden Ave.
22. **RIGHT** and **UP** the stairs into Pioneer Park, passing the Restrooms back to the parking lot and **FINISH**.
