This walk is composed of 5 and 10km routes. This walk explores the Raton which is the county seat of Colfax County. The 5k route explores the historic downtown district while the 10k walks out to the high school and Mt Calvary Cemetery before joining the 5k route and the downtown district.

Walk Registration:

Please use the Online Start Box (OSB) or the Permanent Walk Box at the Raton New Mexico Visitor Center at 100 Clayton Road (US-87). The Visitor Center is opened 10AM-5PM, Mon thru Fri.

Walk Completion and Walk Credit:

Once you have completed the walk, please login to your Online Start Box account click on the "My Start Box" tab, then the "Finish Table" tab, then click on "Go to Finish Table" button for the event you have completed. Use the displayed entry form to submit the date and distance of your walk as well as select applicable AVA Special Programs to generate stamped "virtual" insert cards that you may choose to print out.

Driving Directions to Start Point:

The 10k walk starts at the Raton New Mexico Visitor Center at 100 Clayton Rd (US-64/87) which is about 1/2 mile west of I-25. The Visitor Center is located on the NE corner of Clayton Rd and 2nd St and is open Mon-Fri from 10:00 to 5:00. The 5k walk starts at Legion Park on Legion Drive. From the Visitor Center at 100 Clayton, right on 2nd St about ½ mile to Legion Dr (on the left). Turn left on Legion and park along the park on the left. Restrooms available at the visitor center and at businesses along the route.

RATON - COLFAX COUNTY – 10K

These walk directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.

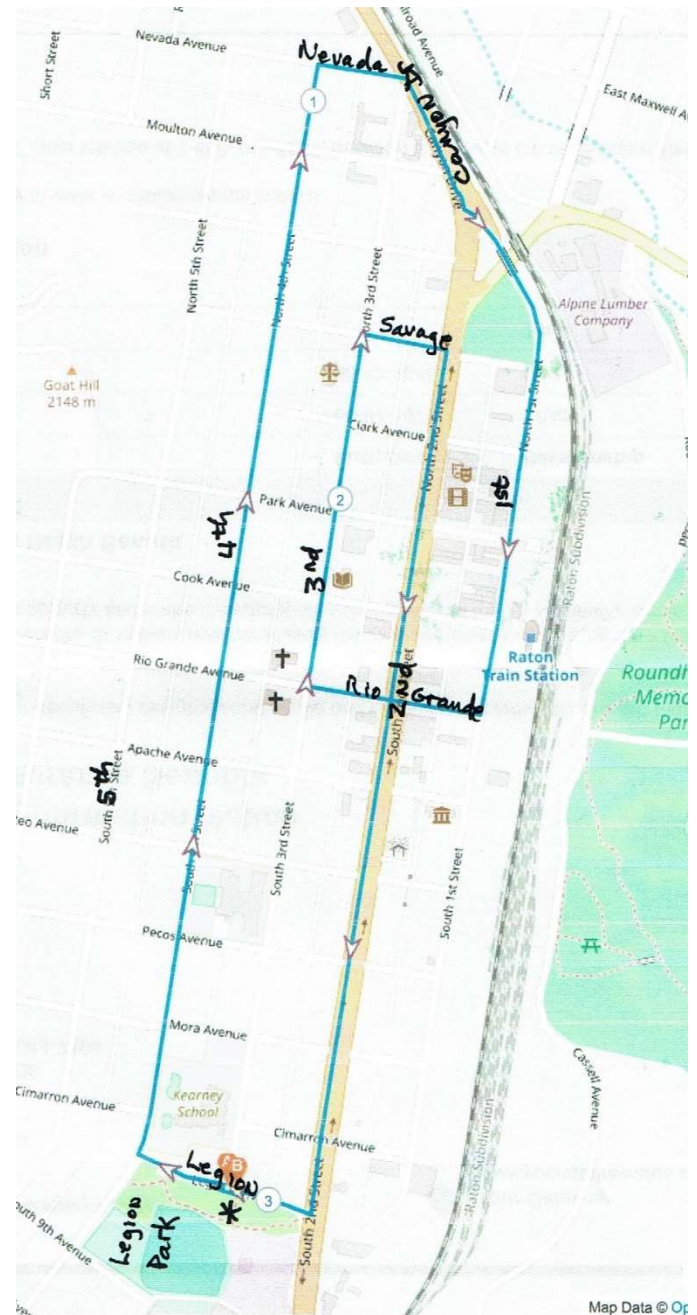
1. From the visitor center, walk the corner of Clayton (Tiger Dr) and 2nd St.
2. **CROSS** 2nd and continue straight on Clayton (becomes Tiger Drive) toward the mountains.
3. Continue on Tiger Dr about 1 mile crossing the railroad tracks and Raton High School on left and Mt Calvary Cemetery on the right.
4. Tiger Road becomes Red River Road at the cemetery.
5. **RIGHT** on Snead (no sign, but 1st street after the cemetery) 1 block to Park Hill.
6. **LEFT** on Park Hill 3 blocks to Hogan.
7. **RIGHT** on Hogan 1 block to Nelson Rd.
8. **RIGHT** on Nelson 3 blocks to Snead.
9. **RIGHT** on Snead 1 block to Park Hill.
10. **LEFT** on Park Hill 1 block to a fork in the road.
11. **VEER RIGHT** on Hillside Rd 1 long block to Scenic Dr. Mt Calvary Cemetery on the right.
12. **RIGHT** on Scenic Road (no sign) 3 blocks to 5th St.
13. **LEFT** on 5th about 9 blocks to Pecos Ave (stop sign, no street sign).
14. **RIGHT** on Pecos 1 block to 4th St and the Raton Middle School.
15. **LEFT** on 4th about 10 blocks to the end of the street at Nevada.
16. **RIGHT** on Nevada 1 block to Canyon Road (Main Highway).
17. **RIGHT** on Canyon Rd 2 blocks to Molton Ave, then cross Canyon Rd at the crosswalk to Ripley Park.
18. **RIGHT** on Canyon Rd and continue over the bridge to 1st St.
19. **RIGHT** on 1st 4 blocks to Rio Grande.
20. **RIGHT** on Rio Grande 2 blocks to 3rd.
21. **RIGHT** on 3rd 4 blocks to Savage passing the Post Office and the Colfax County Courthouse.
22. **RIGHT** on Savage 1 block to 2nd.
23. **CROSS and RIGHT** on 2nd about 1 mile passing thru the business district and passing the Raton Public Service power plant.
24. Continue on 2nd going under the railroad underpass and finally returning to the Visitor Center. **END of 10K.**

RATON – COLFAX COUNTY – 5K

These walk directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.

1. From the visitor center, drive to the start point at Legion Park. Right on 2nd about ½ mile to Legion Drive on the left. Left on Legion and park along the park on the left.
2. With your back to the park, **LEFT** on Legion ½ block to 4th St.
3. **RIGHT** on 4th about 12 blocks to the end of the street at Nevada.
4. **RIGHT** on Nevada 1 block to Canyon Road (Main Highway).
5. **RIGHT** on Canyon Rd 2 blocks to Molton Ave, then cross Canyon Rd at the crosswalk.
6. **RIGHT** on Canyon Rd and continue over the bridge to 1st St.
7. **RIGHT** on 1st 3 blocks to Rio Grande.
8. **RIGHT** on Rio Grande 2 blocks to 3rd.
9. **RIGHT** on 3rd 4 blocks to Savage passing the Post Office and the Colfax County Courthouse.
10. **RIGHT** on Savage 1 block to 2nd.
11. **CROSS and RIGHT** on 2nd about ¾ mile passing thru the business district.
12. Continue to Legion Dr, then **RIGHT** returning to your car. **END of 5K.**
