### **Driving Instructions to Start Point**

#### **Directions from I-90:**

Exit 281 (Division Street)  
Eastbound exit right and then left on Division (under I-90)  
Westbound exit right and then right on Division.  
North to W. Riverside Avenue.  
Left on W. Riverside.  
Right on Washington Street to W. Main.  
Aunties' is on left.

#### **Parking in the area of Auntie's:**

On Street Parking: Meters have a maximum of 2 hours

Off Street Parking: There is a large parking lot to the north of Auntie's (fee is dependent on number of hours)

NOTE: There is a physical start box at this location

#### **AVA Special Programs:**

Walking the USA A-Z (S), Walking the 50 State (WA), IVV-Americas, Town Halls/City Halls, Grain Elevators

#### **ESVA Challenge Programs:**

39 Counties (Spokane), All Clubs (LCVA), Front Line Heroes (Fire Station, Restaurant), Strolling Along the River (Spokane), That's Entertainment (Museum Theater), Tell Me A Story

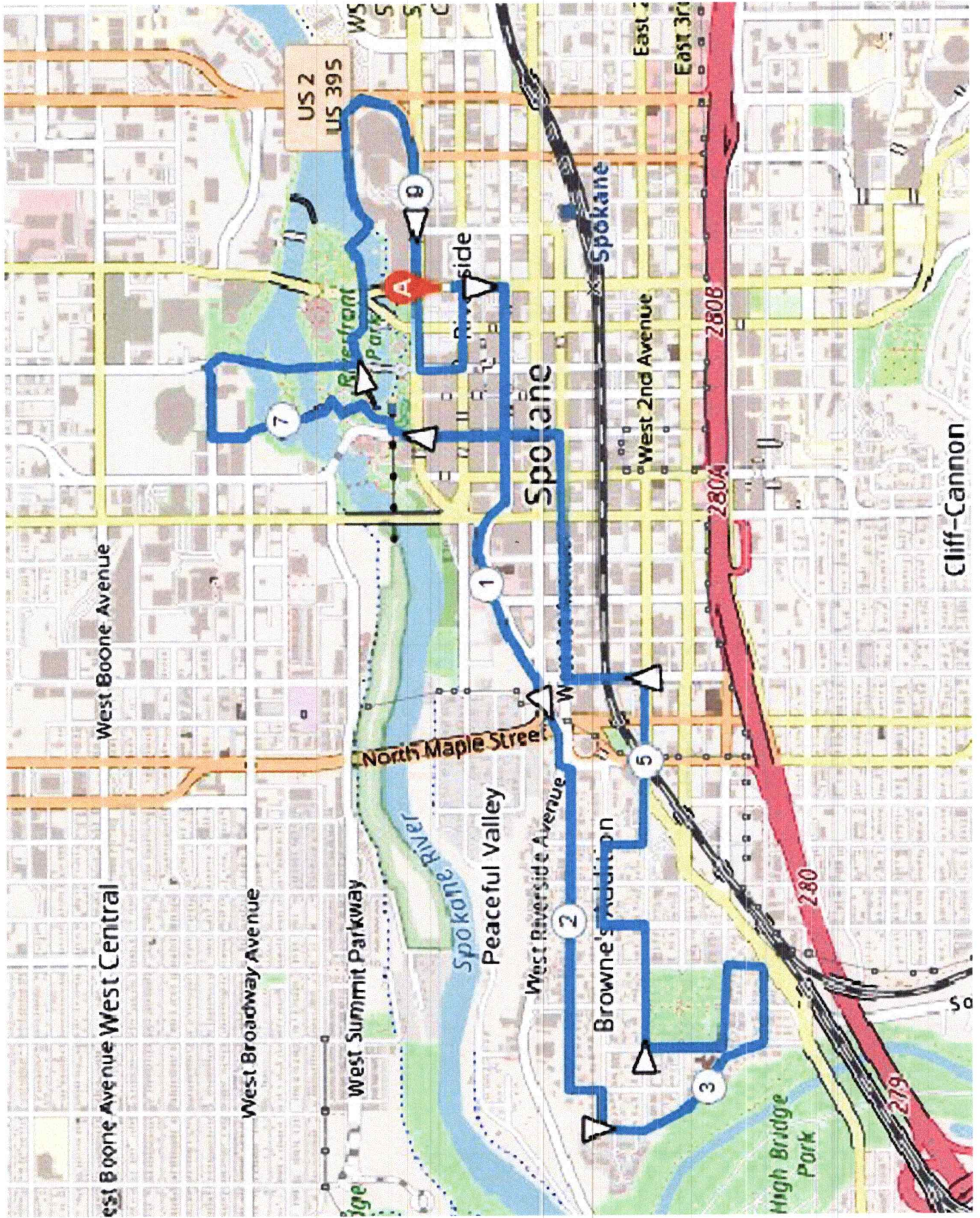

1. **DEPART** Auntie's Bookstore to Washington Street (restrooms available)
2. **RIGHT** on Washington Street to Riverside Avenue
3. **RIGHT** on W. Riverside to Maple (1K Our Lady of Lourdes Cathedral)
4. **LEFT** on Maple to 1<sup>st</sup>
5. **RIGHT** on W. 1<sup>st</sup> passing the Museum of Arts and Culture to its end at S. Poplar (2K at Cannon St)
6. **LEFT** on S. Poplar 1 block to W. Pacific
7. **RIGHT** on W. Pacific to its end at S. Coeur D'Alene St
8. **LEFT** on S. Coeur D'Alene to S. Spruce Street (3K at 3<sup>rd</sup>)
9. **RIGHT** on Spruce to 5th
10. **LEFT** on 5<sup>th</sup> to Chestnut
11. **LEFT** on Chestnut to 4<sup>th</sup> Avenue
12. **LEFT** on 4<sup>th</sup> Ave to Spruce
13. **RIGHT** on Spruce to 2<sup>nd</sup> Street (4K) (Seasonal Restrooms in Coeur d'Alene Park)
14. **RIGHT** on 2<sup>nd</sup> to Cannon St
15. **LEFT** on Cannon to Pacific
16. **RIGHT** on Pacific to Oak Street
17. **RIGHT** on Oak to 2<sup>nd</sup> Ave
18. **LEFT** on 2<sup>nd</sup> Ave to Cedar (5K at Maple)
19. **LEFT** on Cedar to 1<sup>st</sup> Avenue
20. **RIGHT** on 1<sup>st</sup> Ave. to Post (6K at Lincoln)
21. **LEFT** on S. Post through Riverfront Square to Spokane Falls Blvd and cross (restrooms in Riverfront Square)
22. **CROSS** Spokane Falls Blvd staying on Post to path entering the park near the Gondolas
23. **RIGHT** into the park and follow the trail to the footbridge east of the powerhouse and cross to the island and cross the second footbridge (7K)
24. **EXIT** the park to Post Street
25. **RIGHT** on Post St to Mallon
26. **RIGHT** on Mallon to Howard and park entrance
27. **ENTER** the park and cross two bridges staying on paved path around the pavilion and under Washington Street to wooden bridge on the right (8K at Washington St)
28. **RIGHT** crossing the bridge to the Centennial Trail
29. **LEFT** on the Centennial Trail to the path up to Division Street
30. **RIGHT** on Division St around the Convention Center to Spokane Falls Blvd (9K at Spokane Falls Court)
31. **CONTINUE** on Spokane Falls Blvd to Howard Street
32. **LEFT** on Howard to Main
33. **LEFT** on Main Ave to Washington
34. **LEFT** on Washinton to S/F

1. **DEPART** Auntie's Bookstore to Washington Street (restrooms available)
2. **RIGHT** on Washington Street to Riverside Avenue
3. **RIGHT** on Riverside Avenue (1K at Our Lady of Lourdes Cathedral) to Maple
4. **LEFT** on Maple to 1<sup>st</sup>
5. **RIGHT** on W. 1<sup>st</sup> to its end at S. Poplar (2K at Cannon St)
6. **LEFT** on S. Poplar 1 block to Pacific
7. **RIGHT** on Pacific to its end at Coeur d'Alene Street
8. **LEFT** on Coeur d'Alene Street to Spruce Street (3K at 3<sup>rd</sup>)
9. **LEFT** and Cross Spruce and enter Coeur d'Alene Park (seasonal restrooms) to the Gazebo
10. **CIRCLE** the Gazebo until opposite the stairs and take the path to the intersection of 2<sup>nd</sup> and Hemlock
11. **CROSS** 2<sup>nd</sup> and take Hemlock one block to Pacific (Patsy Clark Mansion on left)
12. **RIGHT ON** Pacific to Maple (4K at Oak)
13. **LEFT** on Maple to 1st
14. **RIGHT** on 1<sup>st</sup>, crossing Maple, to Lincoln (5K)
15. **LEFT** on Lincoln to Spokane Falls Blvd
16. **RIGHT** on Spokane Falls Blvd to Washington St
17. **RIGHT** on Washington St to S/F at Auntie's Bookstore
