In case of emergency : Dial 911

Start/Finish point is in front of the Ralls County Courthouse – 311 S Main St, New London MO. Parking is available on the streets around the courthouse. Restrooms available at the courthouse when open or at Casey's or Shell at the corner of US 61 and 1st St.

Directions: From US 36 in Hannibal MO, go south on US 61 (McMaster Ave) about 9 miles. Turn left onto US-61 Bus for 1 mile to the Ralls County Courthouse on the left.

From I – 70 heading east take the Kingdom City (US 54) exit heading north for 18 miles. Turn left on MO-19 N 28 miles crossing US 61 and onto Main St in New London. Courthouse will be on your right.

From I – 70 heading west take the US 61 N exit in Wentzville going about 65 miles. Take MO-19/US61 Bus exit toward New London. Turn right on US 61 Bus to the courthouse on the right.

Special Programs: Walking the USA A-Z – ("N"), Doin' the Louisiana Purchase, Rockin' Around the Clock

1. With back to courthouse turn right on Main St
2. Turn right on 3rd St 5 blocks to Depot St
3. Turn left on Depot St
4. Turn left on 2nd St 5 blocks to Main St
5. Turn right on Main St
6. Turn right on 1st St 4 blocks to Strode St
7. Turn left on Strode St
8. Turn left on Rector a short distance to the cemetery entrance
9. Turn right into Barkley Cemetery and walk counterclockwise on road returning to the entrance
10. Turn right on Rector St
11. Turn left on Ralls St 4 blocks to 4th St (MO V)
12. Turn left on 4th St
13. Turn right on Marshall
14. Turn right on 5th St 5 blocks carefully crossing Main St
15. Turn right on Clay St 3 blocks to 2nd St
16. Turn right on 2nd St
17. Turn right on Church St
18. Turn left on 4th St carefully crossing Main St
19. Turn left on Main back to the finish at the courthouse

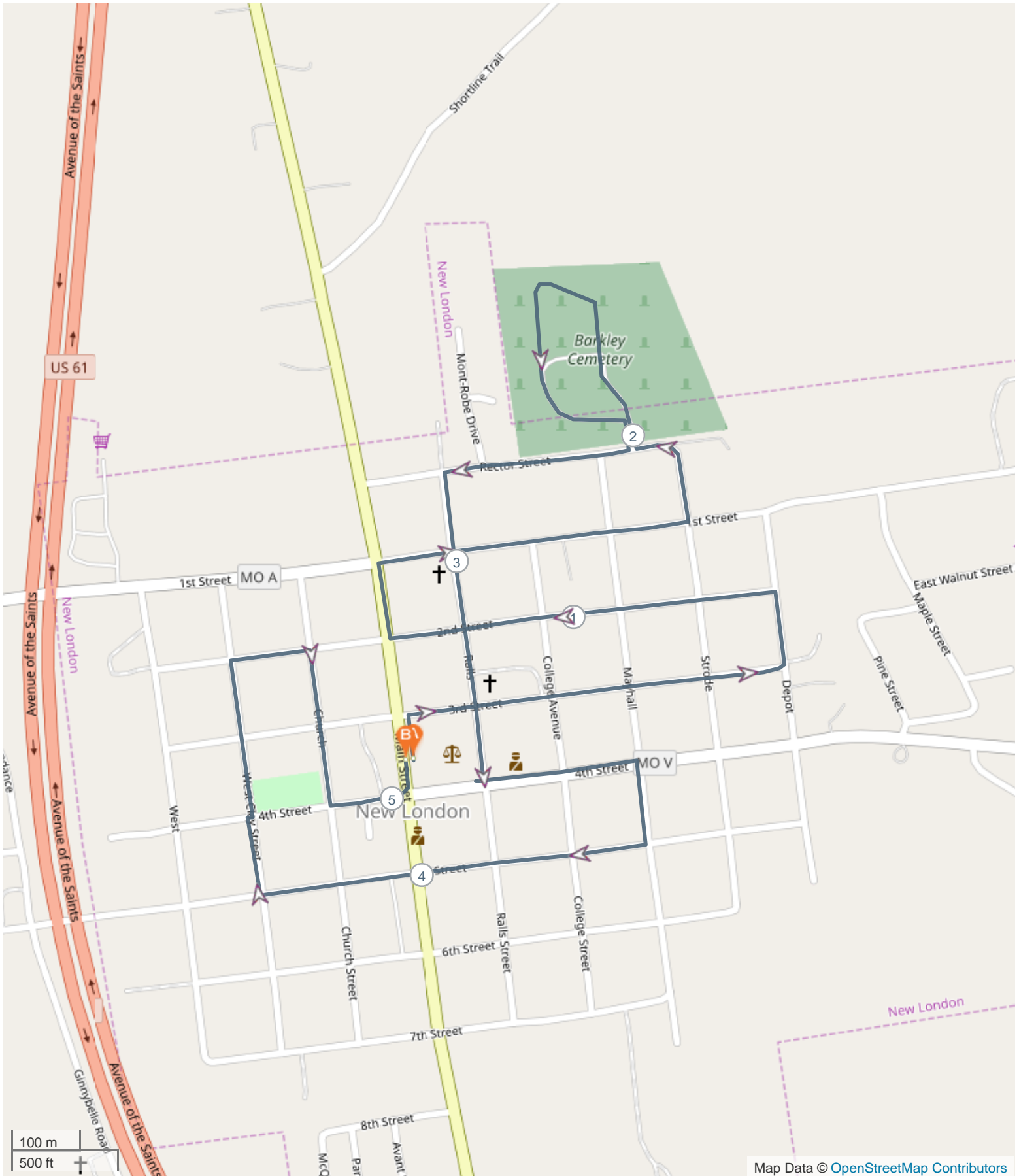

Directions: From US 36 in Hannibal MO, go south on US 61 (McMaster Ave) about 9 miles. Turn left onto US-61 Bus for 1 mile to the Ralls County Courthouse on the left.

From I – 70 heading east take the Kingdom City (US 54) exit heading north for 18 miles. Turn left on MO-19 N 28 miles crossing US 61 and onto Main St in New London. Courthouse will be on your right.

From I – 70 heading west take the US 61 N exit in Wentzville going about 65 miles. Take MO-19/US61 Bus exit toward New London. Turn right on US 61 Bus to the courthouse on the right.

Special Programs: Walking the USA A-Z – ("N"), Doin' the Louisiana Purchase, Rockin' Around the Clock

1. With back to courthouse turn right on Main St
2. Turn right on 3rd St 5 blocks to Depot St
3. Turn left on Depot St
4. Turn left on 2nd St 5 blocks to Main St
5. Turn right on Main St
6. Turn right on 1st St 4 blocks to Strode St
7. Turn left on Strode St
8. Turn left on Rector a short distance to the cemetery entrance
9. Turn right into Barkley Cemetery and walk counterclockwise on road returning to the entrance.
10. Turn right on Rector St
11. Turn left on Ralls St 4 blocks to 4th St (MO V)
12. Turn left on 4th St 4 blocks to Depot St
13. Turn right on Depot
14. Turn right on 5th St 4 blocks to Ralls St
15. Turn left on Ralls
16. Turn left on 6th
17. Turn right on Marshall
18. Turn right on 7th
19. Turn left on Main St
20. Turn left on Parkview Trl just after passing the Old School Market Place
21. Turn left into the New London City Park and walk counterclockwise back to the entrance
22. Turn right on Parkview Trl and carefully cross Main St.
23. Turn right on Main St a short distance to Carstarphen Pl
24. Turn left on Carstarphen Pl
25. Turn right on McQua Estates Loop
26. Turn right at next intersection looping back to McQua Estates Loop
27. Turn left on McQua Estates Loop
28. Turn right on 8th St
29. Turn left on Main St
30. Turn left on 7th St
31. Turn right on West St
32. Turn right on 6th St
33. Turn left on Church St
34. Turn left on 5th St
35. Turn right on West St

36. Turn right on 4th St
37. Turn left on Clay St
38. Turn right on 2nd St
39. Turn right on Church St

40. Turn left on 5th St and carefully cross Main St
41. Turn left on Main St back to the finish
