Start/Finish point is in front of the Monroe County Courthouse – 300 N. Main St. Paris, Mo 65275. Parking is available around the courthouse. Restrooms are available Monday-Friday 8:00am-4:30pm inside the courthouse. There are several gas stations about 1.5 miles south on Main St. with restrooms available 24 hours daily.

**Directions from Highway 36 Eastbound:** Going East on Highway 36 towards Hannibal, MO, take Missouri Highway 15 south at Shelbina, Mo. Continue on MO-15 until you reach Main St. in Paris, Mo.

**Directions from Highway 24 Eastbound:** Going East on Highway 24 towards Monroe, Mo, turn left on Highway 15 into Paris, MO. Highway 15 turns into Main St.

1. Facing the front of the Monroe County Courthouse on N. Main Street, turn **RIGHT** on N. Main Street towards E. Monroe St.
2. **LEFT** on E. Monroe St. to Market St.
3. **LEFT** on Market St. E. Madison St.
4. **LEFT** on E. Madison St to N. Main St.
5. **LEFT** on N. Main St. to E. Marion St.
6. **LEFT** on E. Marion St. to Hill St.
7. **RIGHT** on Hill St. to E. Caldwell St.
8. **LEFT** on E. Caldwell St. until you reach the Monroe County Fairgrounds.
9. **Continue** straight through parking lot. The baseball field will be on your right.
10. **RIGHT** at the next road. Baseball field will be on your right and dirt race track will be on your left.
11. Follow dirt road until you reach the next intersection.
12. **LEFT** on dirt road and continue on this road as it circles around the fairground area.
13. **Continue** on dirt road until you reach the entrance to the fairground area and turn **LEFT** on Locust St to Fairview Ave.
14. **LEFT** on Fairview Ave.
15. **LEFT** on Fairview Ave. to South St.
16. **RIGHT** on South St. to Baskett St.
17. **RIGHT** on Baskett St. to Bodine St.
18. **LEFT** on Bodine St. to S. Main St.
19. **RIGHT** on S. Main St. to Payne St.
20. **RIGHT** on Payne St. to Baskett St.
21. **LEFT** on Baskett St. to Locust St.
22. **LEFT** on Locust St. to Washington St.
23. **RIGHT** on Washington St. to W. Monroe St.
24. **LEFT** on W. Monroe St. to Walnut St.
25. **LEFT** on Walnut St. to W. Locust St.
26. **RIGHT** on W. Locust St. to S. Seminary St.
27. **LEFT** on S. Seminary St. to Cooper Ave.
28. **RIGHT** on Cooper Ave to Fair St.
29. **LEFT** on Fair St. as it curves into Brookview Dr.
30. **Continue** straight on Brookview Drive to Combs St.

31. **RIGHT** on Combs St. to Saint Elmo St.
32. **RIGHT** on Saint Elmo St. to Cleveland St.
33. **LEFT** on Cleveland St. and walk several blocks until you reach the front of the High School.
34. At the front of the high school, **turn around** on Cleveland St the way you came until you get to McMurry St.
35. **RIGHT** on McMurry St. to Combs St.
36. **LEFT** on Combs St. to W. Hickory St.
37. **RIGHT** on W. Hickory St. to S. Washington St.
38. **LEFT** on S. Washington St. to Ruby St.
39. **LEFT** on Ruby St. to Birkett St.
40. **RIGHT** on Birkett St. to McBride St.

41. **RIGHT** on McBride St. to S. Washington St.
42. **LEFT** on S. Washington St. to W. Monroe St.
43. **RIGHT** on W. Monroe St. to N. Main St.
44. **LEFT** on N. Main St. to return back to walk start location in front of the Monroe County Courthouse.

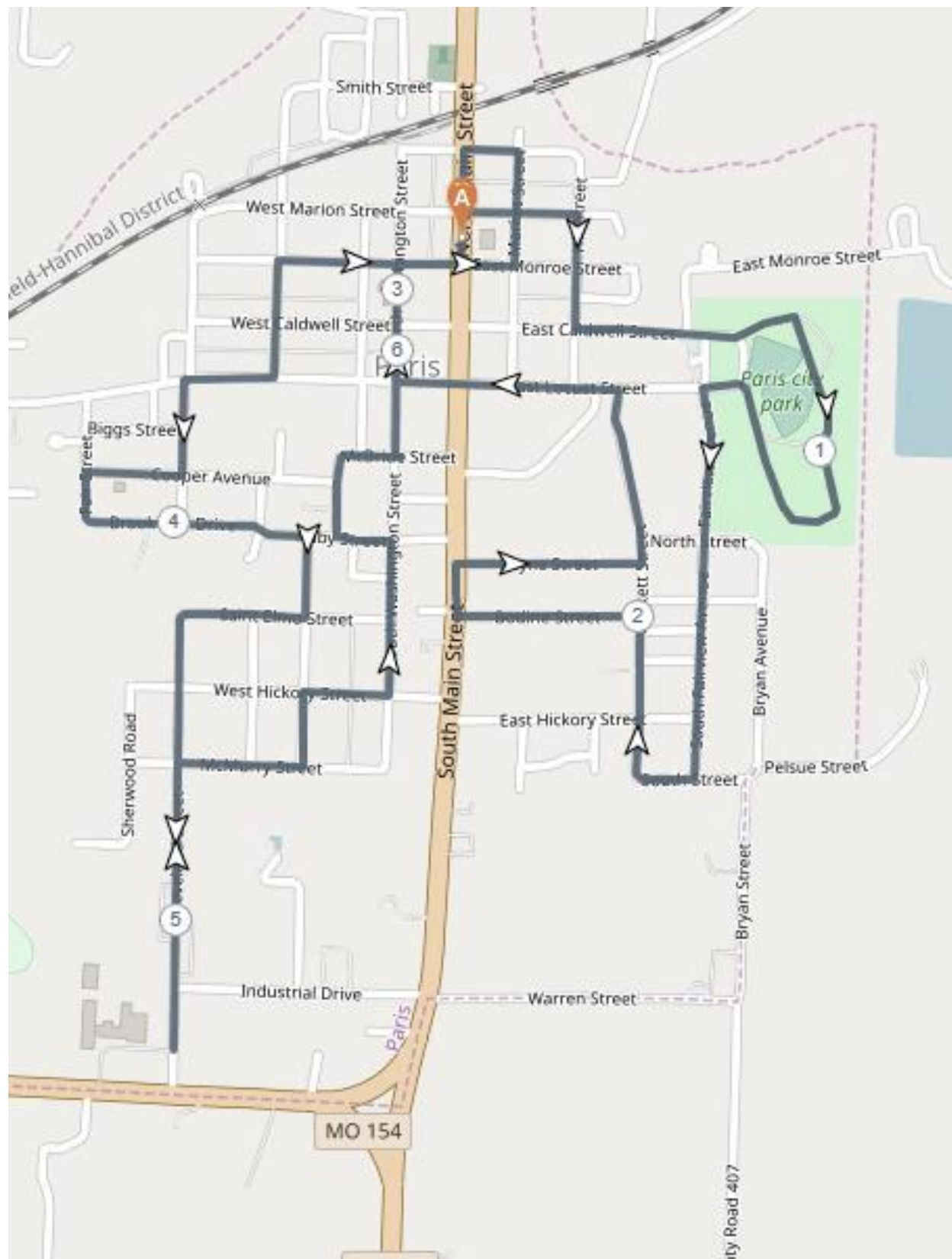
