SPEARMAN, TEXAS**



Spearman came about in anticipation of the arrival of the North Texas and Santa Fe Railroad. It is named for Thomas Spearman, the railroad's vice president. Spearman is about 10 miles from Palo Duro Lake a wintering spot for bald eagles.

Both walks take in neighborhood, churches, the J. B. Buchanan Windmill Park, and the Station Master's House Museum. Both walks are rated 1A.

Walk Completion and Credit:

When you finish your walk(s), be sure to log back in to the OSB System and enter your participation date, distances, and Special Programs (if applicable).

Start Point Address and Driving Directions:

Hansford County Courthouse, 15 NW Court St., TX. 79081. From TX-15/Collard Street in Spearman, turn south on Main Street for 3 blocks to NW Court St.

Restrooms and Parking:

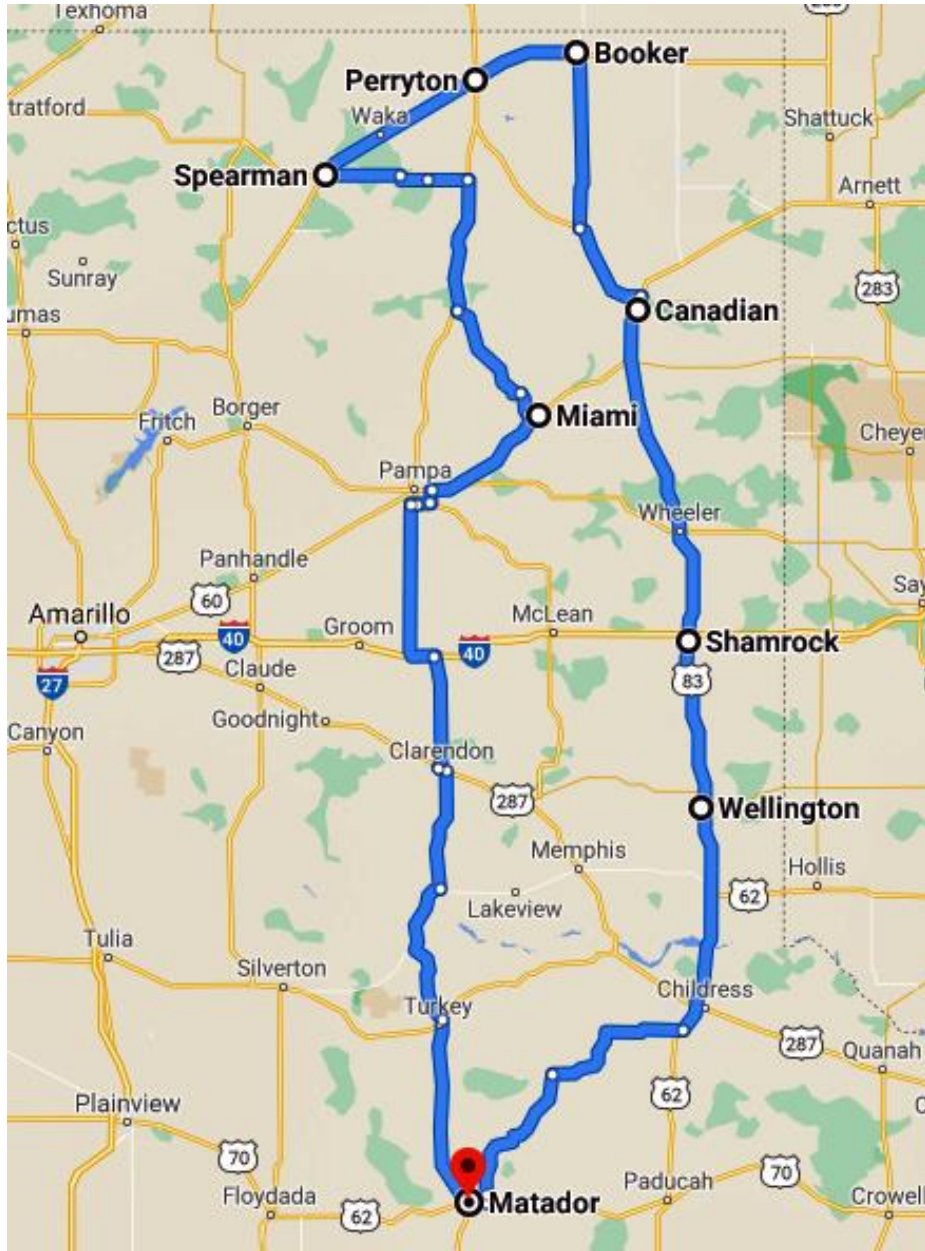

TEXAS COUNTY WALKERS – 2021 HANSFORD COUNTY 10 km WALK in SPEARMAN, TX.

Drive to the Start Point at Hansford County Courthouse, 15 NW Court St. (Main & NW Court St.) in Spearman

10 KM INSTRUCTIONS

1. With your back to clock and Courthouse, walk 2 blocks on right side of Main St. to Hancock St.
2. **RIGHT** on Hancock 2 blocks to Carson St.
3. **RIGHT** on Carson a short block to Bernice St.
4. **RIGHT** Bernice 2 blocks to East A Avenue.
5. **LEFT** on East A Ave. 1 block to N. Endicott St. (no sign)
6. **RIGHT** on Endicott 2 blocks to E. First Ave.
7. **RIGHT** on E. 1st 1 block to S. Bernice St.
8. **LEFT** on Bernice 6 blocks to E. 7th Ave.
9. **LEFT** on E. 7th for 4 blocks to Cotter Dr.
10. **RIGHT** on Cotter to E. 11th Ave.
11. **RIGHT** on 11th to Walter Wilmeth Dr.
12. **RIGHT** on Wilmeth back to E. 7th Ave.
13. **LEFT** on E. 7th 1 block to S. Bernice St.
14. **LEFT** on Bernice 4 blocks to 11th.
15. **RIGHT** on 11th 2 blocks to S Barkley St.
16. **RIGHT** on Barkley 2 blocks to W. 9th Ave.
17. **LEFT** on 9th about 10 blocks to HWY 207.
18. **LEFT** on HWY 207 shoulder to J.B. Buchanan Windmill Park.
19. **ENTER** Park and proceed to the back windmill, #60 20-foot Aeromotor.
20. **LEFT** with windmills on your left and 2 beige buildings on your right.
21. **CONTINUE** to 9th Ave (no sign).
22. **CROSS and RIGHT** on 9th to Maple/Golden Circle Drive.
23. **LEFT** on Golden Circle Dr.
24. Loop back to 9th Ave.
25. **LEFT** on 9th for 1 block to S. Roland St.
26. **LEFT** on Roland 1 block to W. 8th Ave.
27. **RIGHT** on 8th (passing Evans and crossing Archer, Townsend, and Dressen) to Barkley St.
28. **LEFT** on Barkley 5 blocks to W. 2nd Ave.)
29. **LEFT** on 2nd 2 blocks to Townsend St.
30. **RIGHT** on Townsend 2 blocks to W. Kenneth Ave.
31. **RIGHT** on Kenneth 1 block to Dressen St.
32. At Dressen, **CROSS** Kenneth **LEFT** to Andrews.
33. Take Andrews 1 very short block to Hancock St.
34. **RIGHT** on Hancock 2 blocks to Main St.
35. **RIGHT** on Main 2 blocks to **FINISH**.

TEXAS COUNTY WALKERS – 2021 HANSFORD COUNTY 6 km WALK in SPEARMAN, TX

Drive to the Start Point at Hansford County Courthouse, 15 NW Court St. (Main & NW Court St.) in Spearman.

6 KM INSTRUCTIONS

1. Facing the Courthouse, turn **LEFT** on NW Court Street ½ block to corner of NE Court St. and N. Bernice St. (no sign)
2. **CROSS toward the Bank** and turn **LEFT** on Bernice about ¼ block to East A Avenue (keep Bank on your right).
3. **RIGHT** on East A for 1 block to N. Endicott St. (no sign.
4. **RIGHT** on Endicott for 2 blocks to E. First Avenue.
5. **RIGHT** on First Ave. for 1 block to S. Bernice Street.
6. **LEFT** on Bernice for 8 blocks to W. 9th Avenue.
7. **RIGHT** on 9th about 11 blocks to HWY 207.
8. **LEFT** on HWY 207 shoulder to J.B. Buchanan Windmill Park.
9. **ENTER** Park and proceed to the back windmill, #60 20-foot Aeromotor.
10. **LEFT** with windmills on your left and 2 beige buildings on your right.
11. **CONTINUE** to 9th Ave (no sign).
12. **CROSS and RIGHT** on 9th 3 blocks to S. Roland Street
13. **LEFT** on Roland 1 block to W. 8th Ave.
14. **RIGHT** on 8th (passing Evans and crossing Archer, Townsend, and Dressen) to Barkley St.
15. **LEFT** on Barkley 5 blocks to W. 2nd Ave.
16. **LEFT** on 2nd 2 blocks to Townsend St.
17. **RIGHT** on Townsend 2 blocks to W. Kenneth Ave.
18. **RIGHT** on Kenneth 1 block to Dressen St.
19. At Dressen, **CROSS** Kenneth **LEFT** to Andrews.
20. Take Andrews 1 very short block to Hancock St.
21. **RIGHT** on Hancock 2 blocks to Main St.
RIGHT on Main 2 blocks to **FINISH**.
