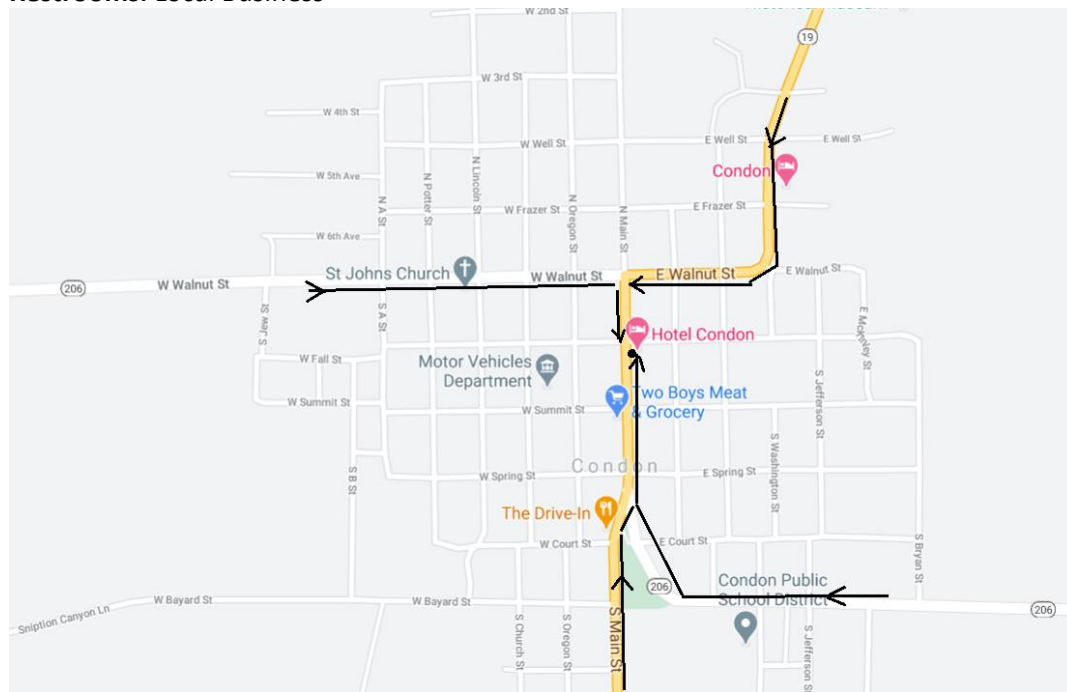
## DESCRIPTION

Arrive from the North or South on Hwy 19 which is Main St.

Arrive from the West or East on Hwy 206 which Walnut or Bayard. Both meet at Main St.

**Park** on street near the Hotel Condon. **Little Shade so prepare accordingly.**

**Walk Completion and Credit:** Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)

These instructions may be used only upon registration at a currently sanctioned IVV/AVA Event

Hotel Condon 202 S Main St, Condon, OR 97823

1. **FROM** the entrance of the Hotel Condon, **STRAIGHT (West)** on W. Gilliam St.
2. **LEFT** on S. Oregon St., passing the Gilliam County Courthouse
3. **LEFT** on W. Summit St.
4. **CROSS and RIGHT** on S. Main St.
5. When the road becomes a “Y”, head toward Heppner and Lone Rock on Hwy 206.
6. **CROSS** E Bayard St. and walk uphill on the sidewalk; the swimming pool will be on your right.
7. **LEFT** on S East St.
8. **RIGHT** on E Court St. for short distance
9. **LEFT** on S East St. again
10. **CROSS** E Walnut St.
11. **IMMEDIATE RIGHT** walking on the left side, facing traffic. This is Hwy 19 as it curves left (2k)
12. At Green Museum sign, **RIGHT to CROSS** Hwy 19 and enter into the museum complex. It is open Wednesday – Sunday 10-5. Walk counter-clockwise around the train depot and exit the museum through the gate you entered.
13. **TURN RIGHT** (or **LEFT** if you couldn't get into the museum grounds), walking on roadway between the pine trees and covered picnic area. Exit back to Hwy 19.
14. **RIGHT** on Hwy 19, walking past the entrance of the Gilliam County Fairgrounds to the next road.
15. **RIGHT** on Cottonwood St./Condon Airport Rd.
16. **RIGHT** at first entrance into St. Joseph Cemetery. Circle to the Left and exit at the far end of the cemetery.
17. **CROSS** the Road and **RIGHT**
18. **CONTINUE** down the road to see the airport.
19. **TURNAROUND** and return to the next cemetery.
20. **RIGHT** entering the next cemetery. Walk back to the restroom. Follow the road to the left to exit this cemetery.
21. **CROSS and RIGHT** on Cottonwood St/Condon Airport Rd.
22. **CONTINUE**, crossing Hwy 19. Note that this is 55 mph zone
23. **LEFT** at next intersection on Brown Lane (Main St.), passing baseball fields on your left.
24. **CONTINUE** on Main St. to FINISH at the Hotel Condon

Hotel Condon 202 S Main St, Condon, OR 97823

1. **FROM** the entrance of the Hotel Condon, **LEFT** on S. Main St.
2. When the road becomes a “Y”, head toward Heppner and Lone Rock on Hwy 206.
3. **CROSS** E Bayard St. and walk uphill on the sidewalk; the swimming pool will be on your right.
4. **LEFT** on S Washington St.
5. **RIGHT** on E Court St.
6. **LEFT** on S Byran St. at the “T” (no sign)
7. **LEFT** on E Spring St. (no sign)
8. **RIGHT** on S East St.
9. **RIGHT** on E Gilliam St.
10. **LEFT** on S Jefferson St. at the end of the school yard
11. **LEFT** on E Walnut St. to East St.
12. **RIGHT** on N East St. and **CROSS** E Walnut St.
13. **IMMEDIATE RIGHT** walking on the left side, facing traffic. This is Hwy 19 as it curves left (2k)
14. At Green Museum sign, **RIGHT to CROSS** Hwy 19 and enter into the museum complex. It is open Wednesday – Sunday 10-5. Walk counter-clockwise around the train depot and exit the museum through the gate you entered.
15. **TURN RIGHT** (or **LEFT** if you couldn’t get into the museum grounds), walking on roadway between the pine trees and covered picnic area. Exit back to Hwy 19.
16. **RIGHT** on Hwy 19, walking past the entrance of the Gilliam County Fairgrounds to the next road.
17. **RIGHT** on Cottonwood St/Condon Airport Rd.
18. **RIGHT** at first entrance into St. Joseph Cemetery. Circle to the Left and exit at the far end of the cemetery.
19. **CROSS** the Road and **RIGHT**
20. **CONTINUE** down the road to see the airport.
21. **TURN AROUND** and return to the next cemetery.
22. **RIGHT** entering the next cemetery. Walk back to the restroom. Follow the road to the left to exit this cemetery.
23. **CROSS and RIGHT** on Cottonwood St/Condon Airport Rd.
24. **CONTINUE**, crossing Hwy 19. Note that this is 55 mph zone
25. **LEFT** at next intersection on Brown Lane (Main St.), passing baseball fields on your left.
26. **RIGHT** on W 2<sup>nd</sup> St.
27. **LEFT** on N Lincoln at “T” section
28. **RIGHT** on W 3<sup>rd</sup> St. which curves to the Left and becomes N A St.
29. **Carefully CROSS** Hwy 206
30. **RIGHT** on W Fall St. to view the Wind Farm.
31. **TURN AROUND** and walk back to S B St.
32. **RIGHT** on S B St.
33. **LEFT** on W Bayard St. at “T” intersection (no sign)
34. **RIGHT** on S Church St.
35. **LEFT** on W Trimble St.
36. **LEFT** on S Main St.
37. **LEFT** on W Court St.
38. **RIGHT** on S Church St.
39. **RIGHT** on W Summit St.
40. **LEFT** on S Oregon St., passing the Gilliam County Courthouse.
41. **LEFT** on W Gilliam St.
42. **RIGHT** on S Church St.
43. **RIGHT** on W 3<sup>rd</sup> St. at “T” intersection (no sign)
44. **RIGHT** on N Main St. to FINISH at the Hotel Condon

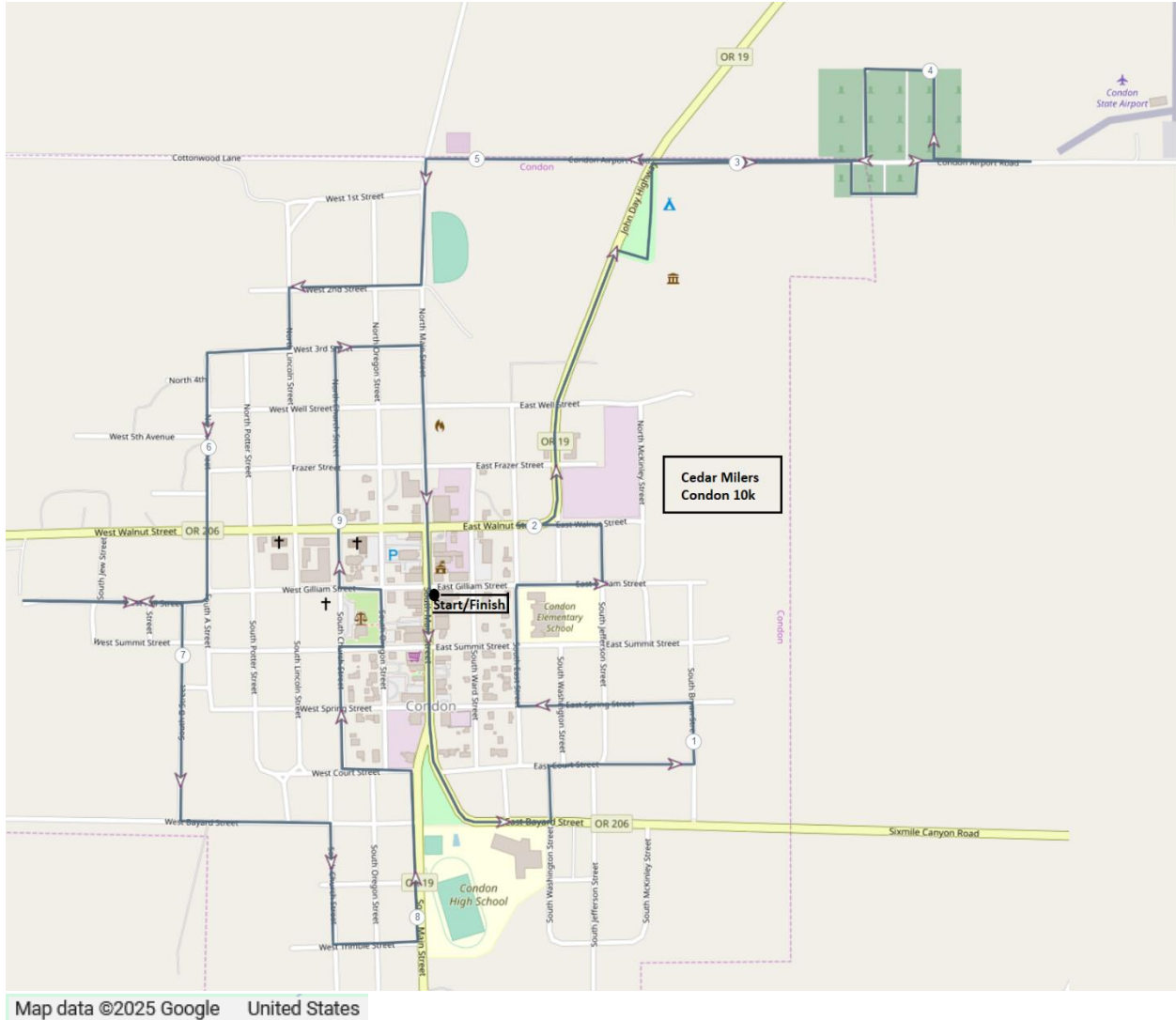
