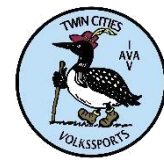

Important Event Information: Street parking, restrooms, and refreshments available at the start point and at the OMNI Brewing Company and taproom. Water and restrooms available at Elm Creek Park Reserve. Food and refreshments available at Omni Brewing Company.

Pets: Yes, Strollers: Easy, Wheelchairs: Easy

Directions: Start at private residence, 11822 99th Place N, Maple Grove MN 55369. From Hwy 169 take 610 west. Exit on to Zachary Lane north. At the roundabout take an immediate right on Zachary Lane northbound and continue approx 3/4 mile to 100th Place N/Maple Valley Drive and take a left on 100th Place just after Fire Station. Go approx 1/2 mile to 2nd stop sign on 100th Place and go left onto 99th Place N. It is the 2nd house on the left. Box will be under the bench on the front step.

Combined OSB/PSB event: Please use either the Online Start Box (OSB) or Physical Start Box (PSB) to register and complete the event. Do NOT mix and match, for example, by registering using the OSB then completing your event using the PSB nor signing the PSB log sheet.

OSB Walk Completion and Credit: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the date the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when they submit the event completion info as a paying for credit participant. Note however that the \$2 coupon for the downloaded PDF expires in 60 days. Also note that an event registration expires after 30 days, but if your registrations lapses, you may re-register without cost.

1. **Exit** at the back side of the parking lot onto the trail that runs behind the chalet
2. **Left** onto the trail (Elm Creek Park Trail)
3. **Left** at the Y toward the Pierre Bottineau House and marker
4. Continue on the trail past the Pierre Bottineau House keeping to the right of the roundabout to reach the stoplights at Elm Creek Blvd/County Rd 81
5. **Left** at stop light using crosswalk
6. **Continue** on paved sidewalk with Elm Creek Blvd/County Rd 81 on your right
7. **Cross** Hemlock Lane N. Sidewalk curves left near stop light at Cty Rd 30/93rd Ave
8. **Left** at Deerwood Lane N. OMNI Brewing is approximately two blocks ahead on the right
9. **Cross** and turn **Left** onto 95th Ave N
10. **Right** onto Hemlock Lane over Hwy 610 and across 97th Ave N. You will pass Forest View Pond Park on the right
11. **Right** to stay on Hemlock Lane
12. **Right** at 99th Place N
13. **Left** at Golden Rod Ln
14. **Left** onto 99th Place N
15. **Right** at second stop sign onto 101st Ave N
16. **Left** crossing James Deane Pkwy
17. Left onto the paved trail into the park crossing James Deane Pkwy
18. **Continue** to the parking lot start point on the **Left** (.6 km)

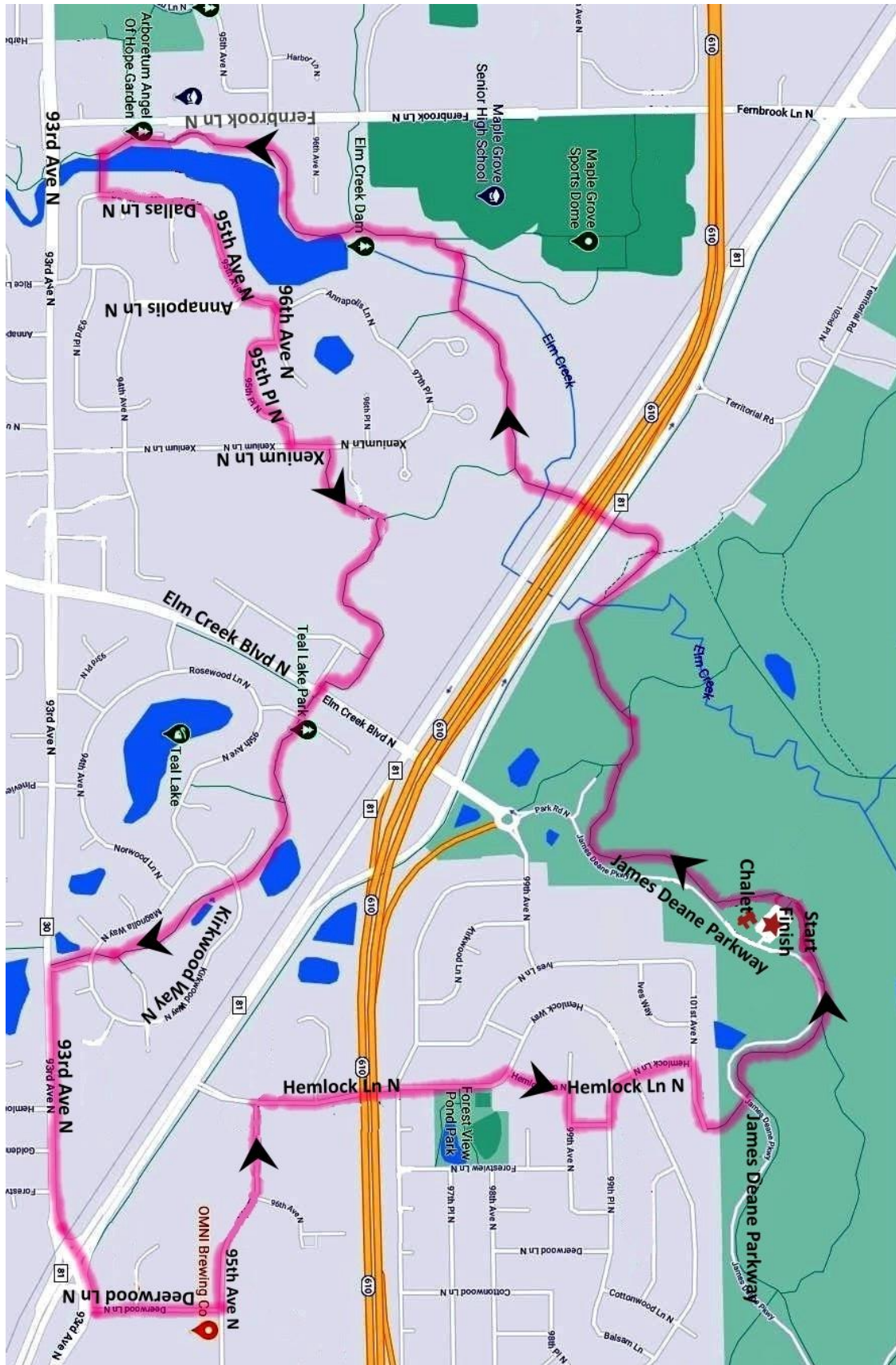
1. **Exit** at the back side of the parking lot onto the trail that runs behind the chalet
2. **Left** onto the trail (Elm Creek Park Trail)
3. **Left** at the double kiosks on the right. (If you come to the bridge over Elm Creek, you missed the turn)
4. **Cross** the Hwy 610 bridge
5. **Right** at the Y on staying on the Medicine Lake Regional Trail with the goldenrod markings down the center
6. **Right** at the Y
7. **Cross** the bridge
8. **Left** at the T to the Arboretum (see sign just after bridge)
9. **Left** at the Y by the Elm Creek dam with the water on your left. The trail now has green center markings
10. **Left** at the Y passing the Angel of Hope statue on the right
11. **Left** at the next Y **crossing** the pedestrian bridge
12. **Left** on Dallas Lane. In three blocks, the road curves right onto 95th Ave
13. **Right** at 96th Ave N
14. **Right** at 95th PLACE N
15. **Left** on Xenium Lane N for a short distance
16. **Right** (before reaching homes/mailboxes) onto paved trail with green center markings
17. **Right** at Y to Elm Creek Blvd N
18. **Cross** Elm Creek Blvd at 96th Ave N
19. **Straight** on trail crossing Kirkwood Way N twice to 93rd Ave N
20. **Left** on 93rd Ave N
21. **Carefully Cross** Hwy 81/Cty Rd 30 at the stop light
22. **Right** onto sidewalk just past 93rd Ave N exit lane. Maple Tavern is on the left
23. **Left** in one block onto Deerwood Ln N. OMNI Brewing is approximately two blocks ahead on the right
24. **Cross** 95th Ave N and turn **Left**
25. **Right** onto Hemlock Lane N crossing over Hwy 610 and 97th Ave N passing Forest View Pond Park on the right
26. **Right** to stay on Hemlock LANE N (straight ahead is Hemlock Way)
27. **Right** at 99th Ave N
28. **Left** at Golden Rod Ln
29. **Left** onto 99th Place N
30. **Right** at second stop sign onto 101st Ave N
31. **Left** onto trail into park
32. **Cross** James Deane Pkwy
33. **Left** onto the paved trail
34. **Continue** to the parking lot start point .6 km on the **Left**
