WALK DETAILS

Snyder began in 1878 as "Hide Town", a trading post for buffalo hunters. Oil was discovered in 1948 and today it is one of the largest oil producing areas in the country. The area is also home to 2 of the largest wind farms in the country. Ranching and cotton round out the economy.

Some well-known actors and actresses from Snyder include Kevin Alejandro (Ugly Betty, Southland); the Emmy Award winner Powers Boothe (Tombstone, Deadwood, 24); Charlene Holt, the love interest of John Wayne and Robert Mitchum in "El Dorado"; Brad Maule, who played 22 years on General Hospital; and Dickie Jones, television actor, B-Western movie star, and voice of Pinocchio in the 1940 Disney movie.

Start Point Address and Driving Directions:

Scurry County Courthouse, 1806 25th St., Snyder, TX. 79549. East or west bound on US-180 / 25th Street, park in front of the Courthouse between College Avenue and Avenue R. Parking is free.

Restrooms:

There are gas stations and fast food restaurants south of the Courthouse on TX-350 / College Ave. Restrooms may be available in the Courthouse during business hours.

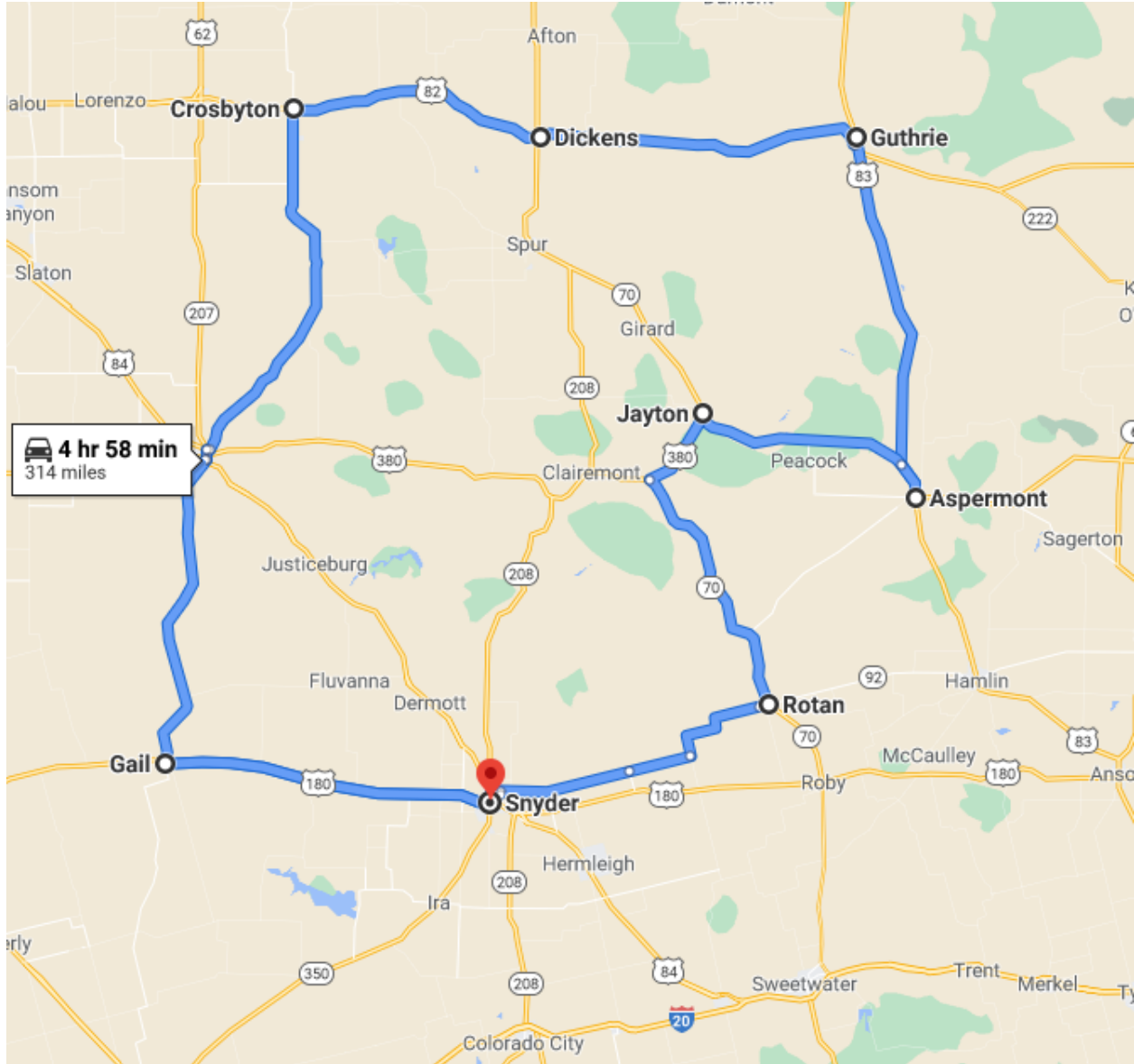

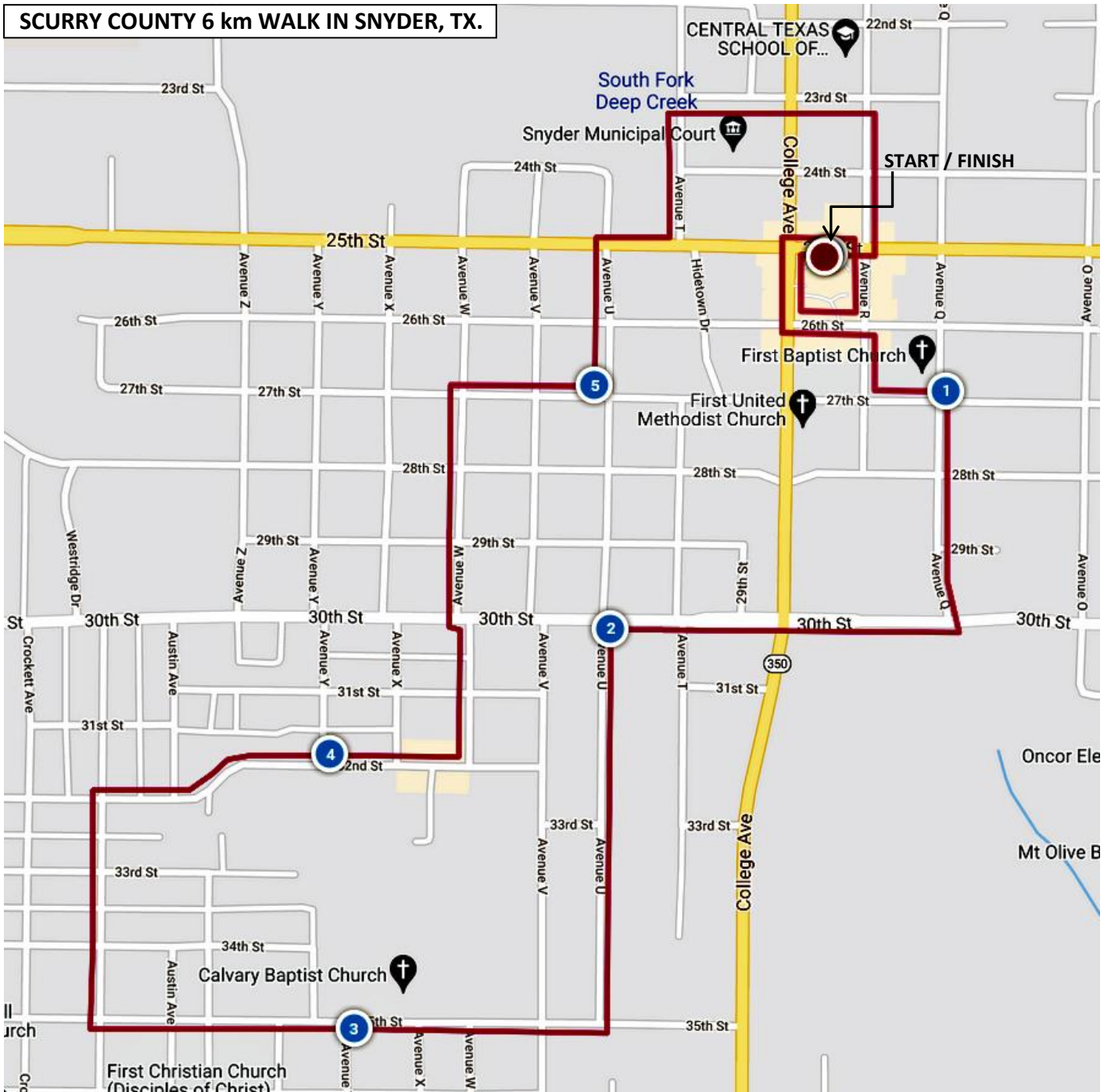
Scurry County Courthouse, 1806 25th St., Snyder, TX. 79549. East or west bound on US-180 / 25th Street, park in front of the Courthouse between College Avenue and Avenue R.

6 km

1. Facing the Courthouse, turn **RIGHT** ½ block to College Ave.; visit historical markers and Veterans Memorial.
2. **LEFT** on College Ave. (staying on courthouse side of street) for 1 block to historical markers at 26th St.
3. **LEFT** on 26th St. (staying on the courthouse side of the street) for 1 block to historical marker at Avenue R.
4. **LEFT** on Ave. R for 1 block to 25th Street.
5. **CROSS and LEFT** on 25th St. for 1 block to College Ave.
6. **CROSS and LEFT** on College Ave. for 1 block to 26th Street.
7. **CROSS and LEFT** on 26th St. for 1 block to Avenue R.
8. **CROSS and RIGHT** on Ave. R for 1 block to 27th St.
9. **LEFT** on 27th St. for 1 block to Avenue Q.
10. **RIGHT** on Avenue Q for 3 blocks to 30th Street.
11. **RIGHT** on 30th St. for 1 block to College Avenue.
12. **CAREFULLY CROSS** College and **continue** straight on 30th St. for 2 more blocks to Avenue U.
13. **LEFT** on Ave. U for 2 long blocks to 35th Street.
14. **RIGHT** on 35th St. for 9 blocks to Beaumont Ave.
15. **RIGHT** on Beaumont for 3 blocks to 32nd Street.
16. **RIGHT** on 32nd St. for 4 blocks to Avenue W.
17. **LEFT** on Ave. W for 5 blocks to 27th Street.
18. **RIGHT** on 27th St. for 2 blocks to Avenue U.
19. **LEFT** on Ave. U for 2 blocks to 25th Street.
20. **RIGHT** on 25th for 1 block to Avenue T.
21. **LEFT** on Ave. T for 2 blocks to 23rd Street.
22. **RIGHT** on 23rd St. for 3 blocks to Avenue R.
23. **RIGHT** on Ave. R for 2 blocks to 25th Street.
24. **CROSS and RIGHT** on 25th St. to **FINISH** at Courthouse.

Scurry County Courthouse, 1806 25th St., Snyder, TX. 79549. East or west bound on US-180 / 25th Street, park in front of the Courthouse between College Avenue and Avenue R.

10 km

1. Facing the Courthouse, turn **RIGHT** ½ block to College Ave; visit historical marker(s) and Veterans Memorial.
2. **LEFT** on College Ave. (staying on courthouse side of street) for 1 block to historical markers at 26th St.
3. **LEFT** on 26th St. (staying on the courthouse side of the street) for 1 block to historical marker at Avenue R.
4. **LEFT** on Ave. R for 1 block to 25th Street.
5. **CROSS and LEFT** on 25th St. for 1 block to College Ave.
6. **CROSS and LEFT** on College Ave. for 1 block to 26th Street.
7. **CROSS and LEFT** on 26th St. for 1 block to Avenue R.
8. **CROSS and RIGHT** on Ave. R for 1 block to 27th St.
9. **LEFT** on 27th St. for 1 block to Avenue Q.
10. **RIGHT** on Ave. Q for 3 blocks to 30th Street.
11. **RIGHT** on 30th for 1 block to College Ave.
12. **CAREFULLY CROSS** College Ave. and **continue** straight on 30th St. for 2 more blocks to Avenue U.
13. **LEFT** on Ave. U for 2 long blocks to 35th Street.
14. **RIGHT** on 35th St. for 4 blocks to Avenue Y.
15. **LEFT** on Ave. Y for 2 blocks to 37th Street.
16. **RIGHT** on 37th St. for 3 blocks to Austin Ave.
17. **LEFT** on Austin Ave. to end at the lake.
18. **LEFT** on Towle Park Rd. (no street sign), passing the pool and the lake.
19. **CONTINUE** to the parking lot.
20. A short distance after the parking lot, turn **RIGHT** on the sidewalk.
21. **Follow sidewalk** about 1 km back to and past the lake, volley ball courts, and parking lot.
22. **At the first street after the parking lot** (skateboard park to the right), turn **RIGHT** for 6 blocks to 38th St.
23. **RIGHT** on 38th for 1 block to Beaumont Ave. (no sign).
24. **LEFT** on Beaumont for 1 block to 37th St. (no sign).
25. **LEFT** on 37th for ½ block to Crockett Ave.
26. **RIGHT** on Crockett for 3 blocks to 34th Street.
27. **RIGHT** on 34th for 1 block to Beaumont Ave.
28. **LEFT** on Beaumont Ave. for 2 blocks to 32nd St.
29. **RIGHT** on 32nd St. for 4 blocks to Avenue W.
30. **LEFT** on Avenue W. for 5 blocks to 27th Street.
31. **RIGHT** on 27th St. for 2 blocks to Avenue U.
32. **LEFT** on Ave. U for 2 blocks to 25th Street.
33. **RIGHT** on 25th for 1 block to Avenue T.
34. **LEFT** on Ave. T for 2 blocks to 23rd Street.
35. **RIGHT** on 23rd St. for 4 blocks to Avenue Q.
36. **RIGHT** on Ave. Q for 2 blocks to 25th Street.
37. **CROSS and RIGHT** on 25th for 1 ½ blocks to **FINISH** at Courthouse.
