



Greensburg Walk - St Helena Parish

This walk is in Greensburg, the parish seat of St Helena Parish and is along local streets and highways. The town's population is 718 and is a very small town. Walkers are advised to walk facing traffic and to be very careful when crossing the roads.

Walk Registration:

Please use the Online Start Box (OSB) or contact the POC for remote registration to register for the walk. If using the OSB, then complete the walk online as indicated below. If registering remotely, insert cards will be mailed to you. Directions and stamps will be available during the MLK weekend, Jan 13-17, 2022 at the events. Restrooms available in the courthouse during the work week and at some business along the route.

Walk Completion and Walk Credit:

Once you have physically completed the walk, please login to your Online Start Box account click on the "My Start Box" tab, then the "Finish Table" tab, then click on "Go to Finish Table" button for the event you have completed. Use the displayed entry form to submit the date and distance of your walk as well as select applicable AVA Special Programs to generate stamped "virtual" insert cards that you may choose to print out.

Driving Directions to Start Point:

Drive to the start point in Greensburg at the St Helena Parish Courthouse at 369 Sitman (LA-43). The courthouse is at the intersection of LA-10 and LA-43. Park on the back side of the courthouse on Hamberlin St which is 1 block west of LA-43.

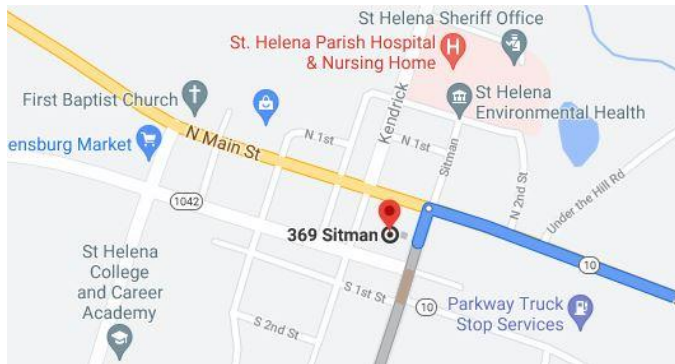

Greensburg – St Helena Parish – 5K

Drive to the start point at the St Helena Parish Courthouse at 369 Sitman St in Greensburg. From I-55, take LA-10 west toward Greensburg to the intersection with LA-43 (Sitman St). LEFT on Sitman to the courthouse. Continue around the courthouse to the back on Hamberlin St.



1. **From Hamberlin St and facing the courthouse, LEFT** on Hamberlin 1 block to Main St, then **RIGHT** on Main 1 block to Sitman.
2. **LEFT** on Sitman 2 blocks to N 2nd St, then **LEFT** on N 2nd 1 block to Sitman.
3. **RIGHT** on Sitman to Dollar General on the right, then **U-TURN** on Sitman back to N 2nd St.
4. **RIGHT** on N 2nd 1 block to Lafayette, then **LEFT** on Lafayette 1 block to N 1st St.
5. **RIGHT** on N 1st and follow it as it curves left to N Main St. (Note: N Main is LA-10 and S Main is a different street that runs parallel to N Main.)
6. **RIGHT** on N Main 2 blocks to LA-37.
7. **LEFT** on LA-37 1 block to S Main (LA-1042), then **RIGHT** on S Main to the second entrance to the cemetery on the left.

8. **LEFT** into the cemetery. **Follow** the road thru the cemetery as it circles back to S Main, then exit the cemetery.
9. **RIGHT** on S Main to LA-37.
10. **RIGHT** on LA-37 to S 3rd St passing the St Helena College and Career Academy.
11. **LEFT** on S 3rd to the entrance to the city park.
12. **RIGHT** into the park, then veer left on the dirt path to the walking track around the park.
13. **Follow** the walking path around the park and return to S 3rd St.
14. **RIGHT** on S 3rd to LA-43 (Sitman).
15. **LEFT** on LA-43 to S Main, then **LEFT** on S Main 1 block to Hamberlin.
16. **LEFT** on Hamberlin 1 block to S 2nd St, then **RIGHT** on S 2nd 1 block to College.
17. **RIGHT** on College 2 blocks to S Main, then **RIGHT** on S Main 2 blocks to Hamberlin.
18. **LEFT** on Hamberlin 1 block back to your car at the courthouse.
