10 km and 5 km Walks
GUTHRIE, TEXAS**



Guthrie is home to the headquarters of the famous Four Sixes Ranch (6666). Original started by Samuel Burk Burnett in the early 1900's, the ranch was up for sale in 2021 at a price of nearly \$350 million.

Our walks include school, the Four Sixes Ranch Supply House, and the Jaguars Track and Field. The 10 km route reverses the 5 km to get the distance.

When you finish your walk(s), be sure to log back in to the OSB System and enter your participation date, distances, and Special Programs (if applicable).

Start Point Address and Driving Directions:

King County Courthouse, 1667 US-83, Guthrie, TX. 79236. North or southbound on US-83, turn into the Courthouse parking lot between 8th and Main Streets. Parking is free.

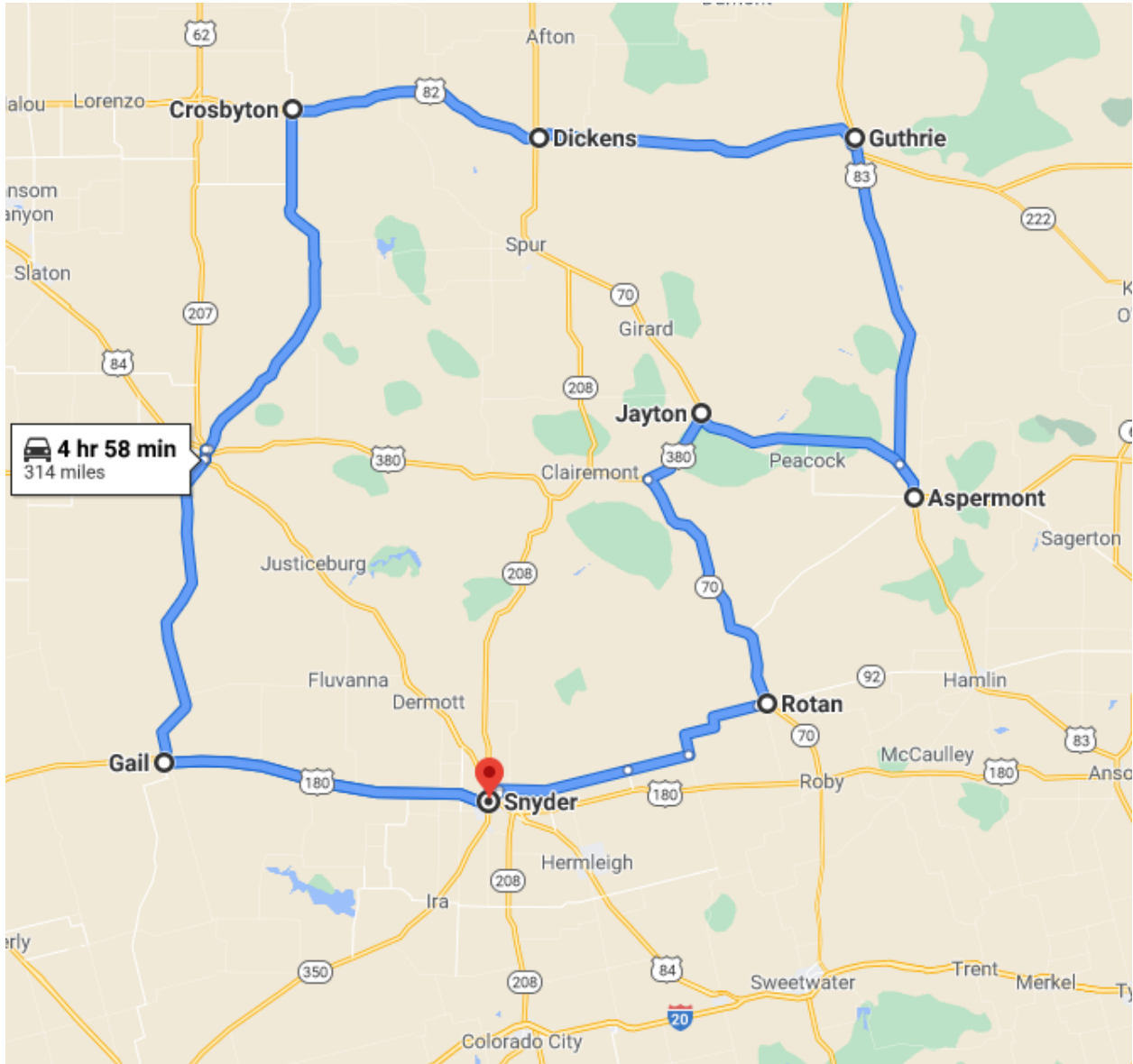
Restrooms:

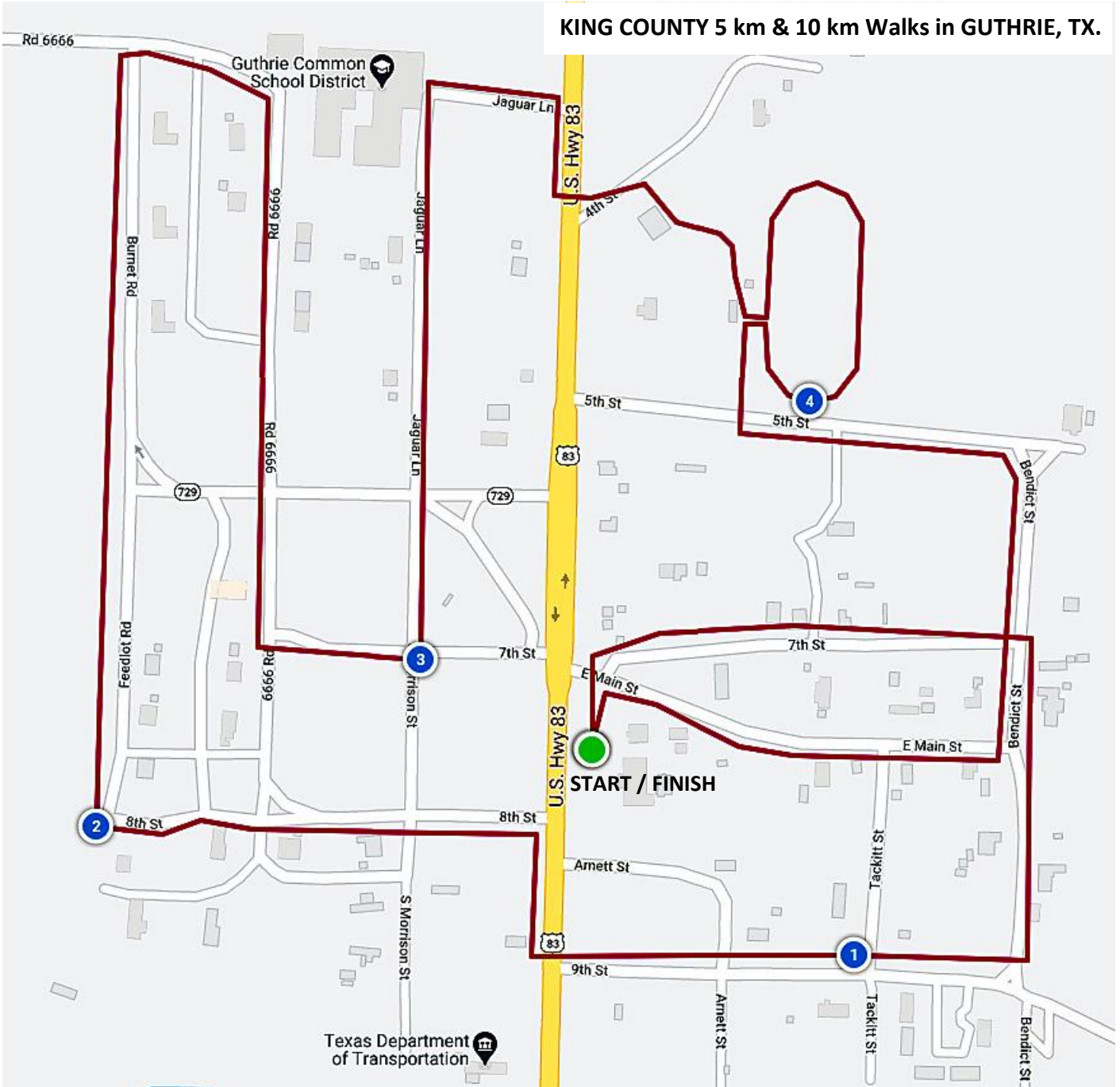
TEXAS COUNTY WALKERS – 2022 KING COUNTY WALKS IN GUTHRIE, TX.

King County Courthouse, 1667 US-83, Guthrie, TX. 79236. North or southbound on US-83, turn into the Courthouse parking lot between 8th and Main Streets.

5 km and 10 km (for 10 km: reverse route when you finish 5 km, instructions included)

1. Facing the Courthouse, turn **LEFT**.
 2. **CROSS** Main to 7th Street (other side of the guardrail).
 3. **RIGHT** on 7th to the end at Benedict St.
 4. **RIGHT** on Benedict for 2 blocks to 9th Street.
 5. **RIGHT** on 9th for 3 blocks to U.S. Hwy 83.
 6. **CROSS** Hwy 83 and turn **RIGHT** for 1 block to 8th Street.
 7. **LEFT** on 8th for 3 blocks to end at Feedlot Road (no sign).
 8. **RIGHT** on Feedlot Rd. for about 3/4 km to **end** at Road 6666.
 9. **RIGHT** on 6666 for 2 blocks to **end** at Guthrie School.
 10. **RIGHT** at the School (still on Road 6666) to the 6666 Supply House.
 11. **JUST AFTER** the Supply House, **LEFT** on 7th Street (no sign) for 1 block to Morrison Street.
 12. **LEFT** on Morrison to **end** in front of the school (Jaguar Lane).
 13. **RIGHT** on Jaguar Lane (yellow paw prints on road) to the highway.
 14. **RIGHT** on the Highway to the **CROSSWALK**.
 15. Use the **CROSSWALK** to cross the highway and turn **RIGHT** to 4th Street.
 16. **LEFT** on 4th St. toward the propane tank and continue around behind the Building.
 17. **CONTINUE** to the smaller set of bleachers by the Track Field on your left.
 18. Look for the gate, enter and circle the track.
 19. **RETURN** to the bleachers, exit the track, and turn **LEFT** to end at 5th Street (no sign).
 20. **LEFT** on 5th to end at Benedict Street.
 21. **RIGHT** on Benedict for 2 blocks to Main Street.
 22. **RIGHT** on Main to **FINISH 5 km at the Courthouse**.
- 10 km REVERSE ROUTE.**
23. Facing the Courthouse, turn **LEFT** to Main Street (before the guardrail).
 24. **RIGHT** on Main to end at Benedict St.
 25. **LEFT** on Benedict to end at 5th Street.
 26. **LEFT** on 5th to the first street on your right.
 27. **RIGHT** to the bleachers in front of the Track Field.
 28. Enter through the gate and circle the track.
 29. When you return, exit to the **RIGHT** toward the propane tank behind the building.
 30. **LEFT** on 4th Street to the Highway.
 31. **Use the Crosswalk** on your right to cross the Highway and turn **RIGHT** to Jaguar Lane.
 32. **LEFT** on Jaguar Lane to front of school.
 33. **LEFT** for 2 blocks to 7th Street (no sign).
 34. **RIGHT** on 7th to end (look for the 6666 Supply House).
 35. **RIGHT** to end behind the School.
 36. **LEFT** for 2 blocks to Burnet Road (no sign, metal rail fence).
 37. **LEFT** about 3/4 km to 8th Street.
 38. **LEFT** on 8th to U.S. Hwy 83.
 39. **CAREFULLY CROSS** and **RIGHT** on Hwy 83 to 9th Street / Cemetery Road.
 40. **LEFT** on 9th St. for 3 blocks to Benedict St.
 41. **LEFT** on Benedict for 2 blocks to 7th Street (no sign).
 42. **LEFT** on 7th to **FINISH 10 km at the Courthouse**.
