

SULPHUR SPRINGS INSTRUCTIONS AND DRIVING DIRECTIONS

The start point for the Sulphur Springs event is The Hopkins County Court House, 118 Church Street, Sulphur Springs, TX 74482.

From IH-30 East Bound or West Bound, exit at exit 124 and turn north on TX 11/154, Gilmer St. Drive approximately 1 ½ miles to Jefferson St., U. S. 67 Bus. Turn right on Jefferson St. to the Hopkins County court house. Turn right after one block onto Oak St. and park on the east side of the court house.

There are restrooms available in the Hopkins County Court House during business hours.

Points of interest along the trail include the historic Hopkins County Courthouse, the town square, the first glass public restrooms in the United States, Buford Park and Coleman Park. The Sulphur Springs Public Library also contains a music box collection and the Sinclair WW II collection of World War II artifacts.

WALK COMPLETION AND CREDIT – Be sure to log back into the OSB system to finish and complete your online registration after doing the event. The OSB system does not deduct any event fee from a participants Event Bank until they have submitted event completion information indicating the date of the event, the distance and the selection of applicable special programs that the person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the users Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion information as a paying "for credit" participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)

SULPHUR SPRINGS 10 KM

1. Cross Oak St. to the court house.
2. Turn LEFT on the walkway that runs through the court house square.
3. Turn LEFT on College St. for four and a half blocks.
4. Turn LEFT on Carter St. for one block.
5. Turn LEFT on Jefferson St. East for four blocks.
6. Turn RIGHT on Jackson St. North for two blocks.
7. Turn LEFT on East Houston St. for two blocks.
8. Turn RIGHT on Church St. for one block.
9. Turn Left on Bonner St. for two blocks.
10. Turn LEFT on Davis St. North (no sign – Janeen’s Country Cottage) for seven blocks.
11. Turn RIGHT on Connally St. for eleven blocks.
12. Turn RIGHT on League St. North for two blocks.
13. Turn LEFT on Buford Circle (no sign – large stew pot and sign for Hopkins County Stew Contest) for one block.
14. Cross Connally St. and bear right to continue on the boardwalk with the water on your right.
15. Continue on the walkway as it becomes a paved trail.
16. Bear RIGHT at the big rock and bear LEFT at the Y intersection.
17. Cross Main St. and continue on the paved trail toward the reservoir.
18. Bear LEFT and then LEFT again onto the walkway that circles the reservoir with the water on your right.
19. Turn LEFT at the first intersection by the park bench and wooden building and then LEFT again through the tunnel through Imagination Mountain to the parking lot.
20. Cross the parking lot to Reservoir St.
21. Turn RIGHT on Reservoir St. for one block.
22. Turn LEFT on Booker St. for one block
23. Turn RIGHT on Craig St. for one block.
24. Turn LEFT on Tate St. for six blocks.
25. Turn LEFT on Texas St. for one block.
26. Turn RIGHT on Bellview St. for five blocks.
27. Carefully cross Gillmer St. and turn LEFT for one block.
28. Bear RIGHT on Oak Ave. for six blocks.
29. Turn LEFT on College St. which turns into Main St. for two blocks.
30. Turn RIGHT on South Davis St. for one block.
31. Turn Right on Connally St. to return to the courthouse.

SULPHUR SPRINGS 5 KM

1. Cross Oak St. to the court house.
2. Turn LEFT on the walkway that runs through the court house square.
3. Turn LEFT on College St. for four and a half blocks.
4. Turn LEFT on Carter St. for one block.
5. Turn LEFT on Jefferson St. East for four blocks.
6. Turn RIGHT on Jackson St. North for two blocks.
7. Turn LEFT on East Houston St. for two blocks.
8. Turn RIGHT on Church St. for one block.
9. Turn Left on Bonner St. for two blocks.
10. Turn LEFT on Davis St. (no sign - Janeen's Country Cottage) for seven blocks.
11. Turn RIGHT on Connally St. for six blocks.
12. Turn LEFT on Garrison St. for four blocks.
13. Turn LEFT on Main St for eight blocks.
14. Cross Davis St. North and continue straight on College St. for one block.
15. Turn LEFT on Gilmer St. for two blocks.
16. Turn RIGHT on Connally St. to return to the court house.
