DESCRIPTION

From East or West on I-84 at Biggs Junction, head South on Hwy 97 to Moro. From the South, Follow Hwy-97 North to Moro. Turn LEFT on 2nd Street down the slight hill and park. Restrooms are available in the park.

DESCRIPTION

From East or West on I-84 at Biggs Junction, head South on Hwy 97 to the Junction with OR-206. Left on OR-206 to Clark St. Right on Clark St. and Right on Fulton St. and park by the City Park. From the South, Follow Hwy-97 North to the Junction with OR-206. Right on OR-206, Right on Clark St., Right on Fulton St.



Walk Completion and Credit: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)

These instructions may be used only upon registration at a currently sanctioned IVV/AVA Event

1. FACING the Park, **RIGHT** up 2nd
2. **RIGHT** on Main St.
3. **RIGHT** on 1st
4. **RIGHT** on Dewey St.
5. **RIGHT** on Moore St.
6. **LEFT** on Main St. to crosswalk at Bidwell St.
7. **RIGHT**, crossing Main St.
8. **CONTINUE** on Bidwell St. until it Curves Right as Hood St.
9. **CONTINUE** Hood St. to 4th St.
10. **LEFT** on 4th St, walking on Left-hand side, facing traffic
11. Road Curves **LEFT** becoming Van Gilder Rd.
12. **CONTINUE** to first angled street **LEFT** up incline to the American Legion Cemetery.
13. **Enter** Cemetery and walk to end of road and return to entrance (or circle counter-clockwise back to entrance)
14. **Return to town, walking on Left-hand side,** facing traffic
15. **LEFT** on Hood St., behind County Courthouse
16. **RIGHT** on 5th St.
17. **RIGHT** on Court St., in front of County Courthouse
18. **LEFT** on 2nd St.
19. **LEFT** on McCoy St.
20. **RIGHT** on 5th St.
21. **RIGHT** on Scott St.
22. **LEFT** on 3rd St.
23. **LEFT** on Alley before Main St.
24. **RIGHT** on 5th St.
25. **RIGHT** on Main St.
26. **LEFT** on 2nd and FINISH.

These instructions may be used only upon registration at a currently sanctioned IVV/AVA Event

Park on Fulton St. at the Train Depot Park with the yellow Railroad Car. Restrooms in the Park. Use Caution when crossing the main highways. The traffic volume is low but the speed is fast.

1. **FACING** the park on Fulton St, **LEFT** (East) to Cross Hwy 206 and up to the end
2. **LEFT** on Scott St. and observe the Airport/Runway to your Right.
3. **LEFT** on Armsworthy St. (the major Old Wasco-Heppner Hwy) walking on LEFT, facing traffic to next intersection (unmarked)
4. **RIGHT** to CROSS on McPherson St. up toward the school
5. **CROSS** Barnett St, and, passing Elementary School on your right, **CONTINUE** with white posts/cable on your right and parking lot on your left.
6. **LEFT** as the McPherson St. curves left and becomes Columbia St.
7. **RIGHT** on Clark St. until past the old Hwy 97 intersection where the street becomes Scott Canyon Rd.
8. **LEFT** to cross Scott Canyon Rd then **RIGHT** to walk facing traffic to next intersection
9. **LEFT** on John Day St. (5th on map)
10. **RIGHT** on Biggs St. to the unmarked “T” intersection at the wheat field (Yates St.)
11. **LEFT** at “T” on Yates St. (6th on map) to Church St. Note the North Sherman Co. RFPD off to your right.
12. **LEFT** on Church St. to Junction with John Day St. and Old Hwy 97.
13. **STAY** Left to the far side of John Day St.
14. **CAREFULLY CROSS** Old Hwy 97
15. **CONTINUE** on Church St. to Barnett St.
16. **LEFT** on Barnett St. which curves **Right** to become Wilson St.
17. **CAREFULLY CROSS** Hwy 206
18. **LEFT** on Fulton St.
19. **RIGHT** on Biggs St.
20. **LEFT** on Davis St. Look to your right to see the Victorian “House on the Hill”.
21. **RIGHT** on Clark St.
22. **RIGHT** on Ellis St.
23. **LEFT** on Biggs St.
24. **LEFT** on Dunlap St.
25. **LEFT** on Clark St.
26. **RIGHT** on Harrison St.
27. **LEFT** on McPherson St.
28. **CONTINUE** straight to Hwy 206
29. **LEFT** on Hwy 206, Facing Traffic
30. **RIGHT** on Clark St
31. **LEFT** on Fulton St.
32. **RIGHT** on Biggs St.
33. **LEFT** Columbia St.
34. **CURVE RIGHT** on Wilson St.
35. **RIGHT** on Deschutes St (Old Hwy 97)
36. **RIGHT** on Biggs St.
37. **LEFT** on Columbia St.
38. **RIGHT** on Clark St.
39. **RETURN** to the Park and FINISH

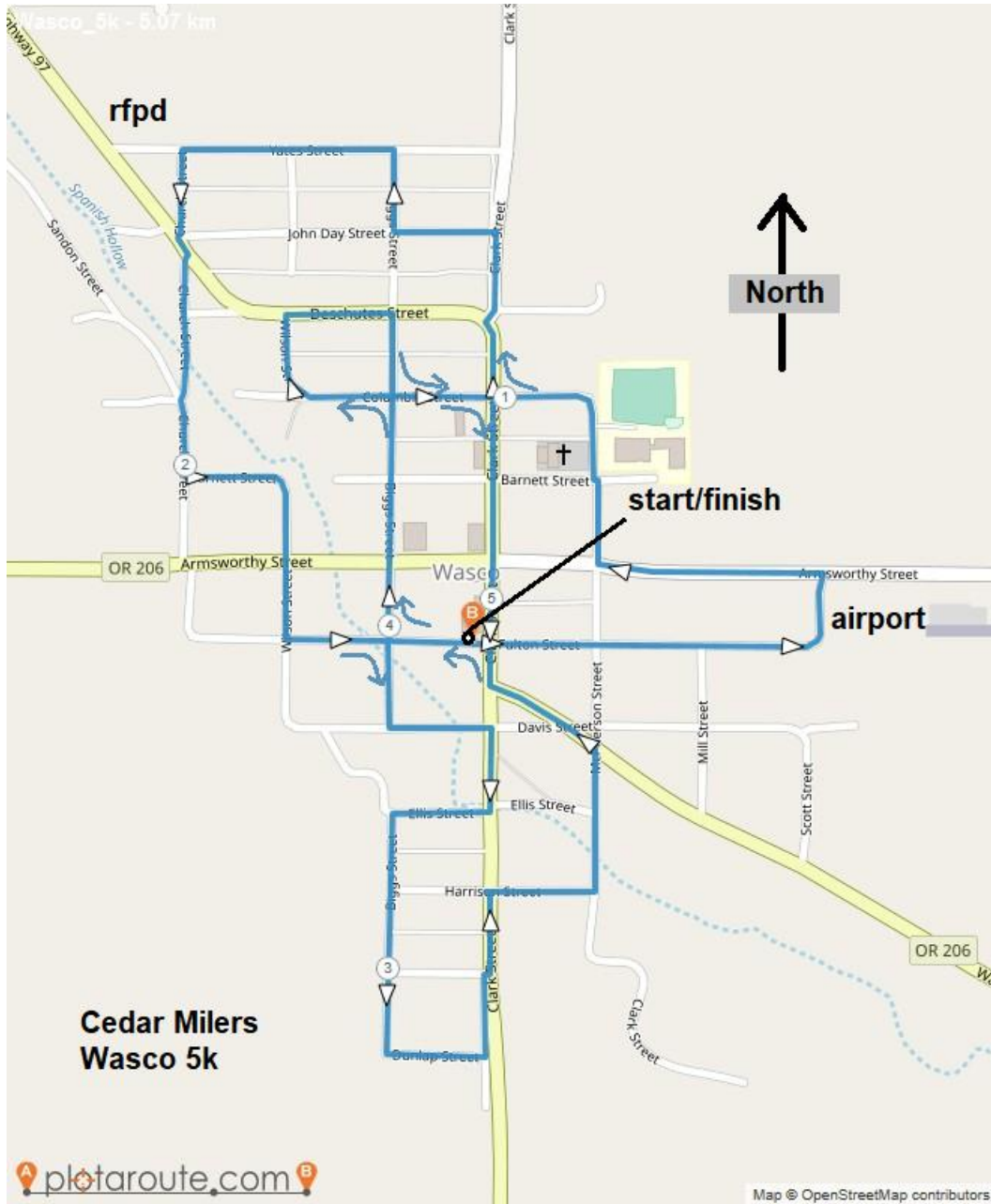
