Driving Directions to Start Point**

**Start Point Address:
Fish Lake Trail Spokane Trailhead
S. 800 Milton
Spokane. WA 99224**

Directions from I-90:

**Take Exit 280, Maple-Walnut and drive north on Walnut.
Go 2 blocks and turn left (west) on W. 2nd Ave.
Go 1 mile staying in the right lane as it becomes Sunset Blvd.
Go to Stoplight at Government Way.
Turn left (south) on Lindeke and go one block to S. Milton
Turn left to parking lot. (Restrooms available at this trailhead)**

Alternate Directions to Spokane Trailhead:

**I-90 Exit 279 (US195) South toward Pullman.
Continue on US195 for .3 mile.
Turn right onto W. 16th Ave, which turns into S. Lindke.
Continue on Lindeke to Milton (about .5 miles)
Right on Milton
Trailhead is on the right.**

Directions to Scribner Road Trailhead:

**I-90 Exit 279 (US 195).
South on US195 to Spokane-Cheney Road.
Right onto Cheney-Spokane Road to Scribner Road (after bridge crossing the railroad tracks)
Left onto Scribner Road. Small gravel trailhead adjacent to the trail. (No water or restrooms at this location.)**

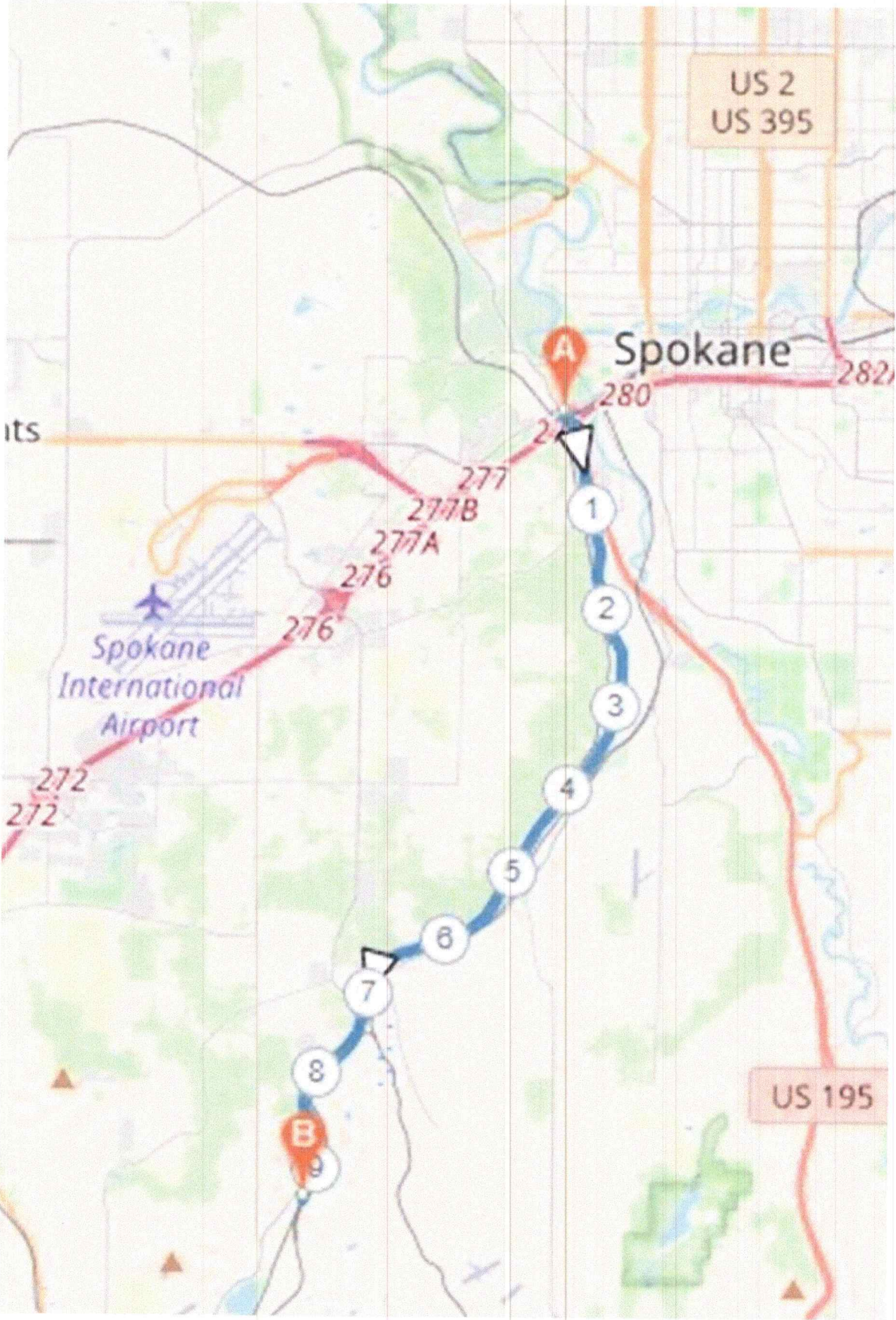
These walk directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.

This event is only available on the Online Start Box (OSB).

From either trailhead the distance you elect to bike is up to you in an out and back format. The only restroom is at the Spokane Trailhead. The trail continues beyond the Scribner Road TH for an additional 2.5 K taking the participant past Queen Lucas Lake to Minnie Creek.

Be sure to log back into the OSB system to 'finish/complete' your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the date of the event, the distance, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.) Also note that an event registration expires after 30 days, but if your registrations lapses, you may re-register without cost.
