This walk is composed of 5 and 10km routes and will be available in 2022 only. Portales is the county seat of Roosevelt County. The walk passes the historic downtown area, churches, schools, and the Eastern New Mexico University campus.

Walk Registration:

Please use the Online Start Box (OSB) to register and complete the event or contact the POC for remote registration. The directions and stamps will be available at the La Quinta Hotel at 26147 US-70E in Ruidoso during the Sun Country Striders Week of Walking April 20-25, 2022. If wishing to do the walk on the way to the events, contact the POC.

Walk Completion and Walk Credit:

Once you have completed the walk, please login to your Online Start Box account click on the "My Start Box" tab, then the "Finish Table" tab, then click on "Go to Finish Table" button for the event you have completed. Use the displayed entry form to submit the date and distance of your walk as well as select applicable AVA Special Programs to generate stamped "virtual" insert cards that you may choose to print out.

Driving Directions to the Start Point:

The walk starts at Roosevelt County Courthouse at 100 2nd St. Follow US-70 to the courthouse which is located in the 100 block between 1st and 2nd streets. US-70 splits into one-way streets 1st and 2nd with 1st street running southwest while 2nd St runs northeast. Park in front of the courthouse on 2nd St. Restrooms available at the courthouse and local businesses along the route.

PORTALES - ROOSEVELT COUNTY – 5k**Special Programs: Town Hall**

These walk directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.

1. Facing the front of the courthouse on 2nd St
LEFT on 2nd St to Ave A.
2. **RIGHT** on Ave A 1 block to the Post Office. Stop inside the Post Office to view the WPA mural.
3. **CONTINUE** on Ave A to the end of the street and the old Portales Depot. **U-TURN** back to Commercial St.
4. **RIGHT** on Commercial St 1 block to Ave B.
5. **LEFT** on Ave B 1 block to 1st St.
6. **RIGHT** on 1st St about 6-8 blocks to Ave K where 1st and 2nd streets merge.
7. **CROSS** 1st St at the light to the left side of the street, then continue on 2nd St to University.
8. **LEFT** on University and follow it as it veers right (becomes Ave N) and continue to the tennis courts on the left.
9. **LEFT** into the parking lot just before the tennis courts and continue to the greyhound statue.
10. **RIGHT** to the parking area and angle thru the parking area to the corner of 17th and Ave K.
11. **LEFT** on Ave K about 5-6 blocks to 2nd St.
12. **RIGHT** on 2nd St 6 blocks to Ave C.
13. **RIGHT** on Ave C 1 block to 3rd St (no sign).
14. **LEFT** on 3rd St 3 blocks to Main St.
15. **LEFT** on Main St 1 block to 2nd St.
16. **LEFT** on 2nd St returning to your car at the courthouse. **End of 5k.**

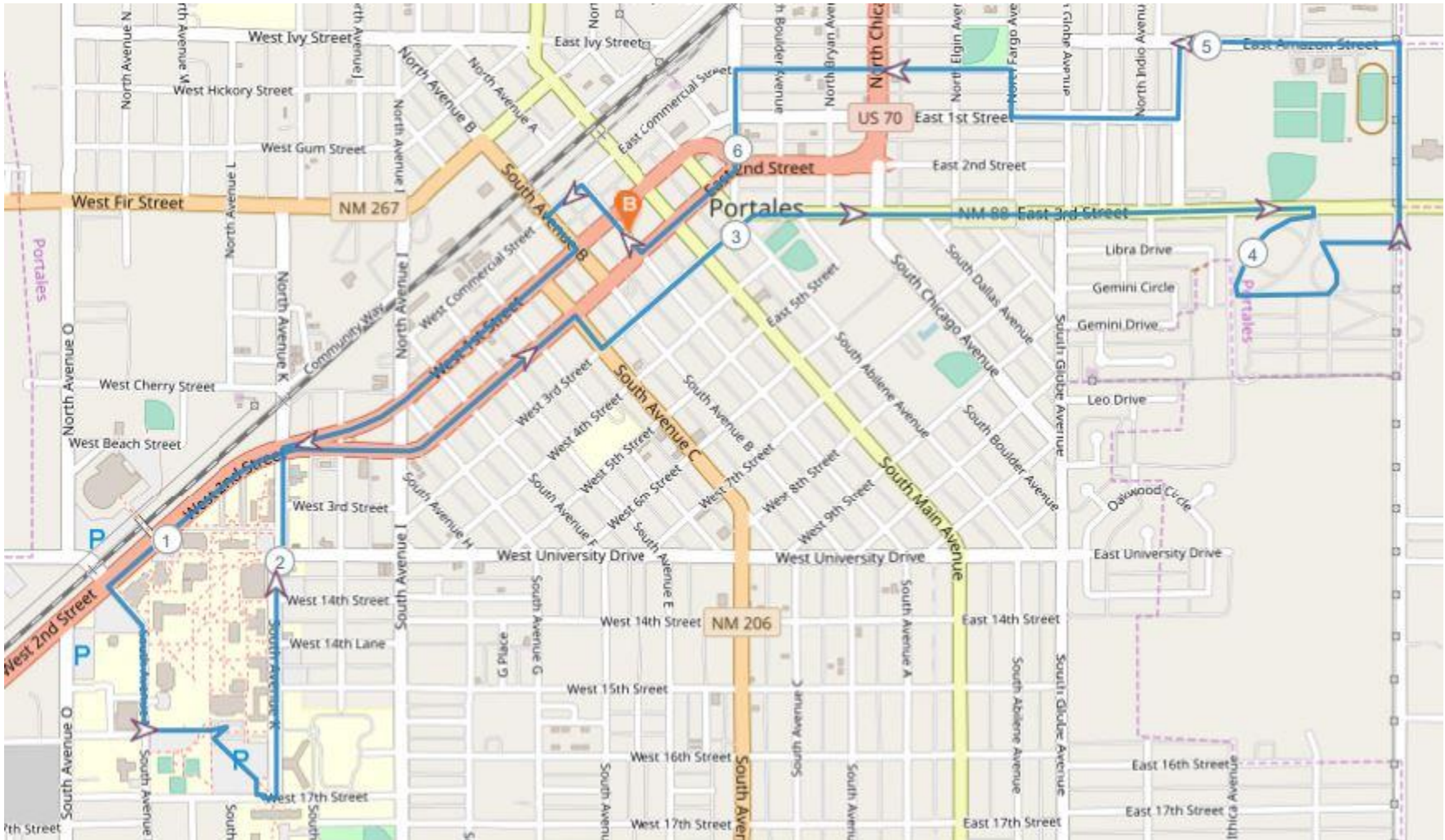
PORTALES - ROOSEVELT COUNTY – 10k

Special Programs: Town Hall

These walk directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.

1. Facing the front of the courthouse on 2nd St
LEFT on 2nd St to Ave A.
2. **RIGHT** on Ave A 1 block to the Post Office. Stop inside the Post Office to view the WPA mural.
3. **CONTINUE** on Ave A to the end of the street and the old Portales Depot. **U-TURN** back to Commercial St.
4. **RIGHT** on Commercial St 1 block to Ave B.
5. **LEFT** on Ave B 1 block to 1st St.
6. **RIGHT** on 1st St about 6-8 blocks to Ave K where 1st and 2nd streets merge.
7. **CROSS** 1st St at the light to the left side of the street, then continue on 2nd St to University.
8. **LEFT** on University and follow it as it veers right (becomes Ave N) and continue to the tennis courts on the left.
9. **LEFT** into the parking lot just before the tennis courts and continue to the greyhound statue.
10. **RIGHT** to the parking area and angle thru the parking area to the corner of 17th and Ave K.
11. **LEFT** on Ave K about 5-6 blocks to 2nd St.
12. **RIGHT** on 2nd St 6 blocks to Ave C.
13. **RIGHT** on Ave C 1 block to 3rd St.
14. **LEFT** on 3rd St about 1 mile to the entrance to the cemetery.
15. **RIGHT** into the cemetery and then immediately right on the first road.
16. Continue to 3rd road and a white building.
17. **LEFT** at the building to the middle of the cemetery.
18. **CONTINUE** straight on the cemetery road to exit the cemetery on Kilgore St.
19. **LEFT** on Kilgore 1+ blocks (Church of Christ on corner of 3rd St) to Amazon.
20. **LEFT** on Amazon 1 long block to Knoxville.
21. **LEFT** on Knoxville 1 block to 1st (no sign) passing the Portales High School.
22. **RIGHT** on 1st St 4 blocks to Fargo (no sign).
23. **RIGHT** on Fargo 1 block to Amazon.
24. **LEFT** on Amazon 5 blocks to Boston St (no sign).
25. **LEFT** on Boston 2 blocks to 2nd St.
26. **LEFT** on 2nd St 2 blocks returning to your car at the courthouse. **End of 10k.**
