Start/Finish point The walk begins at the Gazebo on the grounds of the Gentry County Courthouse. The address for the Courthouse is 116. S. Smith St. Restroom are available inside the Courthouse during regular business hours. It's recommended to use Casey's General Store or the Hyvee Grocery for restrooms prior to beginning the walk. Both locations are located a few blocks north of the courthouse on Highway 136.

Directions from Interstate 35 Northbound (From Kansas City): Head northeast on I-35 N (towards Iowa). Take exit 68 for US-69. Turn left onto US-69 N. Turn left onto 2nd St. 2nd St turns right and becomes State Hwy Z. Turn left onto State Hwy Z/Dilley St. Turn right onto State Hwy A. Continue onto MO-85 N. Turn Left on W. Harrison St. Turn Right on S. Smith St.

Directions from Interstate 35 Southbound (from Iowa): Head southwest on I-35 S (from Iowa) Take exit 92 for US-136 toward Bethany/Princeton. Turn right onto US-136 W/Miller St. Turn left onto S 25th St (US 69). Turn right onto Bethany Ave/US Hwy 136 W. Turn left onto N Hundley St. Turn Right on W. Clay St. Turn Left on S. Smith St.

Special Programs: Walking the USA A – Z ("A"); Walking Missouri Counties (Gentry County)

1. Park in any location around the courthouse. The walk begins in front of front of the Gazebo on the grounds of the courthouse square. The Gazebo is located at the intersection of W. Clay St. and S. Polk St.
2. With your back to the Gazebo and facing Polk St, turn LEFT to Wood St.
3. LEFT on Wood St. to Smith St.
4. LEFT on Smith St. to Canaday St.
5. RIGHT on Canaday St. to Hundley St.
6. LEFT on Hundley St, passing school to Casey's General Store. Restrooms are available inside Casey's.
7. Turnaround on Hundley and go 1 block to Cameron St.
8. LEFT on Cameron St. to East St.
9. RIGHT on East Street.
10. At STOP sign, LEFT on Daniel St. (No sign) to Yarrington Memorial Park/Silas Lee's Crazy Animal Park.
11. At park (on your RIGHT), enter and follow the path through the park to return back to Daniel St.
12. RIGHT on Daniel St. to 7th St.
13. RIGHT on 7th St. to Howell St.
14. RIGHT on Howell St. to East St.
15. LEFT on East St to South St.
16. RIGHT on South St. for 7 blocks to Van Buren St.
17. At end of Van Buren St. (Orton St – no sign) LEFT at STOP sign passing old cemetery. Continue to Polk St.
18. LEFT on Polk St. to return back to the courthouse to end this walk.

WALK COMPLETION AND CREDIT

Be sure to log back into the OSB system to “finish/complete” your online registration after doing the event. The OSB system does not deduct any event fee from a participant’s Event Bank until they have submitted event completion info including the date the event was walked, the distance walked, and the selection of applicable special programs

that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user’s Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user’s Event Bank when he/she submits the event completion info as a paying for credit participant. 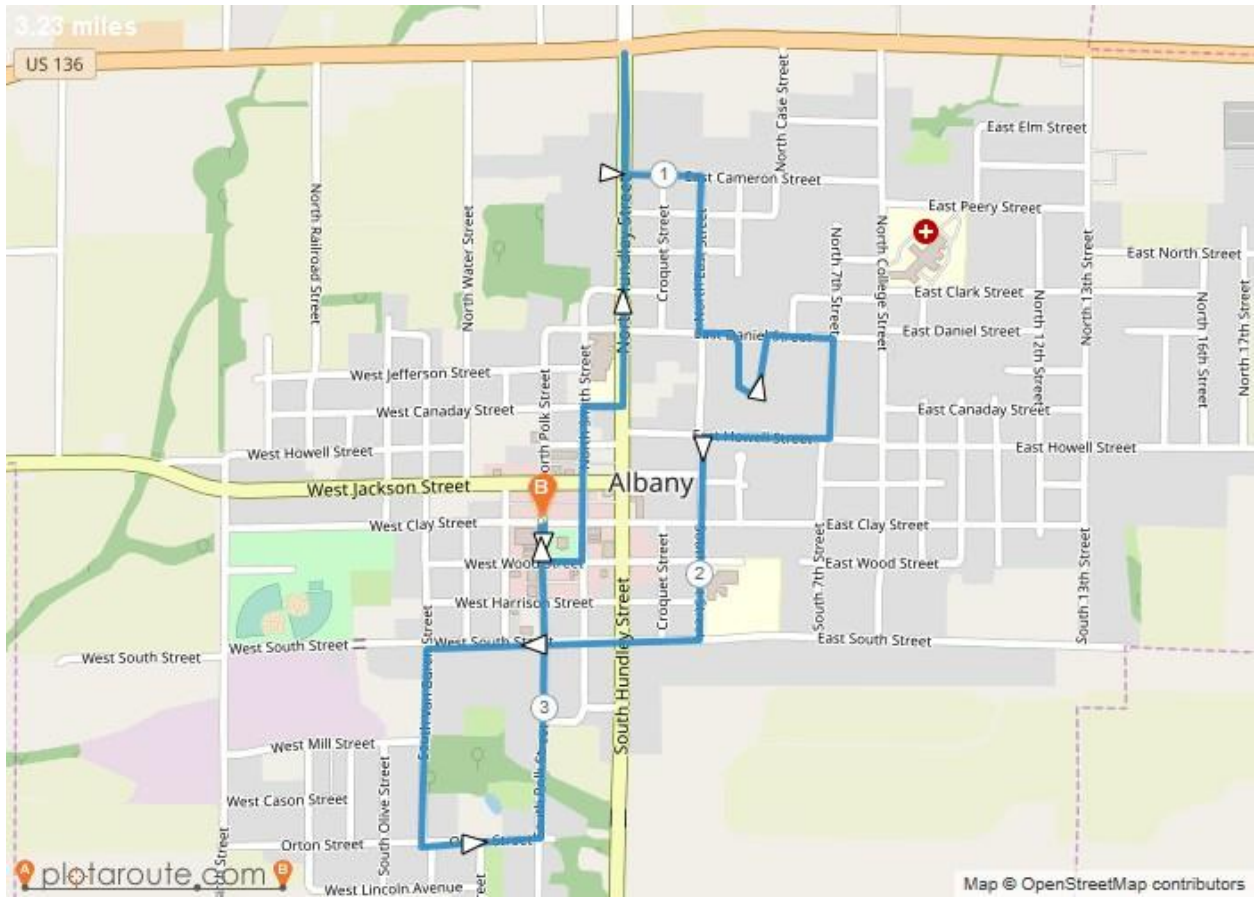

Both locations are located a few blocks north of the courthouse on Highway 136.

Directions from Interstate 35 Northbound (From Kansas City): Head northeast on I-35 N (towards Iowa). Take exit 68 for US-69. Turn left onto US-69 N. Turn left onto 2nd St. 2nd St turns right and becomes State Hwy Z. Turn left onto State Hwy Z/Dilley St. Turn right onto State Hwy A. Continue onto MO-85 N. Turn Left on W. Harrison St. Turn Right on S. Smith St.

Directions from Interstate 35 Southbound (from Iowa): Head southwest on I-35 S (from Iowa) Take exit 92 for US-136 toward Bethany/Princeton. Turn right onto US-136 W/Miller St. Turn left onto S 25th St (US 69). Turn right onto Bethany Ave/US Hwy 136 W. Turn left onto N Hundley St. Turn Right on W. Clay St. Turn Left on S. Smith St.

Special Programs: Walking the USA A – Z ("A"); Walking Missouri Counties (Gentry County)

1. Park in any location around the courthouse. The walk begins in front of front of the Gazebo on the grounds of the courthouse square. The Gazebo is located at the intersection of W. Clay St. and S. Polk St.
2. With your back to the Gazebo and facing Polk St, turn LEFT to Wood St.
3. LEFT on Wood St. to Smith St.
4. LEFT on Smith St. to Canaday St.
5. RIGHT on Canaday St. to Hundley St.
6. LEFT on Hundley St, passing school to Casey's General Store. Restrooms are available inside Casey's.
7. Turnaround on Hundley and go 1 block to Cameron St.
8. LEFT on Cameron St. to East St.
9. RIGHT on East Street.
10. At STOP sign, LEFT on Daniel St. (No sign) to Yarrington Memorial Park/Silas Lee's Crazy Animal Park.
11. At park (on your RIGHT), enter and follow the path through the park to return back to Daniel St.
12. RIGHT on Daniel St. to 7th St.
13. RIGHT on 7th St. to Howell St.
14. RIGHT on Howell St. to East St.
15. LEFT on East St. to South St.
16. LEFT on South St to 7th St.
17. LEFT on 7th St. to Howell St.
18. RIGHT on Howell St. to College Street. Cross College St. carefully and continue to 9th St.
19. RIGHT on 9th St. to Wood St.
20. LEFT on Wood St. to 10th St.
21. LEFT on 10th St to Canady St.
22. RIGHT on Canady St. to 12th St.
23. LEFT on 12th St. to Peery St.

24. LEFT on Peery St. Restrooms available inside Northwest Medical Center Hospital. Continue to College St.
25. RIGHT on College St to Cameron St.
26. LEFT on Cameron St. to Croquet St.
27. LEFT on Croquet St to Daniel St.
28. RIGHT on Daniel St. to Hundley St.
29. Cross Hundley St and continue to Polk St.
30. LEFT on Polk St. to Jefferson St.
31. RIGHT on Jefferson St. to Water St.
32. LEFT on Water St to Jackson St. (Stop Sign – no street sign).
33. RIGHT on Jackson St. to Van Buren St.
34. LEFT on Van Buren St to end of street. This will be Orten St. Stop sign but no street sign.
35. LEFT on Orten St. to Polk St.
36. LEFT on Polk St to South St.
37. RIGHT on South St to Croquet St.
38. LEFT on Croquet St to Wood St.
39. RIGHT on Wood St. to East St.
40. LEFT on East St to Clay St.
41. LEFT on Clay St. to return back to courthouse square and end walk.
