Start/Finish point The walk begins in front of the Worth County Courthouse at 11 W 4th St, Grant City, MO 64456. Restrooms are available inside the courthouse during business hours. It is recommended that during hours when the courthouse is not open, that you use restroom facilities at Casey’s General Store or Hyvee Grocery Store. Both locations are located on E 2nd St (MO Highway 46) about 2 blocks north of the courthouse.

Directions from Interstate 35 Northbound (From Kansas City): Head northeast on I-35 N (towards Iowa). Take exit 54 for MO-110/US-36 toward Cameron/Hamilton. Sharp left onto US-36 W/Chicago–Kansas City Expy/Missouri 110. Turn right onto MO-33 N. Continue onto State Hwy A/N Polk St. Continue onto State Hwy H. Turn left onto State Hwy H/Pomeroy St. Turn right to stay on State Hwy H. Continue onto US-169 N. Turn left onto E 2nd St. Turn left on S. Main St. Turn right on W. 4th St.

Directions from Interstate 35 Southbound (from Iowa): Head southwest on I-35 S (from Iowa). Take exit 54 for US-36/I-35 toward Hamilton/Cameron. Turn right onto I-35BL S/US-36 W. Turn right onto MO-33 N. Continue onto State Hwy A/N Polk St. Continue onto State Hwy H. Turn left onto State Hwy H/Pomeroy St. Turn right to stay on State Hwy H. Continue onto US-169 N. Turn left onto E 2nd St. Turn left on S. Main St. Turn right on W. 4th St.

Special Programs: Walking the USA A – Z (“G”); Walking Missouri Counties (Worth County), City Halls

1. Park in any location around the courthouse. The walk begins in front of the Worth County Courthouse at 11 W. 4th St.
2. With your back to the courthouse, facing the Great Western Bank building across the street, turn LEFT on 4th St. to Main Street.
3. LEFT on Main St. to 3rd St.
4. LEFT on 3rd St. to Front St (1 Block – no sign). City Hall will be visible.
5. RIGHT on Front St to 2nd St. Cross 2nd St. CAREFULLY and continue to 1st St.
6. RIGHT on 1st St to High St.
7. Cross High St and continue on 1st St, which is now a gravel road.
8. Continue 1 block to Lyon St. (gravel road will zig-zag to the right before reaching Lyon St.)
9. LEFT on Lyon St. passing the Worth County Community Activity Center and Skating Rink. Continue on Lyon St. to Farwell St. (Worth County Fairgrounds will be on your left).
10. RIGHT on Farwell St and immediately turn RIGHT and walk through the gravel parking lot past the baseball diamond and toward the tan-colored building to a paved bicycle path.
11. Follow the paved bicycle path as it curves up toward the skating rink. Continue on the bicycle path past the skating rink.

12. At the fork in the path, turn RIGHT and follow the path with the skating rink on your right and the swimming pool on your left. Follow the paved path as it curves around a playground and basketball court.
13. When the paved path is near a shelter house on your left, turn RIGHT off the paved path to a gravel road (McKinley St. – No sign).
14. RIGHT on the gravel road and follow it up the hill and past the Grant City Baptist Church to 2nd St. There are restrooms in the Casey's General Store across the street.
15. Cross 2nd St. and continue to 3rd St.
16. LEFT on 3rd St. to Thomas St.
17. RIGHT on Thomas St to 5th St.
18. LEFT on 5th St. 2 blocks to East St (no sign).
19. RIGHT on East St, passing school on your left to 7th St.
20. RIGHT on 7th St. to Meade St.
21. RIGHT on Meade St. to 4th St.
22. LEFT on 4th St. Walk a short distance then turn RIGHT to continue on Meade St. to 3rd St.
23. LEFT on 3rd St. to Lyon St.
24. LEFT on Lyon St to 4th St.
25. RIGHT on 4th St. to Main St.
26. LEFT on Main St. to 5th St.
27. RIGHT on 5th ST. to Pleasant St.
28. RIGHT on Pleasant St. to 3rd St.
29. RIGHT on 3rd St to Front St.
30. RIGHT on Front St. to 4th St.
31. LEFT on 4th St. to return back to the start of the walk in front of the Worth County Courthouse.

WALK COMPLETION AND CREDIT

Be sure to log back into the OSB system to “finish/complete” your online registration after doing the event. The OSB system does not deduct any event fee from a participant’s Event Bank until they have submitted event completion info including the date the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user’s Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user’s Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)

19. RIGHT on East St, passing school on your left to 7th St.
20. RIGHT on 7th St. to Meade St.
21. RIGHT on Meade St. to 4th St.
22. LEFT on 4th St. Walk a short distance then turn RIGHT to continue on Meade St. to 3rd St.
23. LEFT on 3rd St. to Lyon St.
24. LEFT on Lyon St to 4th St.
25. RIGHT on 4th St. to Main St.
26. LEFT on Main St. to 5th St.
27. RIGHT on 5th ST. to Pleasant St.
28. RIGHT on Pleasant St. to 3rd St.
29. RIGHT on 3rd St to Front St.
30. RIGHT on Front St. to 4th St.
31. LEFT on 4th St. to return back to the start of the walk in front of the Worth County Courthouse.
32. To complete a 10K, return back to Step 1 and repeat the walking directions.
