This walk is composed of 5 and 10km routes and will be available in Apr 1 thru June 30, 2025 only. Deming is the county seat of Luna County. The walk passes the historic downtown area, churches, schools, and other historic buildings.

Walk Registration:

Please use the Online Start Box (OSB) to register and complete the event. The directions and stamps will be available in Las Cruces during the AVA Convention Mon, Apr 28 thru Fri, May 2. You may register for the walk and download the directions 2 weeks before the event opens.

Walk Completion and Walk Credit:

Once you have completed the walk, please login to your Online Start Box account click on the "My Start Box" tab, then the "Finish Table" tab, then click on "Go to Finish Table" button for the event you have completed. Use the displayed entry form to submit the date and distance of your walk as well as select applicable AVA Special Programs to generate stamped "virtual" insert cards that you may choose to print out.

Driving Directions to Start Point:

The walk starts at Deming Visitor Center at 800 E Pine. From El Paso or Las Cruces, take I-10 west toward Deming, then south on Pearl to Pearl, then east on Pine St to the Visitor Center on the right. Park in the visitor center parking lot. Restrooms available at the center and local businesses along the route.

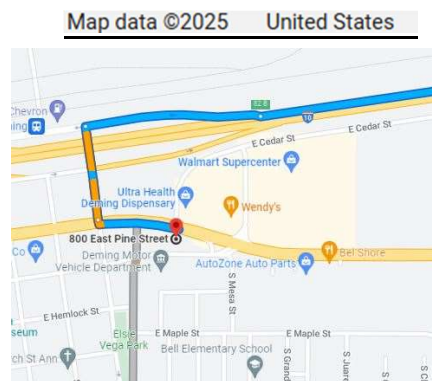

DEMING - LUNA COUNTY – 5k

Walk starts at Deming Visitor at 800 E Pine St.

Special Programs: Town Hall, Rockin' around the Clock

These walk directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.

1. Exit the parking lot away from Pine St to Spruce St. **RIGHT** on Spruce 6 blocks to Silver St.
2. **RIGHT** on Silver 2 blocks to Cedar.
3. **LEFT** on Cedar 1 block to Gold St.
4. **LEFT** on Gold 1 block to Pine St.
5. **RIGHT** on Pine 4 blocks to Tin St.
6. **LEFT** on Tin 1 block to Spruce.
7. **LEFT** on Spruce 3 blocks to Copper.
8. **RIGHT** on Copper 1 block to Hemlock.
9. **RIGHT** on Hemlock 2 blocks to Zinc St.
10. **LEFT** on Zinc 1 block to Maple.
11. **LEFT** on Maple 2 blocks to Copper.
12. **RIGHT** on Copper 1 block to Elm.
13. **LEFT** on Elm 1 block to Gold.
14. **LEFT** on Gold 3 blocks to Spruce.
15. **RIGHT** on Spruce 1 block to Silver.
16. **RIGHT** on Silver 5 blocks to Ash and the Luna County Courthouse.
17. **LEFT** on Ash 1 block to Platinum.
18. **LEFT** on Platinum 2 blocks to Elm.
19. **RIGHT** on Elm 2 blocks to Ruby.
20. **LEFT** on Ruby 1 block to Maple.
21. **RIGHT** on Maple 1 block to Pearl St.
22. **LEFT** on Pearl 1 block to Hemlock.
23. **RIGHT** on Hemlock 1 block to Carlos.
24. **LEFT** on Carlos 1 block to Spruce.
25. **RIGHT** on Spruce 1 block returning to your car. **End of 5k.**

Walk starts at Deming Visitor at 800 E Pine S.

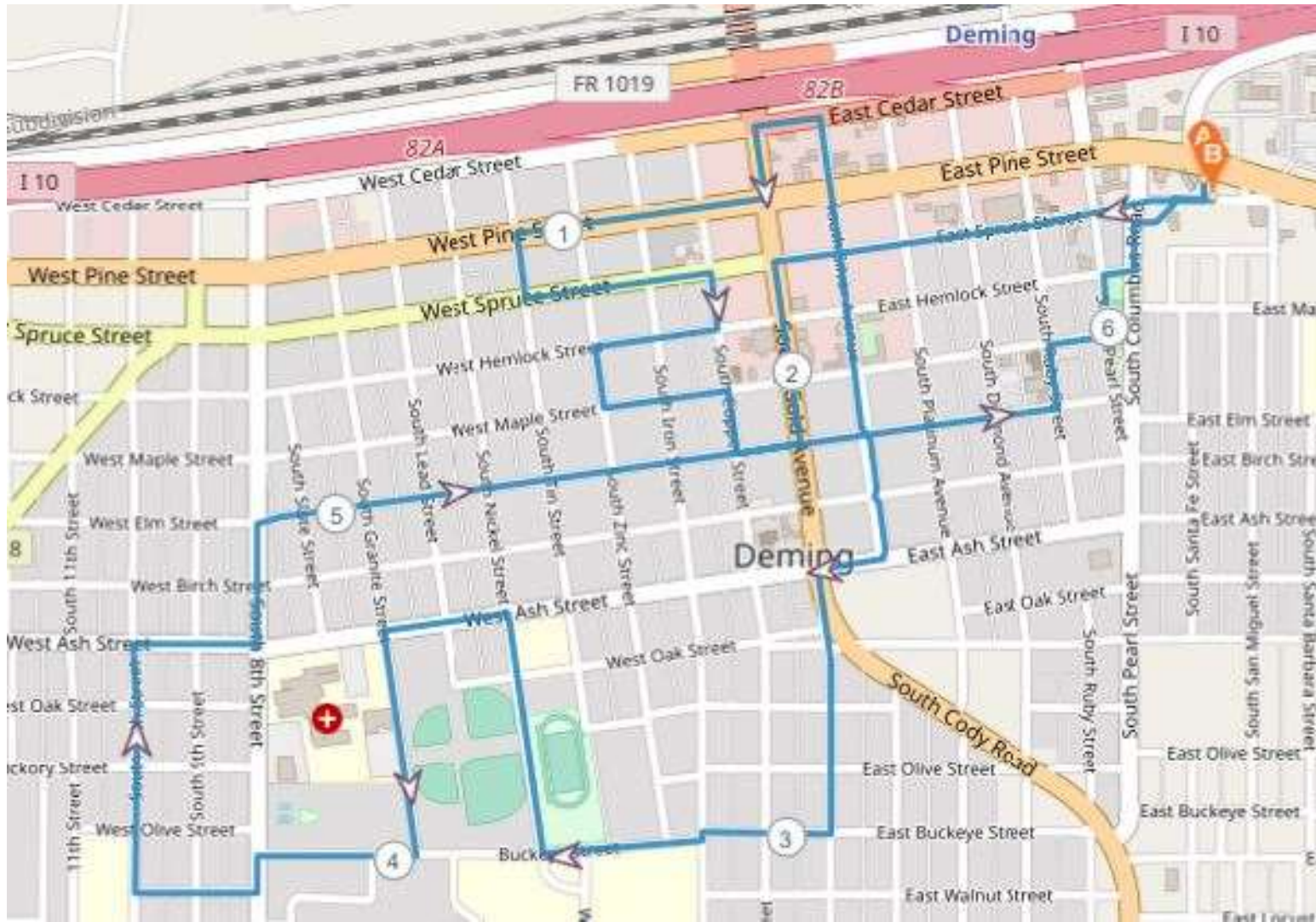
Special Programs - Town Halls, Rockin' around the Clock

These walk directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.

1. Exit the parking lot away from Pine St to Spruce St. **RIGHT** on Spruce 6 blocks to Silver St.
2. **RIGHT** on Silver 2 blocks to Cedar.
3. **LEFT** on Cedar 1 block to Gold St.
4. **LEFT** on Gold 1 block to Pine St.
5. **RIGHT** on Pine 4 blocks to Tin St.
6. **LEFT** on Tin 1 block to Spruce.
7. **LEFT** on Spruce 3 blocks to Copper.
8. **RIGHT** on Copper 1 block to Hemlock.
9. **RIGHT** on Hemlock 2 blocks to Zinc St.
10. **LEFT** on Zinc 1 block to Maple.
11. **LEFT** on Maple 2 blocks to Copper.
12. **RIGHT** on Copper 1 block to Elm.
13. **LEFT** on Elm 1 block to Gold.
14. **LEFT** on Gold 3 blocks to Spruce.
15. **RIGHT** on Spruce 1 block to Silver.
16. **RIGHT** on Silver 5 blocks to Ash and the Luna County Courthouse.
17. **RIGHT** on Ash 1 block to Gold. **NOTE:** The main highway changes name from Gold to Cody Rd and veers left while Gold St continues perpendicular to Ash St.
18. **LEFT** on Gold 4+ blocks to Buckeye.
19. **RIGHT** on Buckeye 4 blocks to Nickel.
20. **RIGHT** on Nickel 2 blocks to Ash passing between the athletic fields.
21. **LEFT** on Ash 2 blocks to Granite.
22. **LEFT** on Granite 1 long block to Buckeye passing the Mimbres Memorial Hospital.
23. **RIGHT** on Buckeye 1 block to 8th St.
24. **LEFT** on 8th a short distance to Walnut (on right side of street only).
25. **RIGHT** on Walnut 2 blocks to 10th St.
26. **RIGHT** on 10th 4 blocks to Ash St.
27. **RIGHT** on Ash 2 blocks to 8th St.
28. **LEFT** on 8th 2 blocks to Elm St.
29. **RIGHT** on Elm 13 blocks to Ruby (about 1 mile).
30. **LEFT** on Ruby 1 block to Maple.
31. **RIGHT** on Maple 1 block to Pearl St.
32. **LEFT** on Pearl 1 block to Hemlock.
33. **RIGHT** on Hemlock 1 block to Carlos.
34. **LEFT** on Carlos 1 block to Spruce.
35. **RIGHT** on Spruce 1 block returning to your car. **End of 10k.**
