

ELDORADO INSTRUCTIONS AND DRIVING DIRECTIONS

The start point for the Eldorado event is the Schleicher County Court House, 2 South Divide, Eldorado, TX 76936.

From US-277 North Bound or South Bound US-277 becomes Divide St. in Eldorado Proceed to the court house and park in the parking lot alongside Divide.

From US-190 West Bound or East Bound proceed to intersection with US-277, Divide and turn east to the court house and park in the parking lot alongside Divide.

There are restrooms available in the Schleicher County Court House during business hours.

Points of interest along the trail include the Schleicher County Courthouse, the confederate war memorial and local museum.

WALK COMPLETION AND CREDIT – Be sure to log back into the OSB system to finish and complete your online registration after doing the event. The OSB system does not deduct any event fee from a participants Event Bank until they have submitted event completion information indicating the date of the event, the distance and the selection of applicable special programs that the person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the users Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion information as a paying "for credit" participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)

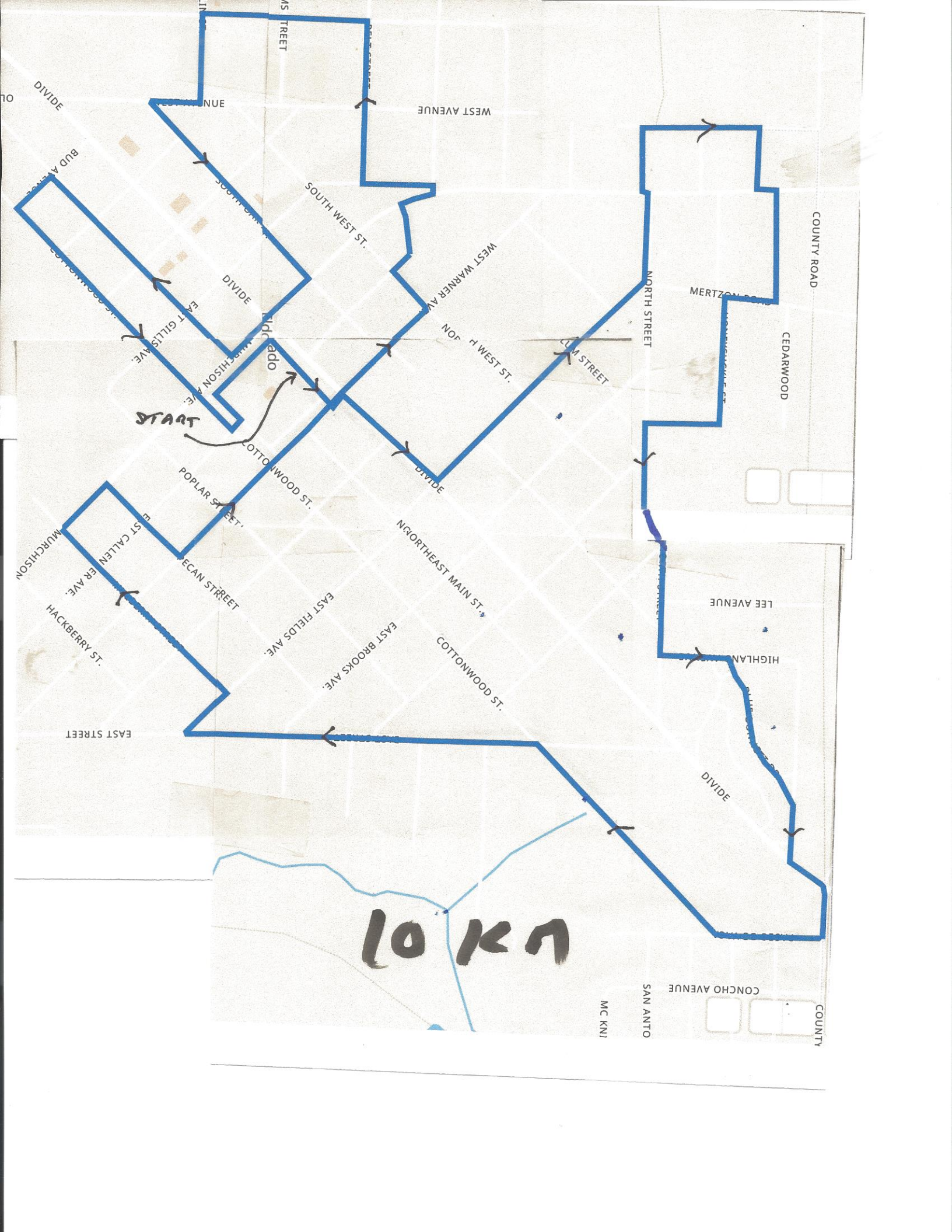

Eldorado - Schleicher County – 10K

1. Facing the court house with Divide St. to your back turn **LEFT** for ½ block to Warner.
2. Turn **LEFT** on Warner crossing Divide and immediately turn **RIGHT** on Divide to Fields.
3. Turn **LEFT** on Fields to North St.
4. Turn **LEFT** on North St. to Murchison Ave.
5. Jog **LEFT** on Murchison and immediately **RIGHT** on Maple to the T-intersection.
6. Turn **RIGHT** following the alley for two blocks to Live Oak St.
7. Turn **RIGHT** on Live Oak St. crossing Murchison to Mertzson Rd.
8. Turn **RIGHT** on Mertzson Rd. to Honeysuckle St..
9. Turn **LEFT** on Honeysuckle to its end and turn **RIGHT** on the alley to North St.
10. Turn **LEFT** on North St. to Highland Ave.
11. Turn **LEFT** on Highland Ave. for one block to circle on the right. Take the first entrance to the circle and bear left to Blue Bonnet Drive.
12. Bear **RIGHT** on Blue Bonnet Drive to Dixie Ave.
13. Bear **RIGHT** on Dixie Ave. to Divide.
14. Bear **LEFT** on Divide a short distance to the first St. on the right (Rudd Rd/CR 300).
15. Turn **RIGHT** on on Rudd Rd. for one block to Paseo de Vaca.
16. Turn **RIGHT** on Paseo de Vaca to Cottonwood St. (no street sign, just past water tower).
17. Bear **RIGHT** on Cottonwood to East St.
18. Turn **LEFT** on East St. to Fields Ave
19. Turn **RIGHT** on Fields Ave. to Mulberry St.
20. Turn **LEFT** on Mulberry St. to Murchison Ave.
21. Turn **RIGHT** on Murchison Ave. (stay on right) to Pecan St.
22. Turn **RIGHT** on Pecan St. to Warner Ave.
23. Turn **LEFT** on Warner Ave. crossing Divide to West St.
24. Turn **LEFT** on West St. to Callender Ave.
25. Turn **RIGHT** on Callender Ave. continuing as it bears **LEFT** to Murchison Ave.
26. Turn **RIGHT** on Murchison Ave. for one block to Herman St. on the left.
27. Turn **LEFT** on Herman St. to Gillis Ave.
28. Turn **LEFT** on Gillis Ave. for one block to Pelt St. on the right.
29. Turn **RIGHT** on Pelt St. to McWhorter Ave.
30. Turn **LEFT** on McWhorter Ave. to Stricklin St.
31. Turn **LEFT** on Stricklin to West Ave.
32. Turn **RIGHT** on West Ave one block to Oak St. on the left.
33. Turn **LEFT** on Oak St. to Murchison Ave.
34. Turn **RIGHT** on Murchison Ave. crossing Divide to Main St.
35. Turn **RIGHT** on Main St. to Bud Ave.
36. Turn **LEFT** on Bud Ave. to Cottonwood St.
37. Turn **LEFT** on Cottonwood St. to Callender Ave.
38. Turn **LEFT** on Callender Ave. to the parking lot behind the court house.
39. Turn **LEFT** in the parking lot and follow it past the Memorial Building and Sheriff's Office and continue around the court house to the its front.

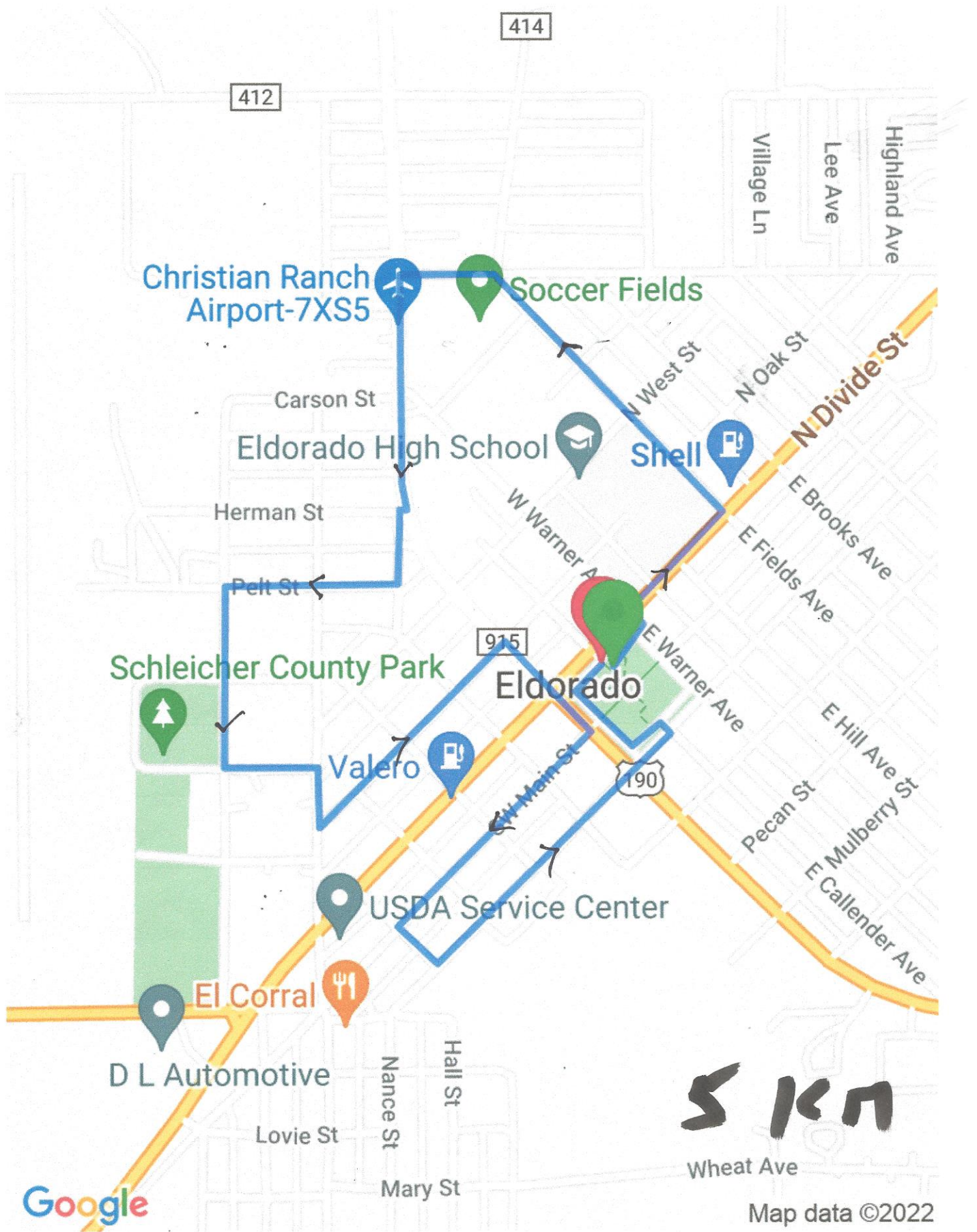

Eldorado - Schleicher County – 5 K

1. Facing the court house with Divide St. to your back, turn **LEFT** for ½ block to Warner.
2. Turn **LEFT** on Warner crossing Divide and immediately turn **RIGHT** on Divide to Fields.
3. Turn **LEFT** on Fields to North St.
4. Turn **LEFT** on North St. to Murchison Ave.
5. Turn **LEFT** on Murchison to Herman on the right.
6. Turn **LEFT** on Gillis to Pelt St. on the right.
7. Turn **RIGHT** on Pelt St. to McWhorter St.
8. Turn **LEFT** on McWhorter St. to Stricklin St.
9. Turn **LEFT** on Stricklin to West Ave.
10. Turn **RIGHT** on West Ave one block to Oak St. on the left.
11. Turn **LEFT** on Oak St. to Murchison Ave.
12. Turn **RIGHT** on Murchison Ave. crossing Divide to Main St.
13. Turn **RIGHT** on Main St. to Bud Ave.
14. Turn **LEFT** on Bud Ave. to Cottonwood St.
15. Turn **LEFT** on Cottonwood St. to Callender Ave.
16. Turn **LEFT** on Callender Ave. to the parking lot behind the court house.
17. Turn **LEFT** in the parking lot and follow it past the Memorial Building and Sheriff's Office and continue around the court house its front.
