CLAUDE, TEXAS



Claude is the County Seat of Armstrong County. The Courthouse dates to 1912. The population of Claude is around 2,000. The movies *Hud*, starring Paul Newman, *Leap of Faith* (Steve Martin, Debra Winger) and the closing scene in *Indiana Jones and the Last Crusade* were filmed there. Armstrong County is home to the JA Ranch, the oldest cattle operation in the Texas Panhandle, founded by Charles Goodnight and George Adair in 1876. The Charles and Mary Ann Goodnight Ranch State Historic Site is 12 miles east of Claude on US-287 and the Goodnight Cemetery is also nearby. The walks include the Courthouse, the Armstrong County Museum, school, library, and neighborhoods.

OSB or PSB Walk Registration:

Please use either the Online Start Box (OSB) or Physical Start Box (PSB) to register and complete the event. Do NOT mix and match. For example, do not register using the OSB, then complete your event using the PSB (nor sign the PSB log sheet). The sponsoring club only receives credit for an OSB participation when an OSB registration has been completed online by entering your participation date, distances, and any special programs using the OSB.

Walk Completion and Credit:

When you finish your walk(s), be sure to log back in to the OSB System and enter your participation date, distances, and Special Programs (if applicable).

Start Point Address and Driving Directions:

The walk starts at the Armstrong County Courthouse, 101 Trice St. East- or westbound on US-287 in Claude, turn south on Goodnight St. and park on Goodnight on the east side of the Courthouse.

Restrooms and Parking:

There is a Cefco Travel Center 2 blocks northwest of the Courthouse on US-287. Free street parking is available around the Courthouse.

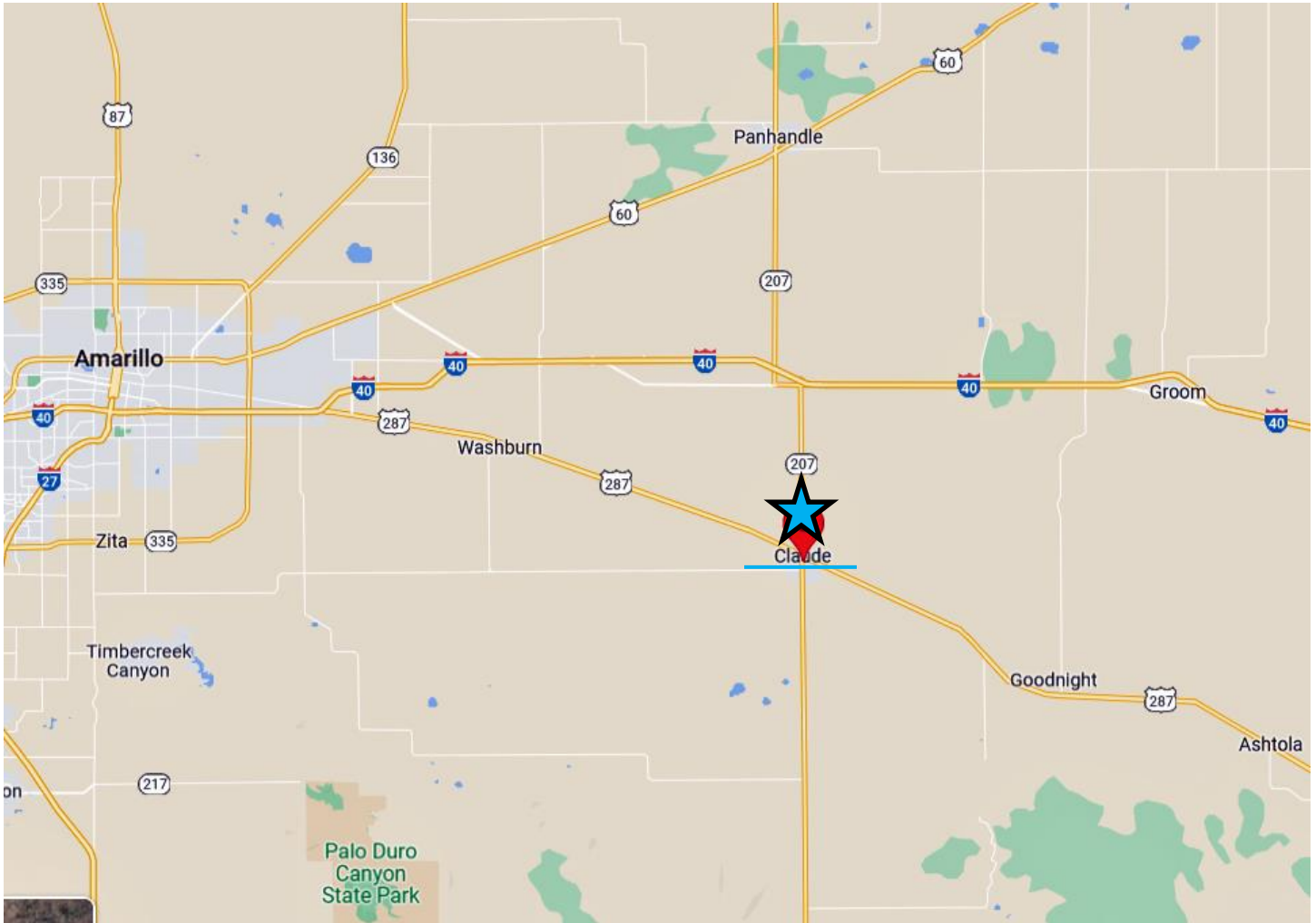

START POINT LOCATION

101 Trice Street, Claude TX

East- or westbound on US-287 in Claude, turn south on Goodnight St. and park on Goodnight on the east side of the Courthouse.



TEXAS COUNTY WALKERS – 2023 ARMSTRONG COUNTY 10 km WALK in CLAUDE, TX.

The walk starts at the Armstrong County Courthouse, 101 Trice St. East- or westbound on US-287 in Claude, turn south on Goodnight Street and park on Goodnight on the east side of the Courthouse.

10 KM INSTRUCTIONS

1. Facing the back of the Courthouse, turn **RIGHT** on Goodnight Street for ½ block to First St. /US-287.
2. Using **CAUTION, CAREFULLY** cross First St. /US-287 and continue for 1 block on Goodnight to end of paved street.
3. **LEFT** on dirt road for 1 block to Trice Street (no sign, Armstrong County Museum bldgs. on the corner).
4. **LEFT** on Trice for 1 block back to the highway.
5. Using **CAUTION, CAREFULLY** cross the highway and visit the Historical Markers by the Courthouse.
6. **RETURN** to Trice St. and **LEFT** on Trice for 4 blocks to Fifth Street.
7. **LEFT** on 5th Street for 1 block to Goodnight Street.
8. **RIGHT** on Goodnight for 1 block to Sixth Street.
9. **RIGHT** on Sixth St. for 3 blocks to Hurley Ave/TX-207.
10. **CAREFULLY CROSS** Hurley/TX-207 and continue 1 more block to Cherry St. (no sign).
11. **RIGHT** on Cherry, passing the athletic field on your left, for 2 blocks to Fifth Street.
12. **LEFT** on Fifth for 1 block to Vine Street.
13. **RIGHT** on Vine St. for 3 blocks to Second Street.
14. **LEFT** on Second St. for 1 block to High Street.
15. **LEFT** on High St. for 5 blocks, passing the Library to the stop sign at Orient St. (no street sign).
16. **RIGHT** on Orient for 1 block to Dysart Street.
17. **RIGHT** on Dysart for 5 blocks to Second Street.
18. **LEFT** on Second St. for 1 block to Wilson Street.
19. **LEFT** on Wilson for 3 blocks to Fifth Street.
20. **RIGHT** on Fifth St. for 1 block to Western Street.
21. **LEFT** on Western for 2 blocks to Orient Street.
22. **RIGHT** on Orient for 1 block to Pratt Street.
23. **RIGHT** on Pratt for 6 blocks to Cavanaugh Street.
24. **LEFT** on Cavanaugh for 1 block to Hermosa Street.
25. **LEFT** on Hermosa for 5 blocks to Fifth Street.
26. **RIGHT** on Fifth St. for 1 block to Alamo Street.
27. **RIGHT** on Alamo for 4 blocks to First Street.
28. **RIGHT** on First St. for 7 blocks to Cherry Street.
29. **RIGHT** on Cherry St. for 3 blocks to Fourth Street.
30. **LEFT** on Fourth St. for 1 block to Hurley Ave/TX-207.
31. **CROSS** Hurley/207 and turn **LEFT** on Hawkins Street.
32. **CONTINUE** on Hawkins 2 blocks to Second Street.
33. **RIGHT** on Second St. for 1 block to Pratt Street.
34. **RIGHT** on Pratt for 2 blocks to Fourth Street.
35. **LEFT** on Fourth St. for 3 blocks to Andrus Street.
36. **LEFT** on Andrus for 2 blocks to Second Street.
37. **LEFT** on Second St. for 1 block to Goodnight Street.
38. **RIGHT** on Goodnight to **FINISH**.

These walk directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.

TEXAS COUNTY WALKERS – 2023 ARMSTRONG COUNTY 6 km WALK in CLAUDE, TX.

The walk starts at the Armstrong County Courthouse, 101 Trice St. East- or westbound on US-287 in Claude, turn south on Goodnight St. and park on Goodnight on the east side of the Courthouse.

5 KM INSTRUCTIONS

1. Facing the back of the Courthouse, turn **RIGHT** on Goodnight Street for ½ block to First St. /US-287.
2. Using **CAUTION, CAREFULLY** cross First St. /US-287 and continue on Goodnight for 1 block to end of paved street.
3. **LEFT** on dirt road for 1 block to Trice Street (no sign, Armstrong County Museum bldgs. on the corner).
4. **LEFT** on Trice for 1 block back to the highway.
5. Using **CAUTION, CAREFULLY** cross the highway and visit the Historical Markers by the Courthouse.
6. **RETURN** to Trice St. and **LEFT** on Trice for 4 blocks to Fifth Street.
7. **LEFT** on 5th Street for 1 block to Goodnight Street.
8. **RIGHT** on Goodnight for 1 block to Sixth Street.
9. **RIGHT** on Sixth St. for 3 blocks to Hurley Ave/TX-207.
10. **CAREFULLY CROSS** Hurley/TX-207 and continue 1 more block to Cherry St. (no sign).
11. **RIGHT** on Cherry, passing the athletic field on your left, for 2 blocks to Fifth Street.
12. **LEFT** on Fifth St. for 2 blocks to High Street.
13. **LEFT** on High St. for 2 blocks (passing the Library) to Orient Street (no street sign).
14. **RIGHT** on Orient St. for 1 block to Dysart Street.
15. **RIGHT** on Dysart for 4 blocks to Second Street.
16. **RIGHT** on Second St. for 3 blocks to Cherry Street.
17. **RIGHT** on Cherry St. for 1 block to Third Street.
18. **LEFT** on Third St. for 1 block to Hurley Ave /TX-207.
19. **CAREFULLY CROSS** Hurley / 207 and **CONTINUE** on Third St. for 1 block to Hawkins St.
20. **LEFT** on Hawkins for 1 block to Second Street.
21. **RIGHT** on Second St. for 1 block to Parks Street.
22. **RIGHT** on Parks for 2 blocks to Fourth Street.
23. **LEFT** on Fourth for 3 blocks to Andrus Street.
24. **LEFT** on Andrus for 2 blocks to Second Street.
25. **LEFT** on Second Street for 1 block to Goodnight St.
26. **RIGHT** on Goodnight St. to **FINISH**.

These walk directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.
