

Echo Bluff State Park – Shannon County – MO

Start Point: Blufftop Pavilion Parking, Echo Bluff State Park, State Rt 19 , MO

GPS: 37.30850366367057, -91.40999369345006

Directions: From Salem MO: take MO 19 South (S Main St) about 27.5 miles. Turn left into Echo Bluff State Park. Turn right at 1st intersection to the Blufftop Pavilion parking lot.

Restrooms: Restrooms are available at the startpoint. Along the trail they are also available in the campground and at the lodge (10k only)

Trail: 2C – The trail is on a groomed trail through the woods and on roads & sidewalks.

WALK COMPLETION AND CREDIT: Be sure to log back into the OSB system to “finish/complete” your online registration after doing the event. The OSB system does not deduct any event fee from a participant’s Event Bank until they have submitted event completion info including the date the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user’s Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user’s Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.).

1. **Please refer to the map**
2. Facing the restrooms, look to the left for the trailhead. Take the trail to the 1st intersection
3. Go straight following RED flashes on the South Loop– do not take boardwalks
4. At 2nd intersection, continue straight, do not follow white flashes
5. At 3rd intersection go straight, now following the BLUE flashes, crossing the boardwalk
6. After crossing the boardwalk, bear left to remain on the North Loop (Blue flashes)
7. Follow the North loop and continue straight where the trail makes a u-turn to the left. DO NOT take the u-turn
8. Follow the blue blazes, going thru numerous switchbacks, until you see Echo Bluff Dr. Cross the grass and go thru the break in the guardrail.
9. Turn right on Echo Bluff Dr crossing the bridge.
10. Turn around and retrace your steps back to the Painter Ridge Trail - Blue Flashes. Walk back up the switchbacks.
11. At the intersection bear left so you are on the lower part of the North loop (see map) following the blue flashes
12. At next intersection go straight across the boardwalk then bear left on the lower trail following the RED blazes
13. At the intersection with bike ramps, go straight.
14. When you see the back of the shelter on your right continue straight, then pass under the overlook and bear right up to the parking lot.

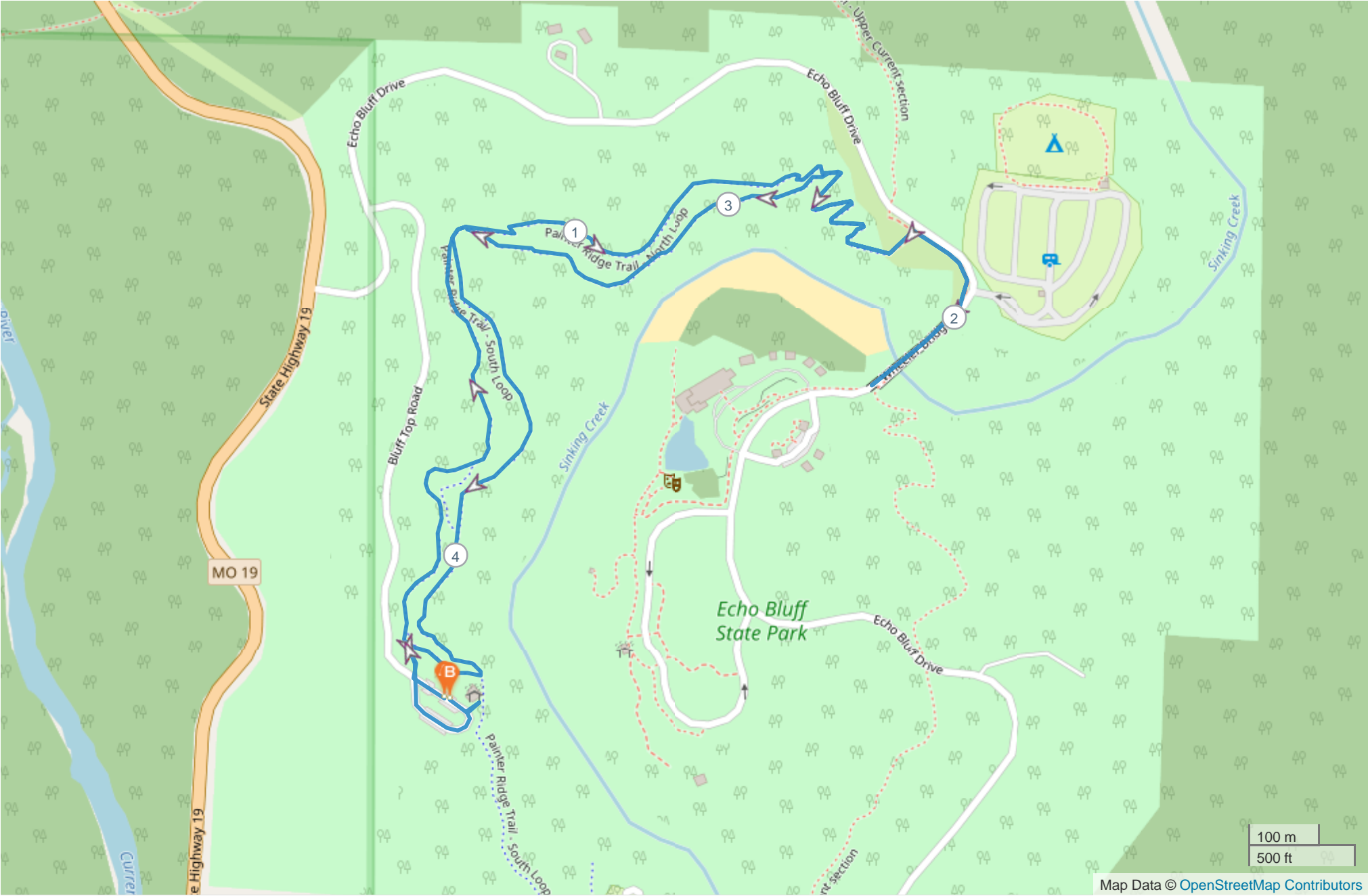

Echo Bluff State Park – Emminence MO – 9 K

1. **Please refer to the map**
2. Facing the restrooms, look to the left for the trailhead. Take the trail to the 1st intersection
3. Go straight following RED flashes on the South Loop– do not take boardwalks
4. At 2nd intersection, continue straight, do not follow white flashes
5. At 3rd intersection go straight, now following the BLUE flashes, crossing the boardwalk
6. After crossing the boardwalk, bear left to remain on the North Loop (Blue flashes)
7. Follow the North loop and continue straight where the trail makes a u-turn to the left. DO NOT take the u-turn
8. Follow the blue blazes, going thru numerous switchbacks, until you see Echo Bluff Dr. Cross the grass and go thru the break in the guardrail.
9. Turn right on Echo Bluff Dr crossing the bridge.
10. Turn right on the road to the Betty Lea Lodge (restrooms available)
11. Continue on the road until you come back out on Echo Bluff Dr
12. Turn right on Echo Bluff Dr
13. Turn right on next road and follow until it loops back to Echo Bluff Dr & turn left
14. Turn right on the next loop road and back to Echo Bluff Dr again.
15. Turn right on Echo Bluff Dr to the 1st road into the campground and bear left at 1st intersection & continue on the outer loop around the campground back to Echo Bluff Dr.
16. Cross Echo Bluff Dr and turn right to break in guardrail, turn left crossing the grass back to the trail to the right of the old shelter.
17. Enter the Painter Ridge trail and follow the BLUE flashes back up the switchbacks.
18. At the intersection bear left so you are on the lower part of the North loop (see map) following the blue flashes
19. At next intersection go straight across the boardwalk then bear left on the lower trail following the RED blazes
20. At the intersection with bike ramps, go straight.
21. After passing the back of the concrete shelter on the right & going under the overlook, bear left to remain on the South loop to the end
22. Retrace your steps passing under the overlook and the back of the shelter to the intersection and bear left to the next intersection and bear left back to the parking lot
23. Turn left and make a loop around the parking lot and return to your car.
