This walk is composed of 6km and 10km routes. The walk is rated 1A and is along city sidewalks. The walk explores Belle Chasse, the largest town in Plaquemines Parish. The 10k extends into a residential neighborhood and passes the Our Lady of Perpetual Hope Church.

**Walk Registration:**

Please use the Online Start Box (OSB) or contact the POC register remotely. If using the OSB, then complete the walk online as indicated below. If registering remotely, insert cards will be mailed to you. Directions and stamp will be available during the MLK weekend events Jan 11-15 from the POC.

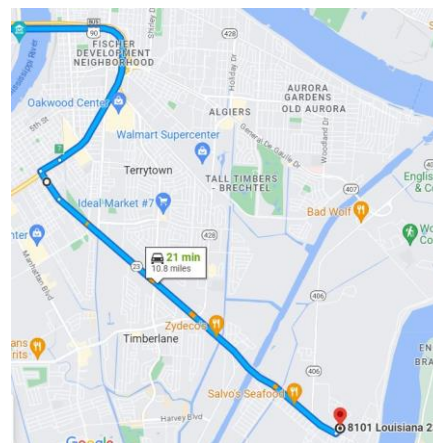
**Walk Completion and Walk Credit:**

Once you have physically completed the walk, please login to your Online Start Box account click on the "My Start Box" tab, then the "Finish Table" tab, then click on "Go to Finish Table" button for the event you have completed. Use the displayed entry form to submit the date and distance of your walk as well as select applicable AVA Special Programs to generate stamped "virtual" insert cards that you may choose to print out.

**Driving Directions to Start Point:**

The walk starts at the Belle Chasse YMCA at 8101 LA-23 in Belle Chasse. From the west, take I-10 east to New Orleans, then exit onto Bus-90. Continue to LA-23. Turn south on LA-23 toward Belle Chasse. Continue to the YMCA on the left side of the highway.

Restrooms available at the YMCA and at businesses along the route.

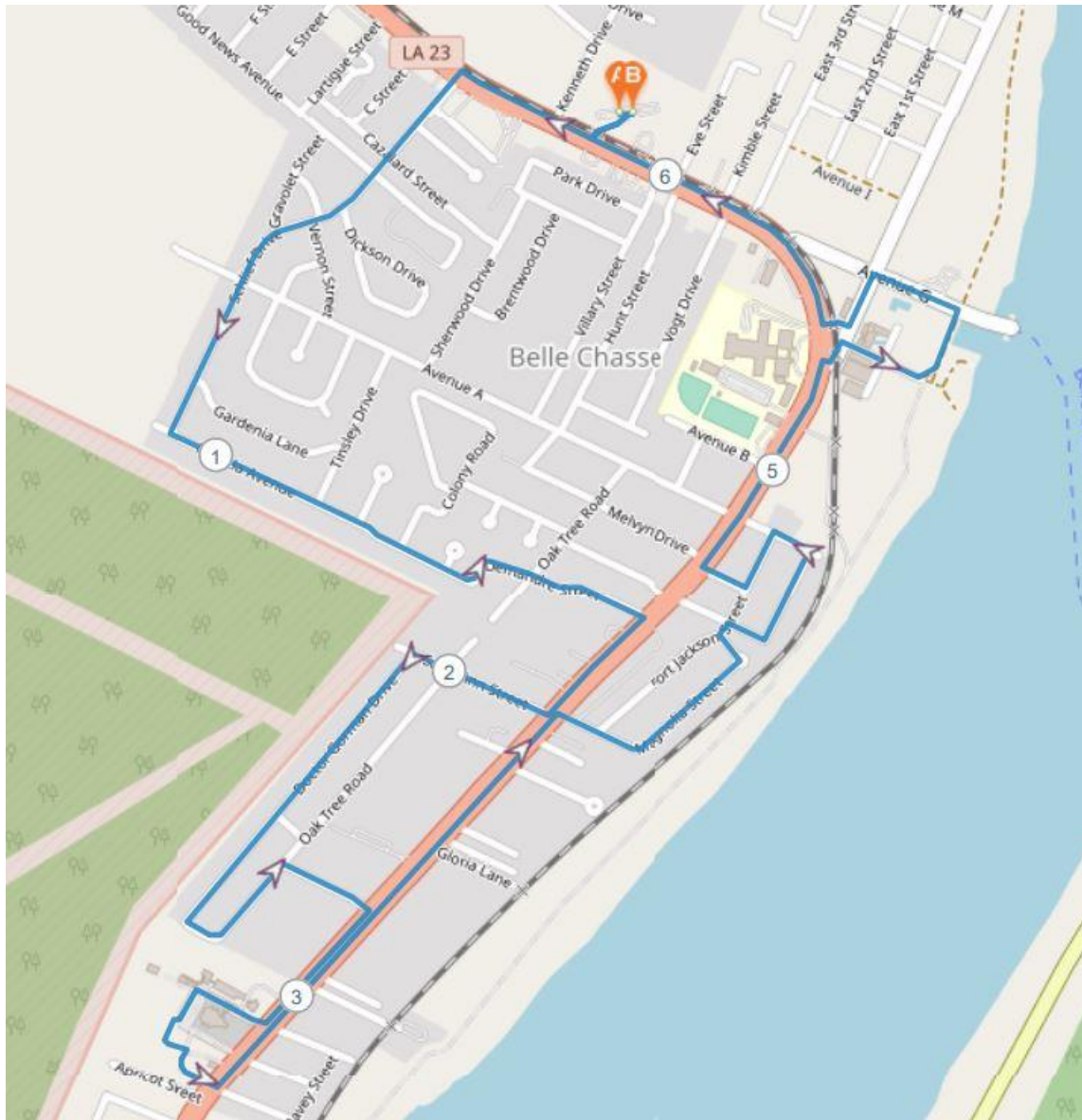

**Belle Chasse - Plaquemines Parish – 6/10K****Drive to the YMCA at 8101 LA-23 in Belle Chasse, La**

1. **From the YMCA parking lot**, walk back to LA-23. Carefully cross the highway and turn **RIGHT**.
2. **CONTINUE** on LA-23 1 block to Schlieff passing the Sheriff's Office.
3. **LEFT** on Schlieff about 1k to the end at Moncla Ave (no sign).
4. **LEFT** on Moncla about 1k. Moncla becomes Demandre. Demandre curves to the left, then right and ends at LA-23.
5. **LEFT** on LA-23 (staying on the right side of the highway) 3 short blocks to St Ann.
6. **6k ONLY: CROSS** the highway to Magnolia (slightly to the left, but almost directly across from St Ann), **then go to step 15**.
7. **10k ONLY: RIGHT** on St Ann to end of street at Doctor Gorman.
8. **LEFT** on Doctor Gorman to the end of the street at Oak Tree Rd.
9. **LEFT** on Oak Tree as it curves to the left to Woodchase (do not go straight on Oliver St).
10. **RIGHT** on Woodchase several short blocks to LA-23.
11. **RIGHT** on LA-23 (staying on the right side) 2 blocks to the entrance to the Our Lady of Perpetual Hope School.
12. **RIGHT** on the school road and circle to the left around the school to the cemetery.
13. Enter the cemetery and follow road to the left to exit.
14. Veer right, then left back to LA-23.
15. **LEFT** on LA-23 about 1k to Magnolia Dr (on the right only). Cross the highway to the right side **when safe**.
16. **RIGHT** on Magnolia 2 blocks, then left to continue on Magnolia.
17. **6k rejoins here: Continue** on Magnolia as it curves left to Fort Jackson.
18. **RIGHT** on Fort Jackson a short distance to Baker.
19. **RIGHT** on Baker to Grand Island.
20. **LEFT** on Grand Island to Belle Chasse.
21. **LEFT** on Belle Chasse to Fort Jackson.
22. **LEFT** on Fort Jackson a short block to New Orleans.
23. **RIGHT** on New Orleans back to LA-23.
24. **RIGHT** on LA-23 to Main St (LA-23 curves to the left, while Main St angles to the right.)
25. **Continue** on Main a short way to Cueva St.
26. **RIGHT** on Cueva, cross Levee Rd and continue up to the levee.
27. **LEFT** on the levee trail to Ave G (ferry landing).
28. **LEFT** on Ave G 1 block to Main passing the Justice of the Peace office, the Plaquemines Parish Courthouse Annex, and the Sheriff's Office.
29. **LEFT** on Main to the Sheriff's Office, then **RIGHT** in front of the office to LA-23.
30. **RIGHT** on LA-23 (Belle Chasse High School across LA-23) staying on the right side of the highway.
31. **Continue** on LA-23 back to the YMCA. **END of walk**.
