Start: Veteran's Memorial – 402 Front Street. Parking available in front. Restrooms available during business hours at the Chamber of Commerce (Rock & Roll Museum), Courthouse, Library, and the District Court (entrance on Elm St).

2. WALK COMPLETION AND CREDIT: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the date the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the Event Bank when the PDF is downloaded. 2. R on Beech St.
3. R on Second St. Rock & Museum located on this street.
4. L on Main St.
5. L on Third St.
6. Cross at the light and continue on Walnut St.
7. L on Rimmel. Before turning left on Bowen St, you will see the house Sam Walton lived in at 6 Rimmel.
8. Left on Bowen St.
9. L on Leona.
10. R on Newport Ave.
11. R on Laura St.
12. Take the sidewalk right before the Rimmel Park columns.
13. Continue on the sidewalk until you reach the high school. Turn L and follow the road between the tennis courts and high school.
14. Turn L and follow the road by the lake going back towards the Rimmel Park columns.
15. Go through the Rimmel Park columns and proceed to Sixth St.
16. R on Hazel St.
17. L on Fifth St.
18. R on Walnut St. Cross at the light and continue on Walnut St. Library located on this street.
19. L on Second St.
20. L on Elm St. District Court entrance on this street.

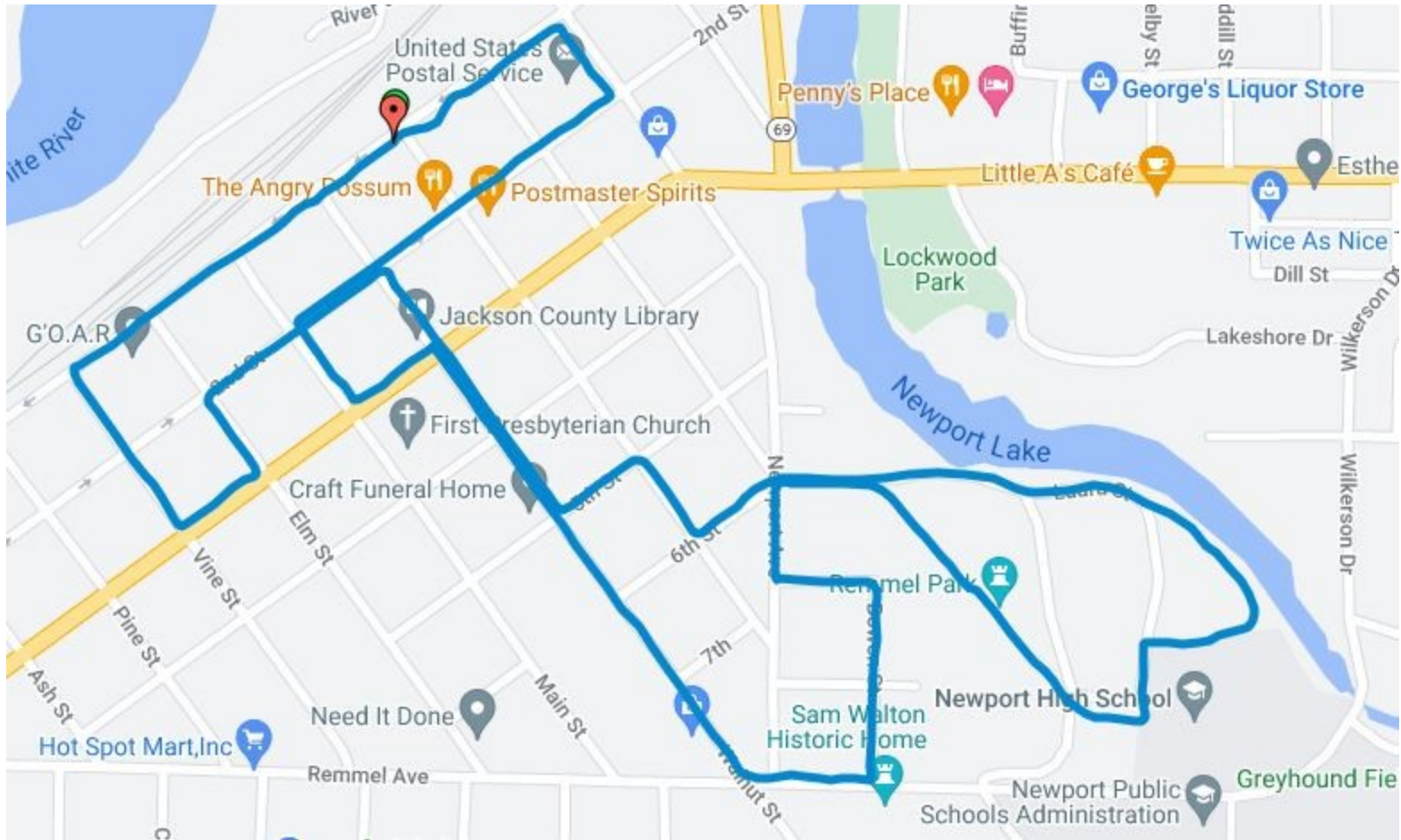

 8. L on Bowen St.
 9. L on Leona.
 10. R on Newport Ave.
 11. R on Laura St.
 12. Take the sidewalk right before the Remmel Park columns.
 13. Continue on the sidewalk until you reach the high school. Turn L and follow the road between the tennis courts and high school.
 14. At the end of the black fence, turn R walking alongside the fence on the footpath leading to a sidewalk.
 15. Continue on sidewalk. Turn L onto Wilkerson St.
 16. L on Lakeshore Dr. Pass a water treatment plant and continue to the park on the left.
 17. Follow the path in the park and return to Lakeshore Dr. Retrace your steps back to Wilkerson St.
 18. L on Wilkerson.
 19. R on Dill.
 20. R on Forest.
 21. L on North Lakeside Ln.
 22. L on Pickens.

23. L on Virginia Rd.
24. L on Country Club Rd.
25. At intersection of Country Club and Dogwood continue straight making the loop (Dogwood Circle). At end of loop continue down Dogwood to Cypress Circle.
26. R on Cypress Circle making loop and coming back to Dogwood.
27. L on Country Club Rd.
28. Pass the football field and come to the end of Country Club Rd. Cross the road to the Newport Greyhound sign and back to the footpath previously taken.
29. Continue straight to the road and walk alongside the lake going back towards the Rimmel Park columns.
30. Go through the columns and proceed to Sixth St.
31. R on Hazel St.
32. L on Fifth St.
33. R on Walnut St. Cross at the light and continue on Walnut St. Library located on this street.
34. L on Second St.
35. L on Elm St. District Court entrance on this street.
36. R on Third St.
37. R on Vine St.
38. R on Front St. to the memorial.
