From Rte. 29 or Rte. 32, take Route 108 West past Route 216 intersection (Highland) to first left onto Hall Shop Road.

Follow Hall Shop Road to park entrance on right.

Or

take Route 29 to Route 216 West.

Follow Route 216 West to Hall Shop Road.

Turn left onto Hall Shop Rd.

Follow to park entrance on left.

5750 Oakland Mills Rd, Columbia, MD 21045

From I-95, take Rt175 West toward Columbia.

LEFT on Tamar Drive.

RIGHT on Oakland Mills Road into Park.

RIGHT into parking lot by baseball fields.

From Rt29, take Rt175 East

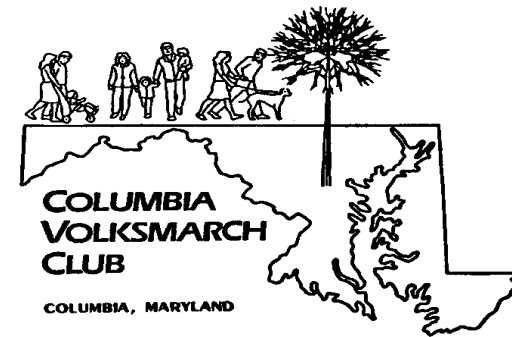
After Traffic Light at Thunder Hill Road, RIGHT into Blandair Park.

COURSE DESCRIPTIONS: There is one event for each walk: Each will have two (2) 5 km options.

- **June 12:** Walk in Schooley Mill Park on grass, asphalt, and natural surface trails. Two small stream crossings. Wheelchairs and strollers are not advised and will have difficulty. TR 2C.
- **August 14:** Trails will be on sidewalks and asphalt pathways in Blandair Regional Park and the Columbia Villages of Oakland Mills and Long Reach. Wheelchairs and strollers should not have difficulty. TR 2A.

PROCEDURE: Each participant will be issued a start card. It must be carried on the walk and presented for validation at each checkpoint. Only one start card will be validated per participant. Start cards must be turned in at the Finish Table after completing the event. Only those participants with a properly validated start card will be eligible for IVV credit. The trail may be walked two times per start card on the same day at no additional cost.

REFRESHMENTS: Restrooms will be located at the start points. Water will not be available.

PARTICIPATION FEES:

- The participation fee for IVV Credit Only is \$3. (maximum \$10 for families with minor children living together).
- *There is no fee to walk the trail without receiving the IVV credit.*

- **Saturday June 12 Schooley Mill Park**
12975 Hall Shop Road, Highland, MD 20777.
Trail Distances: Two (2) 5 kms; Trail Rating 2B
Start anytime from 7:30 a.m. to 9:00 a.m.; finish by Noon.
- **Saturday August 14: Blandair Regional Park**
5750 Oakland Mills Rd, Columbia, MD 21045
Trail Distances: Two (2) 5 kms; Trail Rating 2A
Start anytime from 7:30 a.m. to 9:00 a.m.; finish by Noon.

CONDITIONS: The events are open to all. The events will be held during all reasonable weather conditions, including rain. Littering along the trails is prohibited. Dogs are permitted on the trail but not inside buildings.
