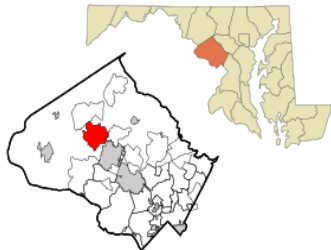

Trails: Walk is on sidewalks and asphalt trails with no significant hills.

FROM I-270 GOING NORTH: Take exit 5 to merge onto MD-189 N/Falls Rd. Immediate **LEFT** onto Great Falls Rd. **STRAIGHT** through the traffic light onto W Montgomery Ave. **LEFT** onto Washington St. **RIGHT** into the Parking area by Dawson's Market. **PLEASE** be courteous and **DO NOT park** in the spaces reserved for Dawson's Market customers. Please use the public parking garages and street parking in the area.

FROM I-270 GOING SOUTH: Take exit 6B-A for MD-28/W Montgomery Ave. **LEFT** onto W Montgomery Ave. **LEFT** at 3rd traffic light to remain on W Montgomery Ave. **LEFT** onto Washington St. **RIGHT** into the Parking area by Dawson's Market. **PLEASE** be courteous and **DO NOT park** in the spaces reserved for Dawson's Market customers.
