From Baltimore, take I-95 South.

From D.C., take I-95 North.

From I-95 take Exit 38B (Route 32 West) to the Exit 15 (Shaker Drive/Eden Brook Drive) and turn right onto Eden Brook Drive to cross over Route 32. Pass traffic light at Old Columbia Rd.

Go To ===== below

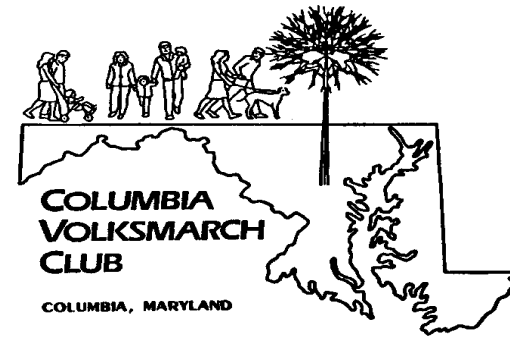
From West, take Route 32 East and take exit 15 toward Shaker Dr/Eden Brook Dr. Keep Right at fork. At traffic light, turn left on Eden Brook Dr.

Pass second traffic light at Guilford Rd.

When divided road ends, turn left toward Amherst House into the Kings Contrivance Village Center.

Use parking lot on the left. Enter Kings Contrivance Village Center between Corner Stable and M&T Bank.

COURSE DESCRIPTIONS: There is one event for this walk: There will be a 10 km trail with a shorter 5 km option on sidewalks and paved paths in the Howard County Columbia's Village of Kings Contrivance. The 10 km trail will include a section on the Patuxent Branch Trail. Strollers should have little difficulty. TR 2A.

PROCEDURE: Each participant will be issued a start card. It must be carried on the walk and presented for validation at each checkpoint. Only one start card will be validated per participant. Start cards must be turned in at the Finish Table after completing the event. Only those participants with a properly validated start card will be eligible for IVV credit. The trail may be walked two times per start card on the same day at no additional cost.

AMENITIES: Restrooms will be located at the start point.

PARTICIPATION FEES:

- The participation fee for IVV Credit Only is \$3. (Maximum \$10 for families with minor children living together).
- *There is no fee to walk the trail without receiving the IVV credit.*

Trail Distances: 10 km with 5 km option; Trail Rating 2A.
Start anytime from 7:30 am to 9:00 am.; finish by Noon.

CONDITIONS: The events are open to all. The events will be held during all reasonable weather conditions, including rain. Littering along the trails is prohibited. Dogs are permitted on the trail but not inside buildings.
