

Instruction for Burnt Bridge Trail 5/10km Walks



The attached walk Map and Directions may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.

OSB Walk Start Location: 8086 E Mill Plain Blvd, Vancouver, WA.

Restrooms and water for 10K may be available at Starbucks 2 blocks east of start, at Burnt Bridge trailhead on Devine St. and at David Douglas Park. No restrooms available on 5K route except at Starbucks. However, restrooms may not be available at Starbucks until phase 3 of Covid-19 and many parks do not have restrooms open.

OSB Driving Directions: From I-205, take Exit #28, Mill Plain Blvd. Southbound, turn right on Mill Plain Blvd. Northbound, stay in the left lane of the exit, circle under Mill Plain, bear right & then turn right onto Mill Plain Blvd heading west. Continue about 1.5 miles. Pass hospital on right & continue another 6 blocks. The Mill Shopping Center will be on your right on the north side of Mill Plain Blvd at Garrison and Mill Plain.

Park: In The Mill Shopping Center parking lot, leave spots close to businesses for customer use.

Walk Completion and Credit: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)

"Please use either the Online Start Box (OSB) or Physical Start Box (PSB) to register and complete the event. Do NOT mix and match, for example, by registering using the OSB then completing your event using the PSB nor signing the PSB log sheet. The sponsoring club only receives credit for an OSB participation when an OSB registration has been completed online by entering your participation date, distances, and any special programs using the OSB."

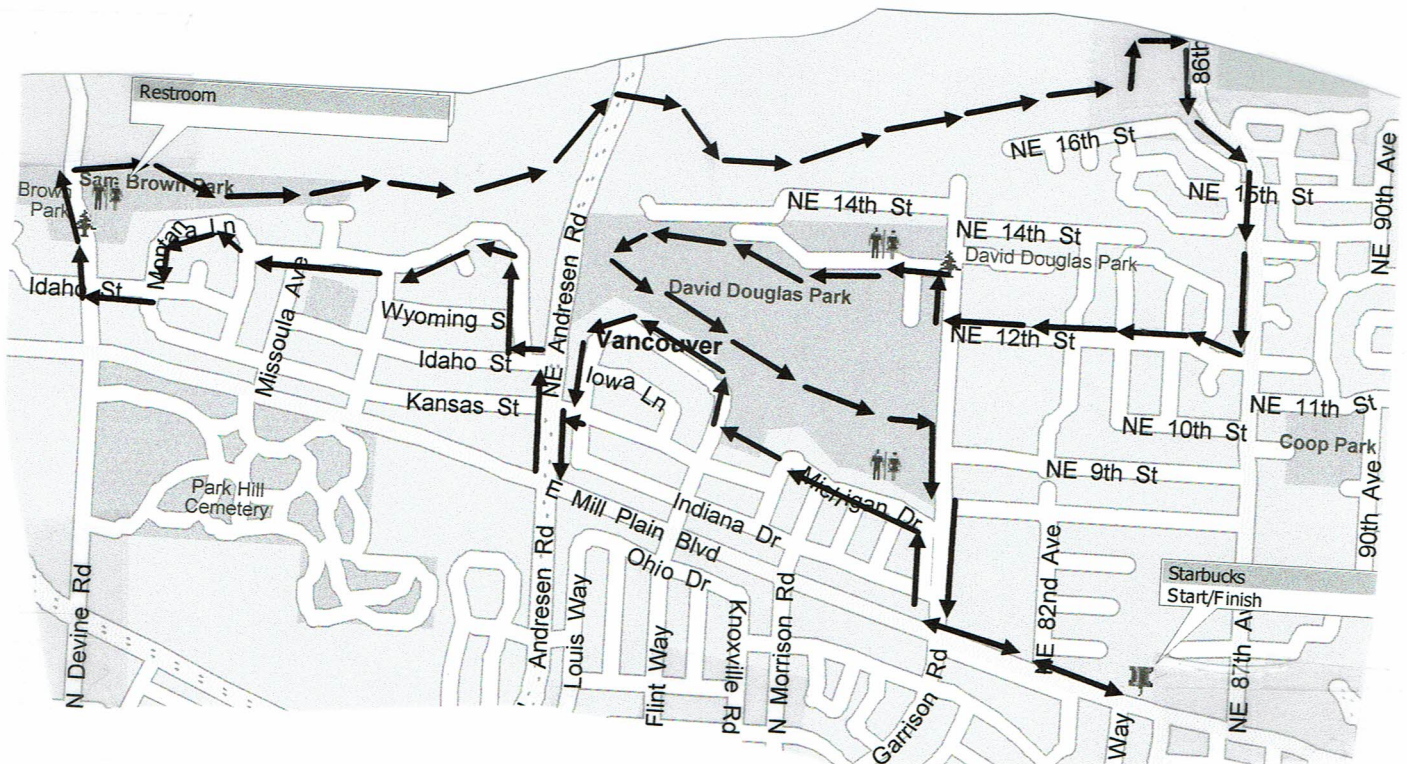
STARBUCKS - BURNT BRIDGE TRAIL

10 KM WALK - rated 2A YRE 632

Challenges: AVA – Bridges, City Park, Walk like an Olympian

OTSVA – 2020 (Parks, Playground & Pedestrian bridge) 2019 (Nature, Noodles, Outlet & Overlook)

1. **RIGHT** on Mill Plain Blvd. to light at Garrison Rd. and **CROSS** Garrison Rd
2. **RIGHT** on Garrison Rd. to Indiana Dr.
3. **LEFT** on Indiana Dr. 20 meters to Garrison Ter.
4. **RIGHT** on Garrison Ter. to Michigan
5. **LEFT** on Michigan St. to Detroit Ave.
6. **ENTER** paved path on right side into park and continue to far side exiting on Flint Ave. (1.0 k)
7. **RIGHT** on Flint Ave. and continue as it curves to your left turning into Topeka Ln.
8. **LEFT** on Topeka Ln and continue as it turns left to Kansas St.
9. **RIGHT** on Kansas St. to Andresen Rd.
10. **LEFT** on Andresen Rd. to Mill Plain Blvd.
11. **RIGHT** on Mill Plain Blvd. then immediately **RIGHT** on Andresen Rd. to Idaho St.
12. **LEFT** on Idaho St one block to Montana Ln. (2 k)
13. **RIGHT** on Montana Ln. to Pocatello Ave.
14. **RIGHT** on Pocatello Ave., which changes back to Montana Ln. as it bears left & continue to Idaho St. (3k)
15. **RIGHT** on Idaho St. crossing Devine Rd.
16. **RIGHT** on Devine Rd. walking on the left side of the road to Burnt Bridge Trailhead.
17. **RIGHT** on Burnt Bridge Trail crossing Devine Rd. to restrooms (3.7 KM at restrooms)
18. **CONTINUE** on trail past restrooms walking under the powerlines to first "Y".
19. **RIGHT** at the "Y" continuing to Andresen Rd. (unmarked divided four lane road) (4.9 km)
20. **CROSS** Andresen Rd and continue on trail ignoring the first left and first right intersections and continue on trail to second left intersection just before overpass.
22. **LEFT** at the second left intersection crossing a small bridge to 86th Ave (unmarked two lane road) (6.5 km)
23. **RIGHT** on 86th Ave. (turns into 87th) to 12th St
24. **RIGHT** on 12th St. to Garrison Rd (7.9 km)
25. **RIGHT** on Garrison 1 block to park entrance road to David Douglas Park.
26. **LEFT** on Park Entrance Road to first restrooms on your right. Move to paved path on left toward small snack shack.
27. **CONTINUE** straight keeping the baseball fields on your left and follow outer paved path counter - clockwise around the entire park until reaching another entrance road to the park onto Garrison Rd.
28. **EXIT** the park here and turn **RIGHT** on Garrison Rd to Mill Plain Blvd.
29. **LEFT** on Mill Plain Blvd. to Starbucks and finish



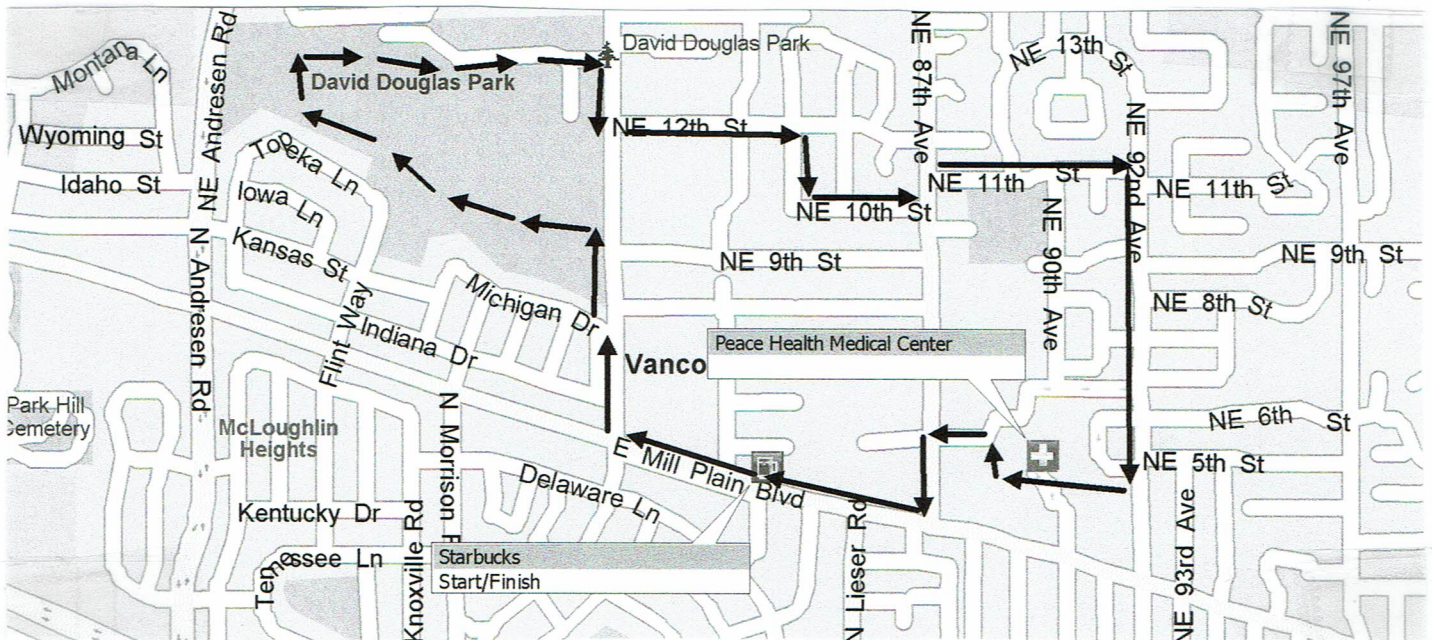

Burnt Bridge Trail and local neighborhoods 5 KM WALK - rated 1A - YRE NW 0632

Challenges: AVA - City Park, Walk like an Olympian

Oregon – 2020 (Parks & Playground) 2019 (Nursej, Nature, Noodle & Outlets) 2018 (Ink. Images, Italian)

1. **EXIT** Starbucks
2. **RIGHT** on Mill Plain Blvd. to Garrison Rd.
3. **RIGHT** on Garrison Rd. **CROSS** Garrison where sidewalk ends on right and starts on left continuing to entrance to David Douglas Park.
4. **LEFT** into the park on sidewalk headed to 2 story snack shack. Continue on right side of snack shack and bear left to paved trail between ball parks until you reach a “Y”.
LEFT at all “Y’s” keeping the woods on your left and ball fields on your right and continue clockwise on outer trail until reaching a smaller snack shack (2 km) on the far side of the park.
5. At Snack Shack **BEAR LEFT** to small entrance road to Garrison (unmarked).
(bathrooms on left – open seasonally)
6. **RIGHT** on Garrison Rd. one block to 12th St.
7. **LEFT** on 12th to 84th Ave.
8. **RIGHT** on 84th Ave to 10th St.
9. **LEFT** on 10th St. to 87th Ave. (3 km at 85th)
10. **LEFT** on 87th Ave. to 11th St.
11. **RIGHT** on NE 11th St to NE 92nd Av.
12. **RIGHT** on NE 92nd Ave. to Parking Garage for the hospital. (4 km @ High School)
13. **RIGHT** on the steps just before the Hospital Parking and bearing slightly left into the Garage and continue through the Parking Garage to the other side by the Physicians Pavillion.
14. **CONTINUE STRAIGHT** in front of the hospital to the far side of the Firstentburg Tower
15. **RIGHT** after the Towers and continue to 5th St.
(first street to the left.)
16. **LEFT** on 5th St. to NE 87th Ave.
17. **LEFT** on NE 87th Ave. to Mill Plain Blvd.
18. **RIGHT** Mill Plain Blvd. to Starbucks (finish)
