Left on Maple St and follow as above.

1. **EXIT** Super One Parking Lot to 29th Ave. (Restrooms available in Super One)
2. **LEFT** on 29th Ave. to Grand Blvd. and cross
3. **LEFT** on Grand Blvd. to 30th Ave.
4. **RIGHT** on 30th to Lamonte
5. **LEFT** on Lamonte to 31st Ave.
6. **RIGHT** on 31st Ave. to Manito Blvd. (Olmstead designed the blvd. when the Spokane park system was created)
7. **LEFT** on Manito Blvd. to High Drive (Keep school on your left as Manito Blvd. turns and then crosses 37th to High Drive) (1K at Tekoa) and cross
8. **RIGHT** on High Drive to 33rd Ave. (Bluff Park is on the left overlooking Qualchan Golf Course and Hangman Creek)
9. **RIGHT** at 33rd Ave ADA Ramp and cross High Drive
10. **RIGHT** on 33rd Ave to Lincoln Drive and cross
11. **LEFT** on Lincoln Drive (sidewalk borders Comstock Park) follow sidewalk to 29th and Post (Restrooms available)
12. **CROSS** 29th and continue on Post to 21st Ave (4K) (Olmstead designed 21st when the park system was formed)
13. **CONTINUE** on Post to 20th (Olmstead designed Triangle Park)
14. **STAY** on Post to Shoshone and cross
15. **ENTER** Cannon Hill Park
16. **CROSS** stone bridge (pond will be on far right, second stone bridge on left slightly behind restroom building and playground as you exit the bridge)
17. **EXIT** park at the intersection of three streets, 18th, 19th and S. Wall
18. **CROSS** 18th to Wall
19. **STRAIGHT** on Wall to 14th Ave.
20. **CROSS** 14th and continue on Wall to 13th Ave.
21. **RIGHT** on 13th to Stevens and cross to sidewalk along Cliff Park
22. **LEFT** on Stevens (a short distance from the corner is a wide section of the street with a large rock border look right and see a set of stairs (50+) up to the Cliff Park Overlook (add .5K if you select to climb to the overlook)
23. **CONTINUE** on Stevens, park on left, to Cotta Street
24. **LEFT** on Cotta St to Wall
25. **RIGHT** on Wall to Summer

26. **RIGHT** on Summer to Stevens
27. **LEFT** on Stevens to Cliff Drive
28. **CROSS** Cliff Drive and enter Edwidge Woldson Park overlook of downtown Spokane
29. **EXIT** park and facing Cliff Drive turn **LEFT**
30. **LEFT** on Cliff Drive to Grove
31. **RIGHT** on Grove to Summer
32. **LEFT** on Summer to S. McClellan (View St John Cathedral)
33. **RIGHT** on McClellan to 13th
34. **RIGHT** on 13th to Division
35. **RIGHT** on Division to Manito Park entrance
36. **LEFT** into the park and follow paved path around Mirror Pond keeping pond on right and restrooms on left. (pond construction may require staying on the road)
37. **LEFT** at end of paved path and transfer to the park road
38. **RIGHT** on park road to the Japanese Gardens
39. **LEFT** to Nishinomiya Road (Restrooms on left and Japanese Gardens on right)
40. **CONTINUE** up a slight hill to entrance to Rose Garden
41. **RIGHT** into the Rose Garden
42. **CROSS** the garden,
43. **RIGHT** at each intersection
44. **RIGHT** and down the stairs
45. **CROSS** road to the entrance to Duncan Gardens (Restrooms available on north side of building)

46. **UP** the slight incline to stairs in front of Gaiser Conservatory and Duncan Gardens
47. **DOWN** the stairs to the fountain
48. **LEFT** at the fountain and exit park on Tekoa
49. **RIGHT** on Tekoa to 22nd Ave
50. **LEFT** on 22nd Ave to Manito Blvd
51. **RIGHT** on Manito Blvd to 27th Ave
52. **LEFT** on 27th Ave to Lamonte
53. **RIGHT** on Lamonte to 28th Ave
54. **LEFT** on 28th Ave to Walgreen Parking Lot
55. **RIGHT** and angle through the parking lot to 29th Ave and Grand Blvd
56. **CROSS** 29th Ave and Grand Blvd
57. **LEFT** on 29th Ave to Start/Finish

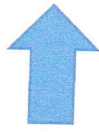

21. **LEFT** on 22nd Ave to Manito Blvd
22. **RIGHT** on Manito Blvd to 27th Ave
23. **LEFT** on 27th Ave to Lamonte
24. **RIGHT** on Lamonte to 28th Ave
25. **LEFT** on 28th Ave to Walgreen Parking Lot
26. **RIGHT** and angle through the parking lot to 29th Ave and Grand Blvd
27. **CROSS** 29th Ave and Grand Blvd
28. **LEFT** on 29th Ave to Start/Finish

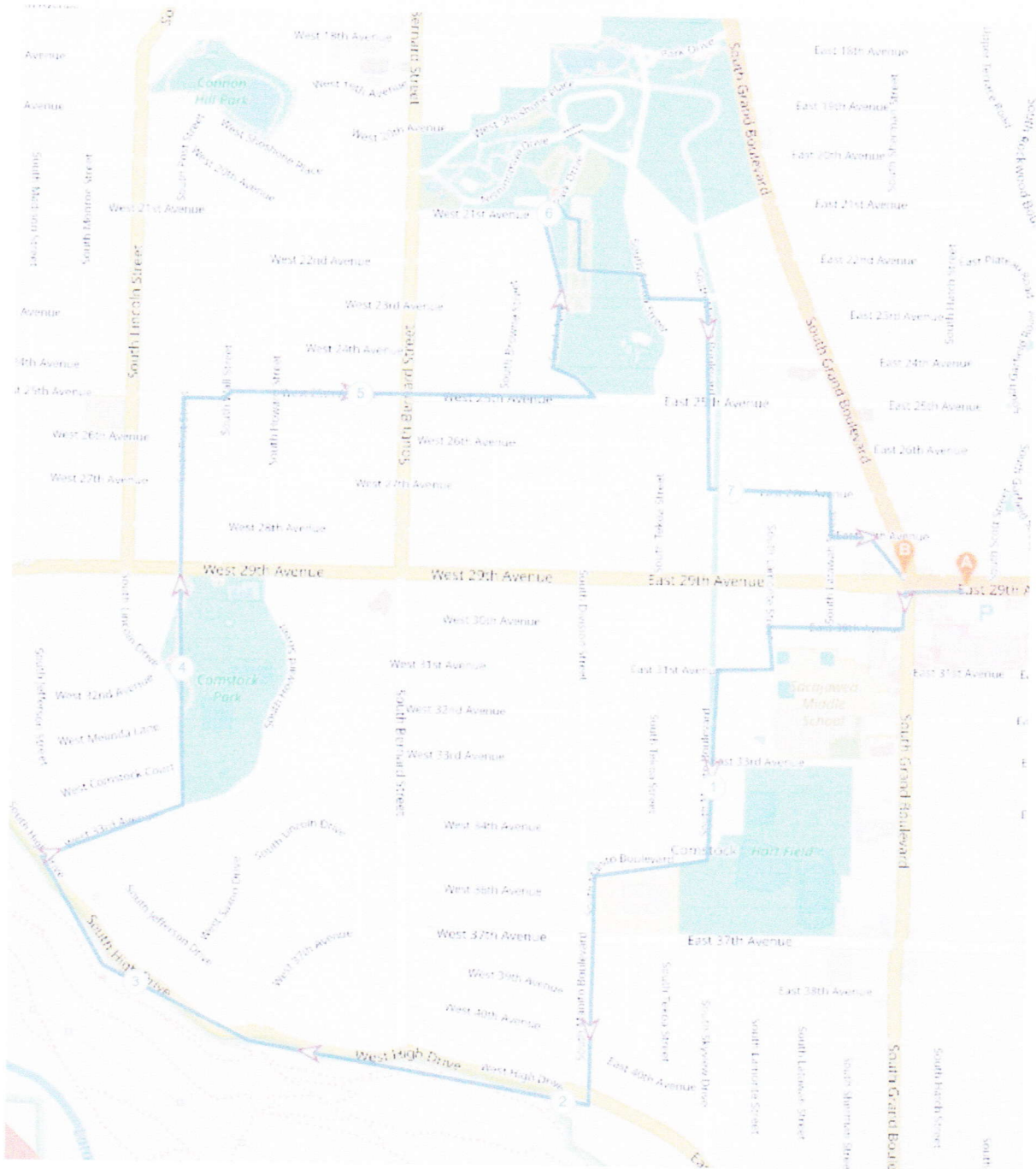

1. **EXIT** Super One Parking Lot to 29th Ave.
(Restrooms available in Super One)
2. **RIGHT** on 29th Ave. to S. Garfield
3. **LEFT** crossing 29th on Garfield to 26th and Garfield (Stay on Garfield to 25th intersection)
4. **LEFT** to 25th Ave (Triangle Park at intersection)
5. **CONTINUE** on 25th to Park Drive
6. **RIGHT** on dirt trail, park on your right and Park Drive on the left to 23rd Ave
7. **RIGHT** and enter Duncan Gardens
8. **LEFT** exit the garden up the stairs, stay left of Gaiser Conservatory to the Rose Garden
9. **UP** the stairs to the Rose Garden.
10. **CROSS** the Rose Garden
11. **EXIT** to Nishinomiya Road (No Sign)
12. **LEFT** on Nishinomiya Road past the Japanese Garden (Restrooms on the left)
13. **RIGHT** on next park road passing the Lilac Gardens on right and Mirror Pond on left
14. **STRAIGHT** crossing the next park road passing the playgrounds on your left
15. **EXIT** the park at 21st and Manito Blvd
16. **RIGHT** on Manito Blvd to 27th Ave
17. **LEFT** on 27th Ave to Lamonte
18. **RIGHT** on Lamonte to 28th Ave
19. **LEFT** on 28th Ave to Walgreen Parking Lot.
20. **RIGHT** and angle through the parking lot to 29th and Grand
21. **CROSS** both 29th and Grand
22. **LEFT** on 29th to Start/Finish
