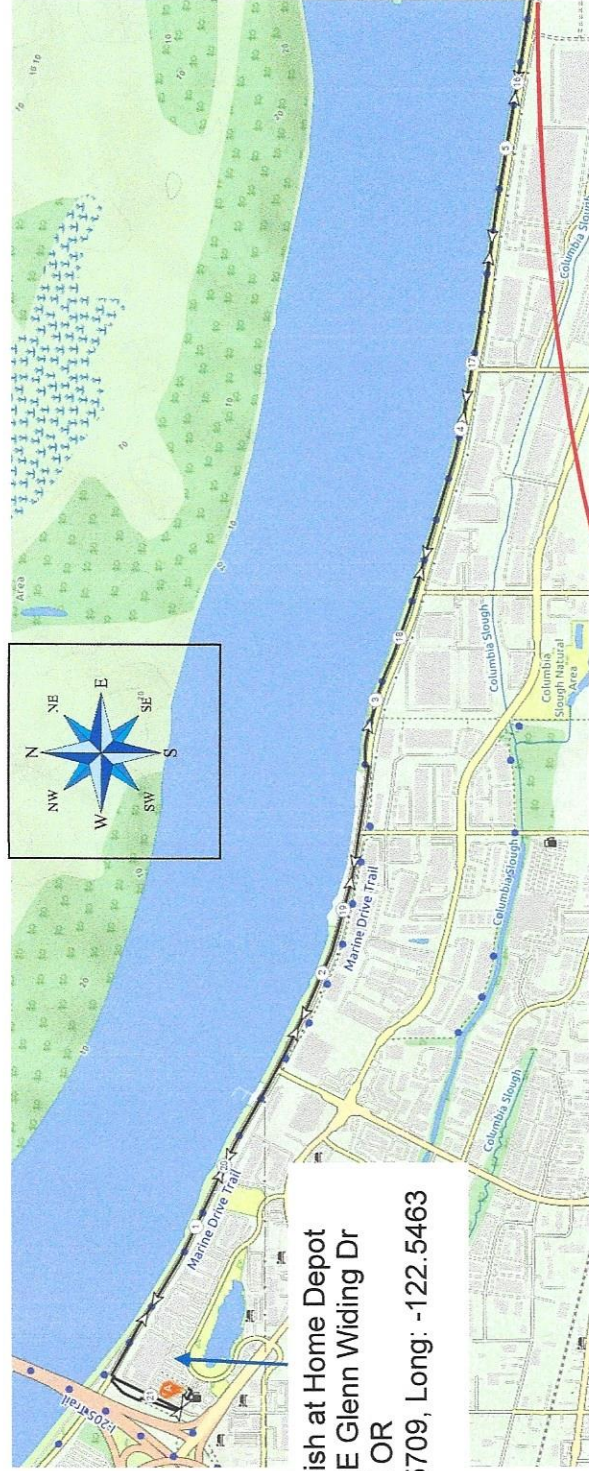
DIRECTIONS TO START POINT: Start at Home Depot at 11633 NE Glenn Widing Dr, Lat: 45.5709, Long -122.5463. From I-205 Southbound take exit 24 and left on NE Airport Way to a left on NE Glenn Widing Dr and Home Depot is ahead on left. From I-205 Northbound exit 24B onto NE Airport Way to a left at the first light onto NE Glenn Widing Dr and Home Depot is ahead on the left.

Ride Overview: route is along NE Marine Dr to Blue Lake Regional Park and back. Start at bike path between Home Depot parking lot and mini shopping area with a gas station.

1. **Right** on bike path and **Right** up to main bike path to NE Marine Dr.
2. **Right** on NE Marine Dr for 2.2kms to Marine Drive Trail on left along Columbia River. (*Caution: busy road, but adequate bike lane*)
3. **Cross** and **Continue** ahead on Marine Dr Trail for 3km.
4. **Cross** and **Left** on NE Marine Dr for 2.3km to NE Blue Lake Rd.
5. **Right** on NE Blue Lake Rd to park entrance on right in .5km.
6. **Right** into park and loop around interior of park and return to NE Blue Lake Rd. (*Restrooms available in park and tables for picnic lunch*)
7. **Right** on NE Blue Lake Rd a short distance to NE Interlachen Lane
8. **Right** on NE Interlachen Lane to NE Marine Dr. (*Caution: NE Marine Dr is a busy road, cross carefully*)
9. **Cross** and **Left** on NE Marine Dr to return to Home Depot.
10. **Slight Right** to Marine Dr Trail on right after about 1.5kms then back onto NE Marine Dr.
11. **Right** onto NE Marine Dr from Marine Dr Trail for 2.3 km to Marine Dr Trail on right just before I-205 bridge.
12. **Slight Right** on Marine Dr Trail and immediate **Left** to cross NE Marine Dr back to Home Depot.

BIKE COMPLETION AND CREDIT: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the event was biked, the distance biked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)
