Start Times: dawn to dusk **Start Point / Driving Directions:** Lynden Food Pavilion, Lynden: I-5, Exit 256A, Bellingham. Right on Guide Meridian for 10.5 miles. Right at stoplight at Kok Road. Food Pavilion is in the shopping center on your left. Park in the store parking lot but *please do not take spaces near the door*. Start box (two drawer oak cabinet) is located to the left just inside the left entrance door.

Please use either the Online Start Box (OSB) or Physical Start Box (PSB) to register and complete the event. Do NOT mix and match, for example, by registering using the OSB then completing your event using the PSB nor signing the PSB log sheet. The sponsoring club only receives credit for an OSB participation when an OSB registration has been completed online by entering your participation date, distances, and any special programs using the OSB.

WALK COMPLETION AND CREDIT: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the date the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.

1. Leaving the Food Pavilion, walk **LEFT** in front of the store and out the driveway with Coconut Kenny's on your right, to the stop sign.
2. **RIGHT** on 19th St. (unmarked)
3. **LEFT** on Kok Rd.
4. **CROSS** Kok Rd. in the sidewalk at the "**Sidewalk ends ahead cross here**" sign.
5. **LEFT** and continue on Kok Rd.
6. **FOLLOW** the sidewalk around the curve.
7. **RIGHT** on "C" St.
8. **LEFT** on S. B.C. Ave. (*note the Stremler house & view*).
9. **RIGHT** on Front. St.
10. **CROSS** and **LEFT** on 4th St. (**restrooms**).
11. **LEFT** on Front St.
12. **CONTINUE** on Front St. past the N.W Washington Fair Grounds.
13. **CROSS** and **LEFT** on 19th St.
14. **RIGHT** into the Food Pavilion parking lot to complete walk.

1. Leaving the Food Pavilion walk **LEFT** in front of the store and out the driveway with Coconut Kenny's on your right.
2. **LEFT** on 19th St. (unmarked)
3. **CROSS** Front St. then 19th St. at the signal, **CONTINUE** on Front St.
4. **CROSS** and **LEFT** on 18th St.
5. 18th becomes Liberty behind Christ the King Church.
6. **CROSS** 17th, 16th, 15th, and 14th, **CONTINUE** on Liberty.
7. **CROSS** and **LEFT** on B.C. Ave.
8. **RIGHT** on Glenning St.
9. **LEFT** on 8th St.
10. **CROSS** the Bridge at the end of 8th St.
11. **CROSS** Main St. in the crosswalk and **CONTINUE** on 8th St.
12. **RIGHT** on North Park St.
13. **CROSS** and **LEFT** on West Park St. "T" not marked.
14. **RIGHT** on N. Park St.
15. **LEFT** on Bonanza Dr.
16. **RIGHT** on Cedar Dr.
17. At the bend in the road & across from Grace Baptist Fellowship veer **LEFT** thru the Netherlands Reformed Church parking lot.
18. **LEFT** on Depot Rd.
19. **CROSS** Homestead Blvd. then Depot Rd. **CONTINUE** on E. Homestead Blvd.
20. After split rail fence ends and blue fire hydrant, **CROSS** Homestead in the crosswalk.
21. Walk across short wood bridge onto asphalt trail with pond on your right, homes on left.
22. **CROSS** Maberry Dr. (not marked) and **CONTINUE** on trail.
23. **RIGHT** at intersection after the gazebo on Jim Kaemingk Sr. trail and walk along Fishtrap creek.
24. **LEFT** at next trail intersection, over the bridge, past the thatched roof house and behind school play fields.
25. Stay on trail thru the park (restrooms) **CROSS** the bridge and **LEFT** on Depot. Rd.
26. **VEER LEFT** on Depot Rd. as it becomes 3rd St.
27. **CROSS** Grover then 3rd, continue on Grover.
28. **LEFT** on 4th St.
29. **RIGHT** on Front St. (restrooms)
30. **CONTINUE** on Front St.
31. **LEFT** on S. B.C. Ave.
32. **RIGHT** on C St.
33. **LEFT** on 17th St.
34. **CONTINUE** on 17th St. around the corner and becomes Kok Rd.
35. **CROSS** Kok Rd. at the first crosswalk. **CONTINUE** on Kok Rd.
36. **RIGHT** on 19th St.
37. **LEFT** onto the food Pavilion parking lot.
