Walk Start Location: Pioneer Park, 400 NW Despain Ave, Pendleton, OR

GPS Coords: 45.67207, 118.7886

Restrooms available at Start

DRIVING DIRECTIONS I-84 Eastbound to Pendleton Exit 209. LEFT on South Gate (John Day/Pendleton Hwy. Keep RIGHT toward City Center on SW Frazer Ave. LEFT on Main St. LEFT on NW Despain Ave. LEFT on NW 4th St to Pioneer Park parking lot on right at end of the street. Restrooms in Pioneer Park. I-84 Westbound: to Pendleton Exit 210. RIGHT on OR11/Oregon-Washington Hwy 8. LEFT on SE Isaac Ave, then RIGHT on S Main St to LEFT on NW Despain Ave. LEFT on NW 4th St to Pioneer Park Parking lot on right at end of the street. Restrooms in Pioneer Park

PARK: Parking lot in park

Walk completion and Credit: Be sure to log back into the OSB to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a download PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days).

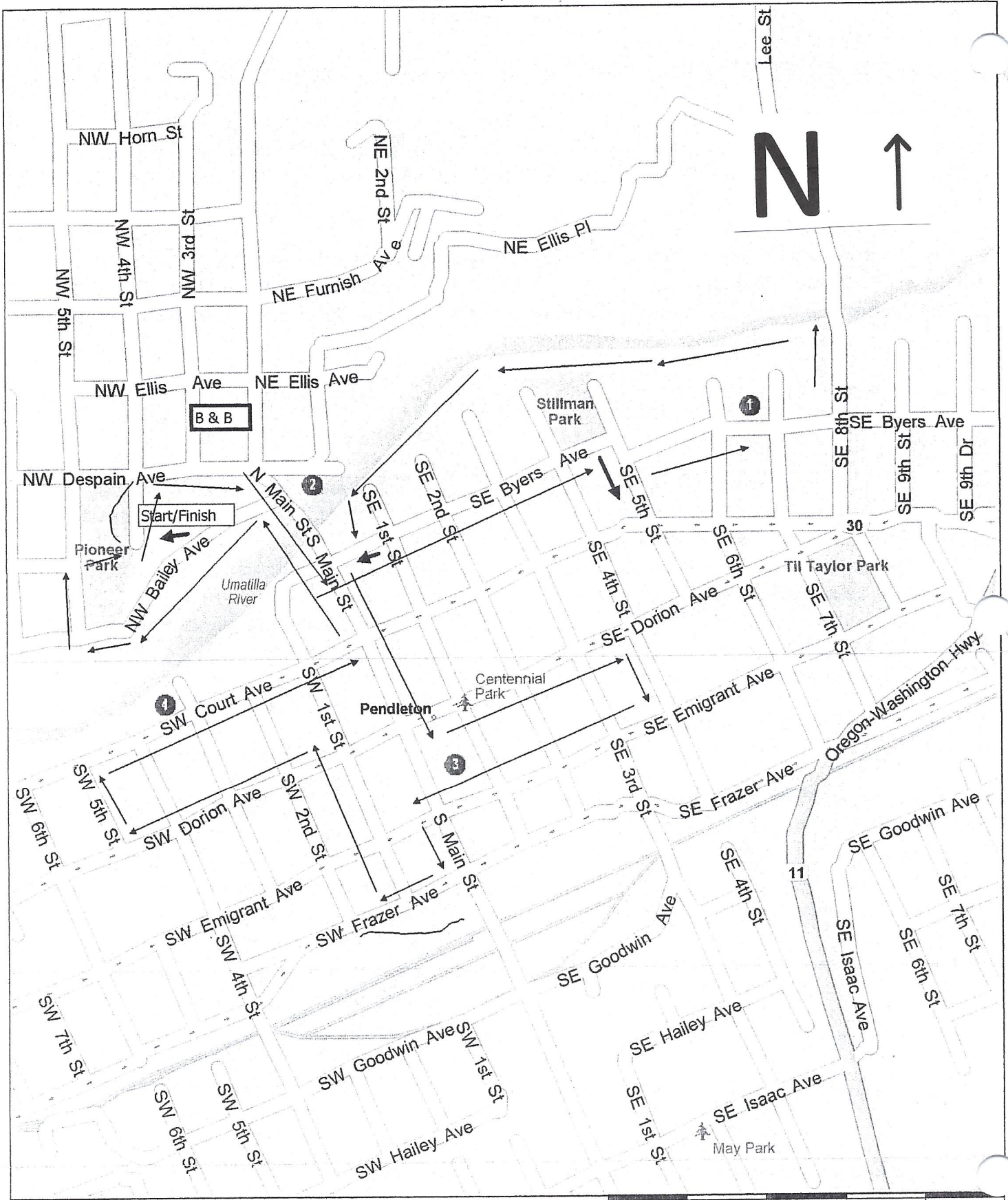

<ol style="list-style-type: none">1. Standing in Pioneer Park Parking Lot off NW 4th St facing Pioneer Park Playground sign with play equipment in front of you2. LEFT to the sidewalk then RIGHT on sidewalk, keeping the playground equipment on your right to NE Despain Ave3. RIGHT on NE Despain Ave to N Main St4. RIGHT on N Main St to SE Byers Ave5. LEFT on SE Byers Ave, jog RIGHT at 5th St continuing on SE Byers Ave to SE 8th6. LEFT on SE 8th St to River Trail (1 km) Do not cross the bridge7. LEFT on Umatilla River Trail just before the bridge to the end of the trail SE Byers St8. RIGHT on SE Byers Ave to S Main St (2 km)	<ol style="list-style-type: none">9. LEFT on S Main St to SE Dorion Ave10. CROSS then LEFT on SE Dorion Ave to SE 4th St11. RIGHT on SE 4th St to SE Emigrant Ave12. RIGHT ON SE Emigrant Ave to Main St13. CROSS Main St then LEFT to SW Frazer Ave (3 km)14. RIGHT ON SW Frazer to SW 1st St15. RIGHT on SW 1st St to SW Dorion Ave16. LEFT on SW Dorion Ave to SW 5th St17. RIGHT on SW 5th St to SW Court Ave18. RIGHT on SW Court Ave to Main St (4 km at SW Court Ave and SW 3d St)19. LEFT on Main St to NW Bailey Ave20. LEFT on NW Bailey Ave to NW 5th St21. RIGHT on NW 5th St to NW Carden Ave22. RIGHT at NW Carden Ave up the stairs into Pioneer Park, passing the restrooms back to the parking lot and Finish

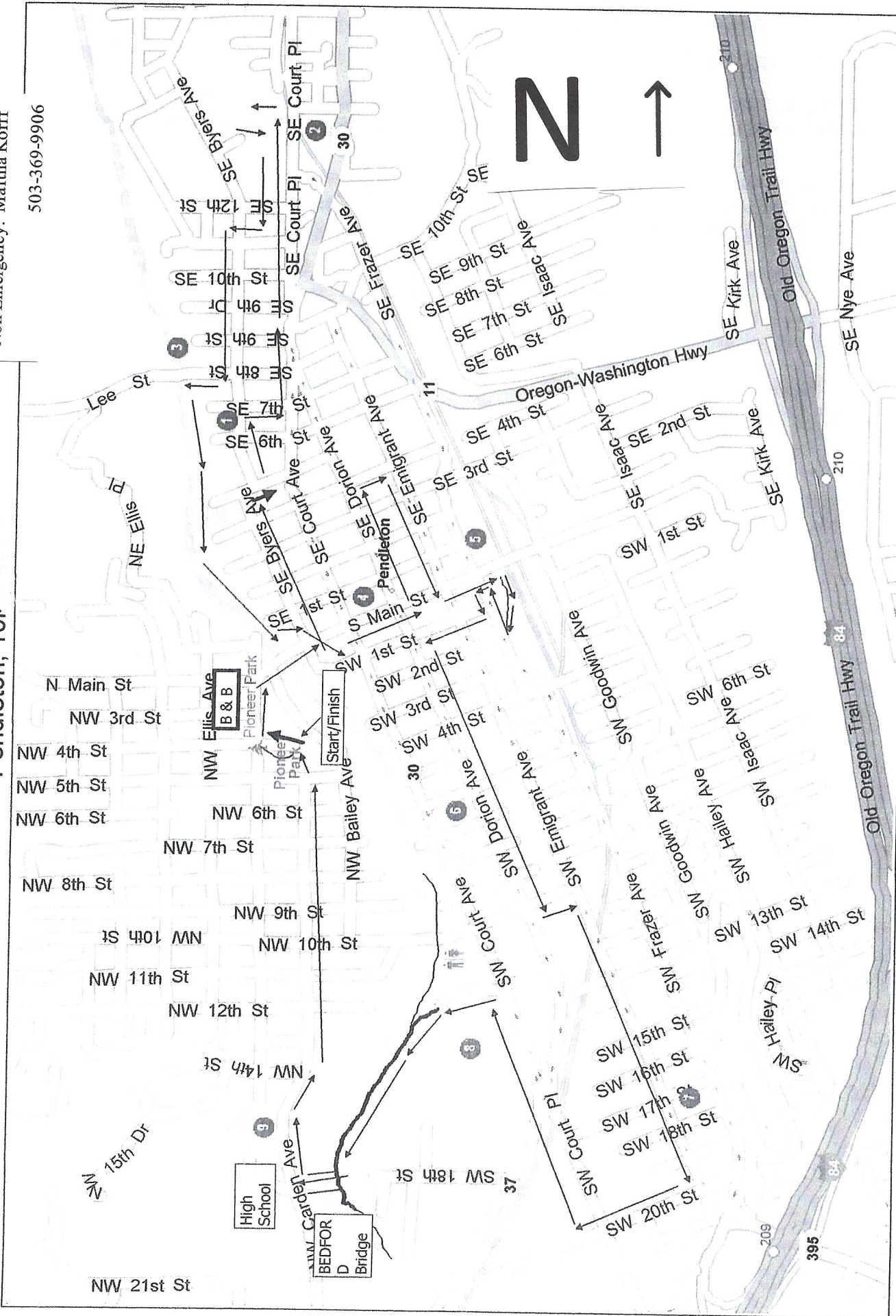
<ol style="list-style-type: none">1. Standing in Pioneer Park Parking Lot off NW 4th St facing Pioneer Park Playground sign with play equipment in front of you2. LEFT to the sidewalk then RIGHT on sidewalk, keeping the playground equipment on your right to NE Despain Ave3. RIGHT on NE Despain Ave to N Main St4. RIGHT on N Main St to SE Byers Ave5. LEFT on SE Byers Ave, jog RIGHT at 5th St continuing on SE Byers Ave to SE 7th6. RIGHT on SE 7th St to SE Court Ave (1 km)7. LEFT on SE Court Ave. Street name changes at 8th or 9th St to SE Court Place. Continue to Pendleton Woolen Mills8. LEFT to Pendleton Woolen Mills Store. Then return to SE Court Place (2 km)9. RIGHT on SE Court Pl to SE 12th St10. RIGHT on SE 12th St to SE Byers Ave11. LEFT on SE Byers Ave to SE 8th St12. RIGHT on SE 8th St to River Trail. Do not cross the bridge (3 km)13. LEFT on Umatilla River Trail just before the bridge to the end of the trail SE Byers Ave14. RIGHT on SE Byers Ave to S Main St15. LEFT on S Main St to SE Dorion Ave (4 km)16. CROSS then LEFT ON se Dorion Ave to SE 4th St	<ol style="list-style-type: none">17. RIGHT on SE 4th St to SE Emigrant Ave18. RIGHT on SE Emigrant Ave to S Main St19. CROSS then LEFT on S Main St. Do not cross the RR tracks20. RIGHT before RR Tracks, walk on sidewalk toward the museum, passing the Union Pacific Caboose to a windmill at SW 2d St (5 km)21. At the windmill, return on sidewalk to Main St, keeping caboose and museum on your right.22. LEFT on S Main St at the light to SW Frazer23. LEFT on SW Frazer Ave to SW 1st St24. RIGHT on SW 1st to SW Dorion Ave25. LEFT on SW Dorion Ave to SW 10th St26. LEFT on SW 10th St to SW Emigrant Ave (6 km)27. RIGHT on SW Emigrant Ave to SW 20th St28. RIGHT on SW 20th St to SW Court Pl (7 km)29. CROSS then RIGHT on SW Court Pl to SW Court Ave30. After RR tracks, CROSS SW Court Ave in crosswalk (street name now is SW Court Ave – no sign). Walk past Pendleton Roundup on left to SW 12th St (8 km)31. LEFT (at bronco) SW 12th St and keep left to River Trail. (Roy Raley Park on right has restroom)32. LEFT on River Trail to Bedford Bridge.33. RIGHT at Bedford Bridge to Carden Ave (9 km)34. RIGHT on NW Carden Ave (no sign) to 5th St35. CROSS NW 5th St, then up the stairs into Pioneer Parking passing restrooms and Finish
