Directions from I 90:

From I 90 westbound Exit 15 (Sherman).
turn left to downtown area.
proceed to the city parking lot east of the resort.

From I 90 eastbound Exit 11 (Northwest Blvd).
turn right to downtown area.
proceed to the city parking lot east of the resort.

NOTE: There is a Physical Start Box at the Coeur d'Alene Resort. Please use either the Online Start Box (OSB) or Physical Start Box (PSB) to register and complete the event. DO NOT mix and match, for example, by registering using the OSB then completing your event using the PSB nor signing the PSB log sheet. LCVA only receives credit for an OSB participation when an OSB registration has been completed online by entering your participation date, distances, and any special programs using the OSB.

**EMERGENCY CALL 911

1. Exit the front door of the CdA Resort
2. **LEFT** to the boardwalk around the marina
3. **LEFT** on the boardwalk and follow it around back to shore near the tour boats
4. **RIGHT** at the top of the ramp and walk toward the restroom bldg. and on to the foot trail on Tubbs Hill.
5. Follow the main trail around Tubbs Hill keeping Lake Coeur d'Alene to your right
6. Upon exiting the trail to the small park (porta potty available) exit the park to 11th
7. Left on 11th to Sherman
8. **LEFT** on Sherman
9. Continue straight passing the clock tower into the city park keeping the lake to your left
10. At the west edge of the park continue on West Lakeshore Drive (which becomes Rosenberry Drive) and is the Dike Road around North Idaho College.
11. **RIGHT** on College Drive to W. Garden Ave.
12. **LEFT** on Garden Ave., the library will be on your left, pass Boswell Hall on your right to Hubbard Avenue
13. **RIGHT** on Hubbard Ave...checkpoint...when was the Red Chapel added to the National Historic Registry?
14. **LEFT** on Woodland Drive to Military Drive.
15. **RIGHT** on Military Drive to Sherman Court.
16. **LEFT** one block to the city park.
17. **CROSS** the street and enter the park.
18. Follow the sidewalk **CLOCKWISE** through the park (restrooms available) to the clock tower at 1st and Sherman.
19. **Return** to the start/finish in the CdA Resort.

Note: for an additional 1K after step 6, keep the lake on your right follow Lakeside Drive to 15th, left on 15th to Ash, left on Ash to 11th and right on 11th to Sherman and rejoin the instructions at step 8.

1. Exit the front door of the CdA Resort and continue up 2nd St. to Sherman Avenue.
2. **LEFT** on Sherman and follow sidewalk along the city beach through the park.
3. At the west edge of the park **CONTINUE** on West Lakeshore Drive (which becomes Rosenberry Drive) and is the Dike Road around North Idaho College.
4. **RIGHT** on College Drive (take time to view Ft. Sherman if open) to W. Garden Ave.
5. **LEFT** on Garden Ave., the library will be on your left, pass Boswell Hall on your right to Hubbard Avenue
6. **RIGHT** to checkpoint...when was the Red Chapel added to the National Historic Registry?
7. **LEFT** on Woodland Drive to Military Drive.
8. **RIGHT** on Military Drive to Sherman Court.
9. **LEFT** and go one block to the city park.
10. **CROSS** the street and enter the park. OR **LEFT** on North Park Drive to NW Corner of Park and enter park
11. Follow the sidewalk **CLOCKWISE** through the park (restrooms available) to the clock tower at 1st and Sherman.
12. **CONTINUE STRAIGHT** on Sherman to 2nd Street.
13. **RIGHT** on 2nd Street and walk 1 block to Front Ave.
14. **CROSS** Front and walk to the end of the parking lot.
15. **LEFT** and walk toward the lake.
16. At the end of the building enter the boardwalk and follow around the marina.
17. Exit the boardwalk
18. **RIGHT** to the start/finish.

1. Exit the Coeur d'Alene Resort
2. **ANGLE LEFT** on sidewalks to continue on park path to Lakeshore and Park Drive.
3. **CONTINUE** on Lakeshore to Rosenberry Dr.
4. **CONTINUE** on Rosenberry Dr. to W. River Ave.
5. **STAY LEFT**, Continue on the Trail, keep River on left, stay left to merge with the Centennial Trail.
6. **CONTINUE** on Centennial Trail with Lewis and Clark State College on left
7. **CONTINUE** with the Spokane River on your left under US 95
8. **CONTINUE** to the paved street (Bellerive Ln) to N. Beebe Blvd (Le Peep Café on left)
9. **RIGHT** on N. Beebe Blvd to Centennial Trail
10. **LEFT** Centennial Trail to Restroom Bldg in Riverstone Park
11. **RETRACE** your steps to N. Beebe Blvd.
12. **RIGHT** on N. Beebe Blvd. to Bellerive Ln. (if slick/icy stay on Bellerive Ln)
13. **CROSS** Bellerive Ln and walk between LePeep and the condos
14. **LEFT** on walkway passing Le Peep to the end of walkway
15. **LEFT** on walkway to Bellerive Ln.
16. **RIGHT** on Bellerive Ln. to its end
17. **CONTINUE** on path back under US 95 overpass to Lewis and Clark State College
18. **ANGLE LEFT** on N. Academic Way to W. Hubbard St.
19. **RIGHT** on W. Hubbard St. to W. River Ave.
20. **RIGHT** on W. River Ave. to N. College Drive.
21. **LEFT** on North College Drive to W. Garden Ave.
22. **LEFT** on West Garden Drive to N. Hubbard Ave.
23. **RIGHT** on North Hubbard Drive to West Woodland Drive
24. **LEFT** on Woodland Drive to Military Dr.
25. **RIGHT** on Military Dr to West Sherman Court
26. **LEFT** on Sherman Court to North Park Drive and Cross
27. **LEFT** on sidewalk in the park and continue in a clockwise direction (Restrooms in the park) and exit the park to Sherman
28. **RIGHT** on Sherman to 1st
29. **RIGHT** on 1st St. to boardwalk around Marina(CdA Resort)
30. **WALK** counterclockwise around the floating walkway
31. **EXIT** the walkway
32. **LEFT** to the Start/Finish at the CdA Resort
