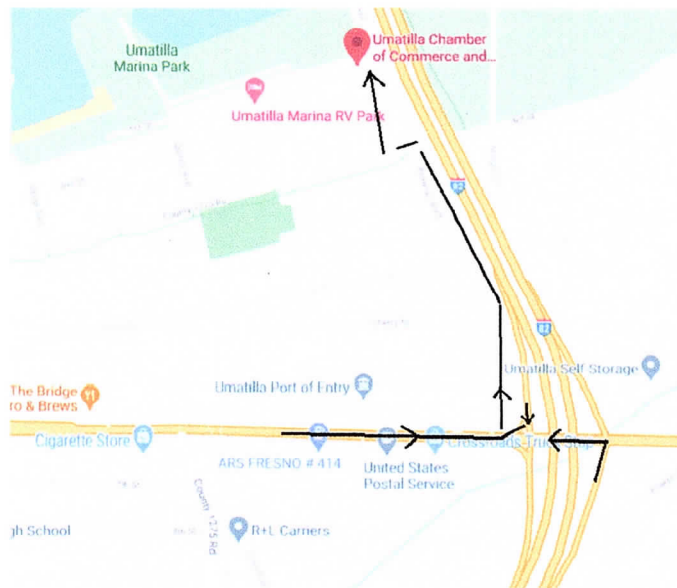
DESCRIPTION

From US-730, turn North on Brownell Blvd. Continue to "T" with 3rd St. LEFT on 3rd St. and Quick RIGHT on Cline Ave. to the Umatilla Chamber of Commerce and Visitor Center.

Walk Completion and Credit: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)

These instructions may be used only upon registration at a currently sanctioned IVV/AVA Event

100 Cline Ave, Umatilla, OR 97882: From Highway I-82, take exit 1 for U.S. 395/U.S. 730, Follow signs to Visitor Center. Turn West towards the city. Turn Right on Brownell Blvd to 3rd St. Turn Left then quick Right on Cline Ave. to Visitor Center. **HOURS:** Wed-Sat 10am-4pm **Restrooms available when open.**

1. **RIGHT** from Visitor Center Parking Lot past the Gravel Shed to W. 3rd St.
2. **LEFT** under the bridge to the Pathway on the LEFT
3. **LEFT** up the pathway and cross the Columbia River
4. On the Washington side, follow the path way down the switchback.
5. **RIGHT** on Pathway, through tunnel under Highway I-82
6. **CONTINUE** on road (left side) toward Plymouth, WA
7. **At the end of the trees on the Left**, there are some cement road barricades on the side of the road.
8. **TURNAROUND** and return across the Columbia River to Oregon, return to W.3rd St.
9. **RIGHT** on W. 3rd St. to Cline Ave.
10. **5k Walkers** return to the Visitor Center.
11. **10k Walkers** Cross over to the pathway on the Left along the parkway/Soccer Fields.
12. **CONTINUE** on Pathway past the end of the Soccer Fields; it will veer to the LEFT, towards Switzler Ave and 4th St.
13. **LEFT** on Switzler Ave to 6th St. (US 730), and **CAREFULLY CROSS** the Highway.
14. **RIGHT** on US 730 and Continue until C St. (Cemetery across street)
15. **LEFT** on C St. to 7th
16. **RIGHT** on 7th St to the end and CONTINUE down the roadway to a Pathway.
17. **LEFT** on the pathway into Nugent Park.
18. **CONTINUE** on the pathway as it follows the river and comes out by the School Track and curves to the LEFT.
19. **LEFT** when pathway joins Access road/parking area.
20. **UP** the gravel road to I St.
21. **CONTINUE** to 8th St.
22. **RIGHT** on 8th St
23. **LEFT** on L St. to US 730/6th St.
24. **CAREFULLY CROSS** US 730 and CONTINUE to 5th St.
25. **RIGHT** on 5th St. to Switzler Ave.
26. **LEFT** on Switzler Ave to 3rd St.
27. **CROSS and RIGHT** on 3rd St to Nugent Ave.
28. **LEFT** on Nugent Ave to 2nd St.
29. **RIGHT** on 2nd St to Quincy Ave.
30. **RIGHT** on Quincy Ave. to 3rd St.
31. **LEFT** on 3rd to Cline Ave.
32. **LEFT** on Cline Ave and return to the Visitor Center.

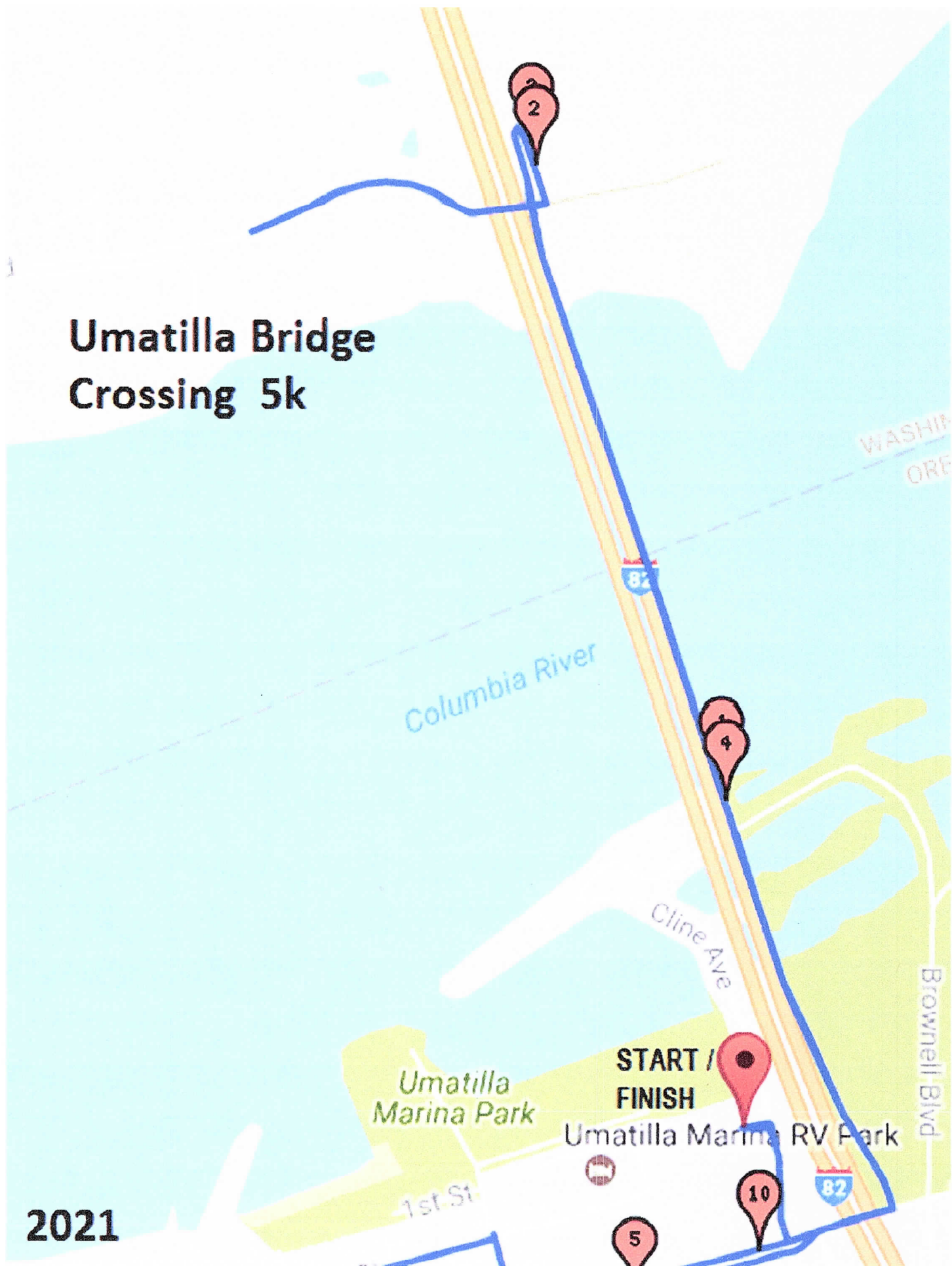
