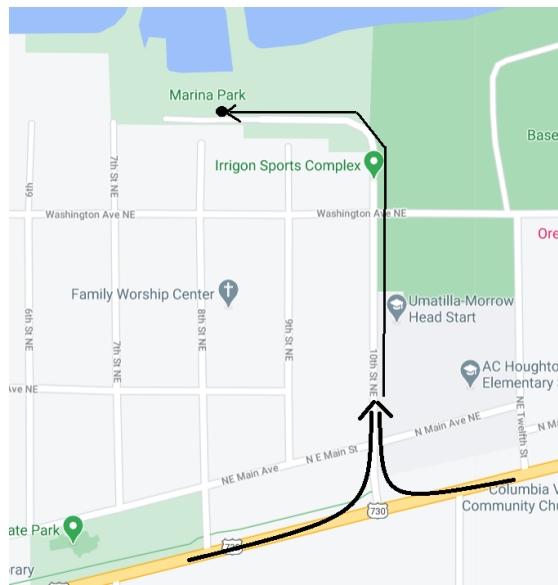

DESCRIPTION

From US-730, turn North on 10th St. NE. This leads to the entrance of the Marina. Park near the Restrooms.



Walk Completion and Credit: Be sure to log back into the OSB system to finish/complete your online registration after doing the event. The OSB system does not deduct any event fee from a participant's Event Bank until they have submitted event completion info including the event was walked, the distance walked, and the selection of applicable special programs that person is participating in. (Nevertheless, a fee of \$2 for a downloaded PDF is deducted from the user's Event Bank when the PDF is downloaded. Later, any PDF fees are credited back to a user's Event Bank when he/she submits the event completion info as a paying for credit participant. Note, however, the \$2 coupon for the downloaded PDF will expire in 60 days.)

From I-84 or I-82, access US 730 to Irrigon. At 10th St. NE, turn toward the River, following signs to the Marina. Park in front of the Restrooms

1. **In the Marina Parking Lot, facing away from the River, Start Left towards the entrance.**
2. **RIGHT** on 10th St. NE
3. **RIGHT** on Washington Ave. NE.
4. **LEFT** on 9th St. NE
5. **RIGHT** on Oregon Ave. NE
6. **LEFT** on 7th St. NE
7. **CONTINUE** on 7th St. NE, crossing through the Park to a spot opposite SE 7th St (Across Highway)
8. **CAREFULLY CROSS** US 730 and Continue on SE 7th St to E. Idaho Ave.
9. **LEFT** on E. Idaho Ave. to SE 8th St.
10. **RIGHT** on SE 8th St. to E. Utah Ave.
11. **RIGHT** on E. Utah Ave to SE 3rd St.
12. **LEFT** on SE. 3rd St to W California Ave.
13. **RIGHT** on W. California Ave to S. First St.
14. **LEFT** on S. First St
15. **CONTINUE** past the High School to SE Wyoming Ave
16. **RIGHT** on SE Wyoming Ave. to Second St W.
17. **RIGHT** on Second St.
18. **CONTINUE, Carefully CROSSING** US 730, to Columbia Ln.
19. **RIGHT** on Columbia Ln to N. First St. (unmarked, where black lamp posts start)
20. **LEFT** on N. First St. to Oregon Ave
21. **RIGHT** on Oregon Ave. to NE Third St.
22. **LEFT** on NE. Third St to Washington Ave.
23. **RIGHT** on Washington Ave to 7th St. NE
24. **LEFT** on 7th St. NE, entering the Marina
25. **VEER RIGHT** into the Parking Lot and Finish.

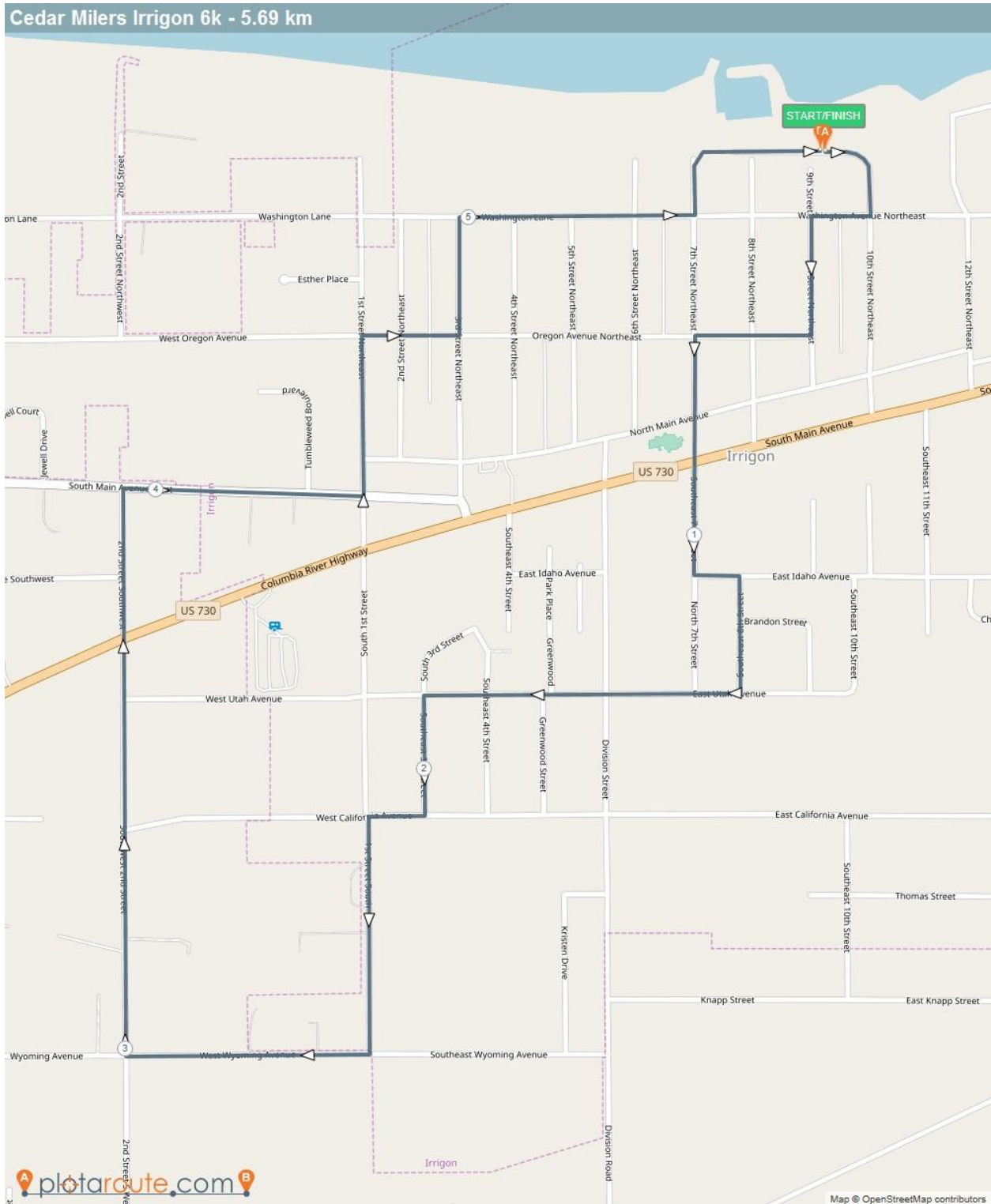

These instructions may be used only upon registration at a currently sanctioned IVV/AVA Event

From I-84 or I-82, access US 730 to Irrigon. At 10th St. NE, turn toward the River, following signs to the Marina. Park in front of the Restrooms

26. In the Marina Parking Lot, facing away from the River, Start Left towards the entrance.
27. **RIGHT** on 10th St. NE
28. **CONTINUE** on 10th St. NE to NE Main Ave.
29. **RIGHT** on NE Main Ave. to 3rd St. NE, passing the park and City Hall.
30. **LEFT** on 3rd St. NE for about a block
31. **LEFT** on the pathway as it also passes the Post Office, City Hall and park, to a spot opposite SE 7th St (Across Highway)
32. **CAREFULLY CROSS** US 730 and Continue on SE 7th St to E. Utah Ave
33. **RIGHT** on E. Utah Ave to SE 3rd St.
34. **RIGHT** on SE. 3rd St to W California Ave.
35. **RIGHT** on W. California Ave to S. First St.
36. **LEFT** on S. First St. and continue past the High School to SE Wyoming Ave.
37. **RIGHT** on SE Wyoming Ave, heading West away from School
38. **CONTINUE** to Second St W.
39. **LEFT** on Second St. W. to Nevada St.
40. **RIGHT** on Nevada St. to Third Rd W.
41. **RIGHT** on Third Rd. W.
42. **CONTINUE** on Third Rd W, **Carefully CROSSING** US 730, to Idaho St.
43. **RIGHT** on Idaho St. to Second St. W
44. **LEFT** on Second St. W to Columbia Ln.
45. **LEFT** on Columbia Ln to Fourth St. W.
OPTION: (see map)
RIGHT on Fourth St. W to Oregon Ln.
RIGHT on Oregon Ln to Second St. W.
(Passing Orchard on Right).
LEFT on Second St. W to Washington Ln.
Skip to #22
46. **RIGHT** on Fourth St. W. to Washington Ln.
47. **RIGHT** on Washington Ln to N First St.
48. **RIGHT** on N. First St to Oregon Ln.
49. **LEFT** on Oregon Ln to 7th St. NE
50. **LEFT** on 7th St. NE, crossing Washington Ln to Path at Entrance of Marina
51. **CONTINUE** into the Marina Parking Lot and Finish.

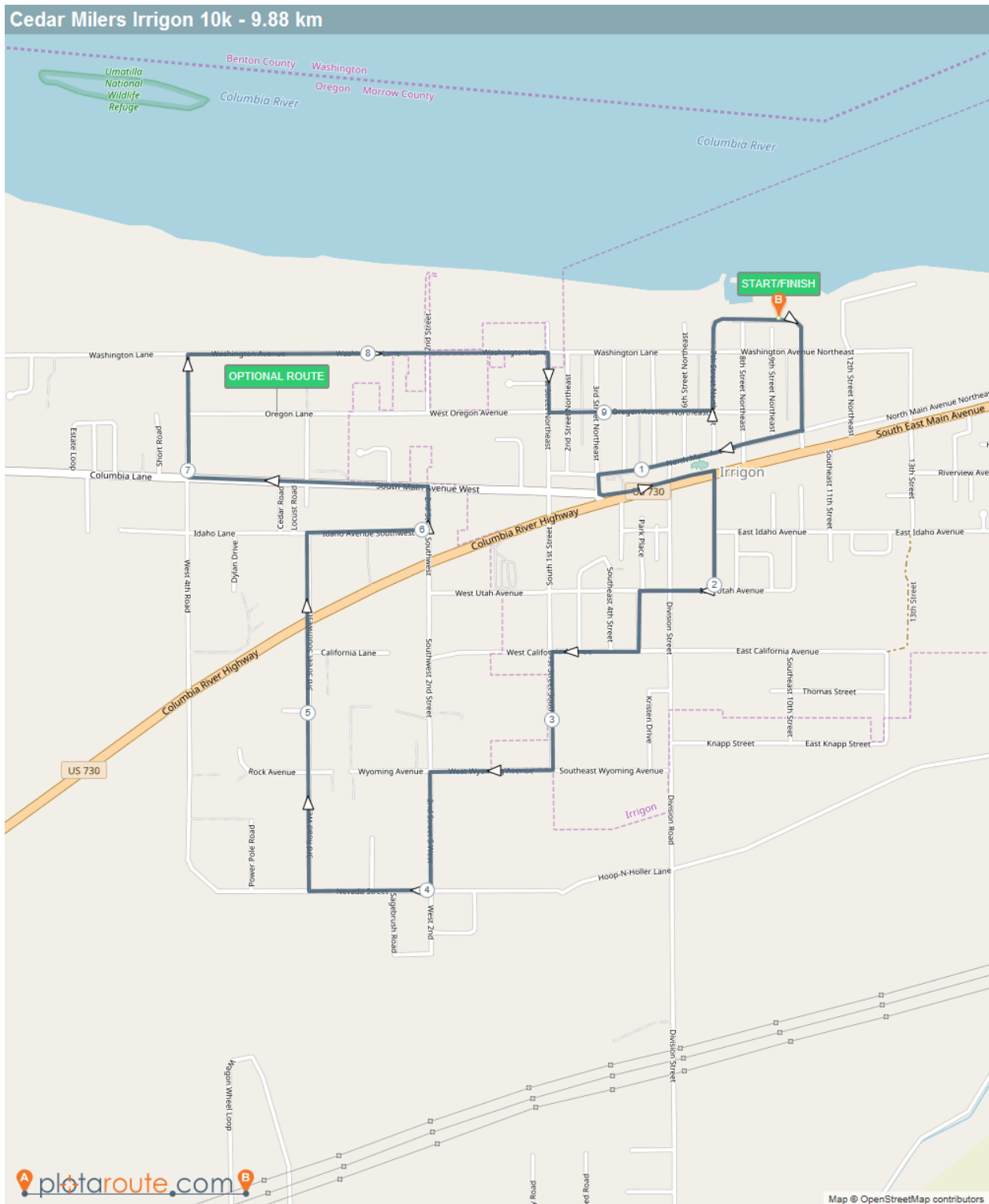
