Matador is another small town, county seat. It boasts of murals, Bob's Oil Well, a County Historical Museum, and the Historic Matador Hotel.

Both walks start at the Courthouse and pass several churches, post office, a Quanah Arrow, and all of the above sites. Both walks are rated 1A, but are hard for strollers and wheelchairs. Pets on leash.

Start Point Address and Driving Directions:

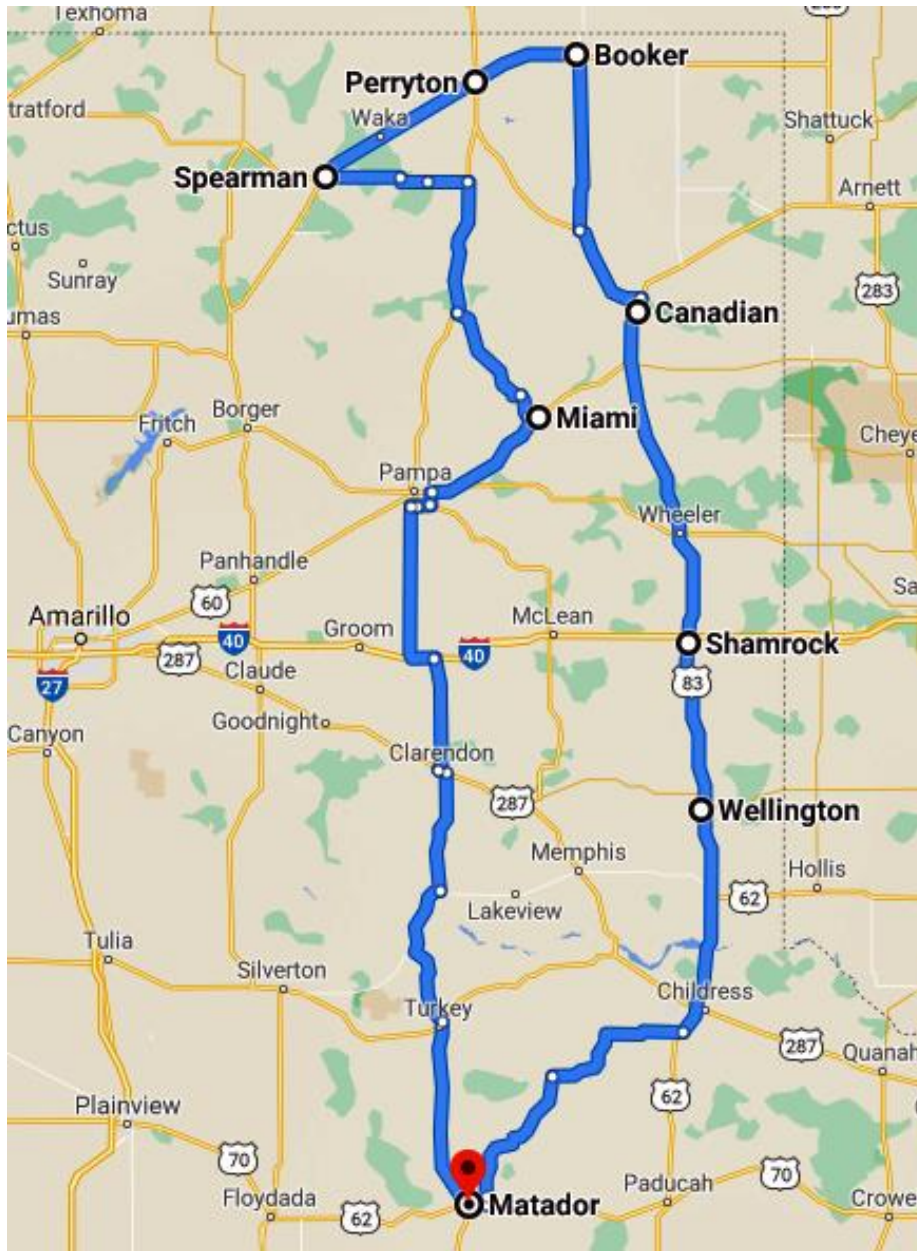
Motley County Courthouse, 701 Dundee Avenue, Matador, TX. 79244. From US-62/Bailey Ave. in Matador, turn north on Eubank Street for 1 block to Dundee Ave. Turn left and park.

Restrooms:

There is an Allsup's Convenience Store and gas station at 1220 Bailey Ave., 4 blocks from the Courthouse. There is a Lowe's grocery at 1111 Main St., ½ block from the Courthouse.

TEXAS COUNTY WALKERS – 2021 MOTLEY COUNTY WALKS in MATADOR, TX

The Start Point is at the Motley County Courthouse, 701 Dundee Avenue, Matador, TX. 79244. From US-62/Bailey Ave. in Matador, turn north on Eubank Street for 1 block to Dundee Ave. Turn left and park in front of the Courthouse.

10 km Walk Instructions:

1. Facing the Courthouse, turn **LEFT** ½ block to Main St.
2. **RIGHT** on Main 1 block to Stewart Avenue.
3. **RIGHT** on Stewart for 1 block to Eubank Street.
4. **RIGHT** on Eubank for 1 block to Dundee Avenue.
5. **CROSS and RIGHT** on Dundee for 1 block to Main St.
6. **LEFT** on Main for 1 block to US-62/Bailey Ave.
7. **LEFT** on US-62 for 1 block to Eubank Street.
8. **RIGHT** on Eubank, **CAREFULLY CROSSING** US-62, for 3 blocks to Virginia Avenue.
9. **RIGHT** on Virginia for 1 block to Main Street.
10. **LEFT** on Main for 1 block to Hazel Street.
11. **LEFT** on Hazel for 1 block to Eubank Street.
12. **RIGHT** on Eubank for 3 blocks to Walton Road.
13. **RIGHT** on Walton for 1 block to Main St.
14. **CROSS and RIGHT** on Main for 2 km to end at Harrison Avenue.
15. **LEFT** on Harrison for 1 block to Bundy Street.
16. **LEFT** on Bundy for 7 blocks to Newlin Avenue.
17. **CONTINUE** about another block to the first dirt road on your right.
18. **RIGHT** on the dirt road and loop around the park and back to Bundy Street.
19. **RIGHT** on Bundy for 9 blocks to end at Walton Road.
20. **RIGHT** on Walton for 3 blocks to end at Pipkin Street (no sign).
21. **RIGHT** on Pipkin for 1 block to Burleson Avenue.
22. **RIGHT** on Burleson for 2 blocks to Scotch Street.
23. **LEFT** on Scotch for 3 blocks to Virginia Avenue.
24. **RIGHT** on Virginia for 1 block to Bundy Street.
25. **LEFT** on Bundy for 2 blocks to Lariat Avenue.
26. **LEFT** on Lariat for 1 block to Scotch Street.
27. **RIGHT** on Scotch for 1 block to US Hwy 62/Bailey Ave.
28. **LEFT** on US-62 for 1 block to Pipkin Street.
29. **RIGHT** on Pipkin, **CAREFULLY CROSSING** US-62, for 1 block to Dundee Avenue.
30. **RIGHT** on Dundee for 3 blocks to **FINISH** at the Courthouse.

5 km Walk Instructions:

1. Facing the Courthouse, turn **LEFT** ½ block to Main St.
2. **RIGHT** on Main for 1 block to Stewart Avenue.
3. **RIGHT** on Stewart for 1 block to Eubank Street.
4. **RIGHT** on Eubank for 2 blocks to US-62/Bailey Ave.
5. **CAREFULLY CROSS** US-62 and continue on Eubank for 4 blocks to Hazel Avenue.
6. **RIGHT** on Hazel for 1 block to Main St.
7. **RIGHT** on Main St. for ~9 blocks to Hackberry Ave.
8. **LEFT** on Hackberry for 1 block to Bundy Street.
9. **LEFT** on Bundy for 8 blocks to Hazel Ave.
10. **RIGHT** on Hazel for 1 block to Scotch Street.
11. **RIGHT** on Scotch for 4 blocks to US-62.
12. **LEFT** on US-62 for 1 block to Pipkin St.
13. **RIGHT** on Pipkin, **CAREFULLY CROSSING** US-62, for 1 block to Dundee Avenue.
14. **RIGHT** on Dundee for 3 blocks to **FINISH** at the Courthouse.

These walk directions and maps may only be used in conjunction with a signed American Volkssport Association athletic waiver. All other uses are prohibited.
